

Only this I will say: Until now the government has been founded on vio-lence; in the future it must be founded on the love of the people."

# PREPARING FOR WAR

Gournal Special Service.) Chicago, Jan. 8.—The Daily News correspondent at London says that Eng-lish observers concede the gravity of the situation resulting from the Mo-rocco imbrogilo.
