WOMAN HAD MANIA FOR SHOPPING

Merchandise Amounting to Nearly Half a Million Dollars Found Piled in House.

BROWNSTONE MANSION FILLED WITH PURCHASES

Find Made in "House of Mystery" at Brooklyn Explains What Became of the Estate Left to Mrs. Mary Cook King.

New York, Feb. 2.—More than \$450,000 worth of goods, bought in four years' shopping in Brooklyn and New York are piled unused in rooms, closets and halls, nearly filling a large four-story brownstone mansion in Brooklyn, for 18 years unheeded. Ladies are heaped upon callus, furs on cotton, the faintest linens and silks stored with common household garments, \$500 gowns from the most fashionable dressmakers laid on cheap mother Hubbard, solid silver and cheap plate, the most fragile china sets mixed with ironware, crystal cut glass with common glassware—all cast into piles reaching as high as the ceiling, stuffed into closets and lying on the stairs. One entire floor is devoted to handkerchiefs.

TIMBER TESTS ARE OF MUCH VALUE

Big Structural Timbers of Pacific Coast Being Studied by Forest Service.

EXPERIMENTS COVER ALL GRADES OF PRODUCT

Red Fir First Among Structural Timbers of Importance on Coast Is Making Rapid Strides in Eastern Markets.

(Journal Special Service.) Washington, Feb. 2.—The study of the structural timbers of the Pacific coast was begun by the bureau of forestry, now the forest service, in 1905. In order to determine with greater accuracy the exact scope of their commercial use. At that time the only laboratory in the west suitably equipped for work of this character was that of the University of California. Accordingly, the first testing station was established there, and the program has since been steadily carried out since. Keen interest and hearty cooperation have greatly aided the work. The lumber mills of the coast have furnished all the timber needed; railroads and steamer companies have given free transportation for the test material; and the University of California has contributed the use of its well-equipped testing laboratory and a supply of power.

DIRECT PRIMARY LAWUPSETS ALABAMA POLITICS

Two United States Senators to Be Nominated by the People—Many Candidates.

(Journal Special Service.) Montgomery, Ala., Feb. 2.—Under the plan recently adopted by the state legislative committee for the nomination of state and federal officers at the primary this summer, it appears as if a lively race for United States senator will be precipitated. The senators are to be chosen at the primary because of the fact that the Alabama legislature meets but once in four years, while the term of Senator John T. Morgan expires next year, and Senator Edward W. Pettus ends two years later. The plan adopted not only provides that successors to the two senators shall be chosen at the primary, but it also makes provision for the selection of two alternate senators who are to be appointed by the governor in the event that Senators Morgan and Pettus, or their successors, should die or resign. This arrangement is a unique departure in American politics.
