Investigators to Recommend That "Hosing" System at Prison Be Dropped.

Walla Wash, Nov. 16.—The special commission appointed by Governor Mead to investigate affairs at the penitentiary finished the work yearterday and the various members left for their homes. As a result of the investigation the commission will recommend better sanitary conditions, better methods for exercising about 500 convicts lying in the prison unemployed, the need of giving more employment, the separation of the young convicts from the older criminals and the abolishment of the "hosing" system except in extreme cases where it is impossible to subdue unruly prisoners by any other means.

The commission will probably also recommend that the dining-room be enlarged and be fitted up so it can be used as a chapel and amusement hall. Whether the commission will recommend that the jute mill be enlarged is a question, as the proposed improvement will cost approximately \$100,000, while will cost approximately \$100,000

jurisdiction be extended from 16 years,
as it now is, to 18 years. Those interested in juvenile improvement believe that the age limit now fixed prevents the court from reforming many
youthful offenders who must now be
sent to jail because they are more than
16 years old.
