FRISCO LUMBER COMPANY IS DESTROYED BY FIRE. Yards of Union Lumber Company Burn, Causing a Loss of Quarter of a Million. (Journal Special Service.) San Francisco, Dec. 7.—The entire plant of the Union Lumber company, located at Sixth and Hooper streets, was burned early this morning, causing a loss of \$250,000. Five alarms in quick succession brought practically all the fire department to the scene. Notwithstanding the strenuous efforts of the army of firemen and all the apparatus, the overcoming of the flames was a hard task. The mill and yards of the Union Lumber company were entirely destroyed.

When it became apparent that the lumber establishment could not be saved, the firemen gave their attention to protecting surrounding property and succeeded in keeping the flames in check. The Union Lumber company's plant was one of the largest in the state and its destruction at this time is a serious loss.
