

HUGHES CHAGRINED AT TEDDY'S INTERFERENCE

Governor of New York Wants to Run His Own Presidential Campaign.

TEDDY MAY BECOME TOO ENERGETIC AS A FRIEND

Taft Realizes His Brother Blundered in Pronouncing the Taft-Forker Ohio Fight Contest Between Forker and Administration Friends.

(Washington Bureau of The Journal) Washington, May 4.—Governor Hughes of New York is much chagrined that President Roosevelt has taken charge of the Hughes fight in that state and has semi-officially announced that he will utilize the federal appointive power to ward the Hughes opponents.

Hughes and his friends incline to the belief that Secretary Taft's presidential hopes has suffered injury because of the well-defined impression that the secretary is largely the creature of the president and that the latter is really the person who is involved in the Ohio fight against Forker and Dick Hughes.

It is also claimed that even Secretary Taft realizes that a serious blunder has been made in Ohio by his brother, Charles F. Taft, who, while the secretary was in the south recently, issued a statement that the Taft-Forker contest in Ohio was actually a fight between the senator and the "administration's friends."

Still another mistake of the president was to send Third Assistant Postmaster-General Frank Hitchcock through the southern states ostensibly in the interest of Taft.

CLAIMS HIS DEBTS DUE TO WIFE'S DIVORCE SUIT

Acquitted of Charges of Actions Unbecoming an Officer and Gentleman — Courtmartial Finds False Representation Established.

(New York, May 4.—The findings of the court-martial which recently tried Major Francis F. Fremont, son of General John C. Fremont, "the Pathfinder," at the army building in this city on charges of alleged irregularities in his personal financial affairs, were made public tonight by the war department at Washington.

The alleged false representation—excepted in its findings by the court—of being owner of property seem to have been established beyond any doubt in reason.

The acts found by the court that he borrowed money on promises of payment from his officers and sent the Brigadier-General Grant, commanding the department of the east, taking the court to task for its leniency.

The trial of Major Fremont, who is one of the best-known officers in the service, attracted wide attention. Witnesses came from all over the country and even from Cuba to testify.

PERMISSION IS GIVEN BY INTERNATIONAL BODY

Union Men Will Be Paid Five Dollars a Week All the Time They Are Idle—Mayor Schmitt Makes Fruitless Effort to Arbitrate.

(Hearst News by Longest Leased Wire.) San Francisco, May 4.—Just before this morning's meeting of the street car men, President Cornelius announced that he believed that a street car strike could not be averted.

The ultimatum issued by Patrick Calhoun, president of the United Railroad, to the effect that under no consideration would the corporation recede from the conference proposition, namely, that there should be a sliding scale of wages from 80 to 40 cents an hour, which he declared he had accepted as the result of the conference with the authorized agents of the union, was read to the men.

Many of the speakers were eloquent in their advocacy of an immediate strike, while others counseled delay and advised further arbitration, declaring that it would be possible to adjust the difference in the demands of the men and the concessions that the corporation was willing to make.

Mayor Schmitt made a fruitless effort to effect a settlement during the day but very little was accomplished.
