

# FINANCIAL STANDING OF CITY NEVER BETTER

Immense Sum of Available Money Ready for Use on Call—Fully \$10,000,000 Will Be on Deposit When the Voted Bond Issue Becomes Cash.

With daily receipts of from \$10,000 to \$15,000 and a balance of \$1,262,291.71 remaining in nine banks of New York and Portland and the city vault, City Treasurer Werlein states that the financial condition of the city was never better. Four-fifths of the money is subject to check and the city could lay hands on the immense sum today if it were necessary.

However, this splendid amount will be increased immensely when the bonds voted at the Monday election have been converted into cash, the total being something like \$10,000,000. Eighty-eight thousand dollars will be paid into the city strong box during July by the liquor dealers of the city. The yearly revenue from this source amounts to \$350,000.

At the close of business May 31, city money was on deposit in Portland subject to check in the following sum: United States National bank, \$277,092.40; Merchants National bank, \$150,000; First National bank, \$75,723.34; Bank of California, \$152,500; Portland Trust company, \$200,000.

In interest bearing certificates of deposit the Portland Trust company holds \$100,000 of the city's money and Ladd & Tilton have \$135,561.54.

For the purpose of redeeming matured interest coupons, deposits are kept in the following New York banks: Chemical National, \$5,250; and N. W. Harris & Co., \$1,020. The cash in the vault at the city treasurer's office totaled \$35,777.67.

City Treasurer Werlein contemplates asking the city council to appoint a special committee to examine the ac-

counts at the end of every fiscal year, as he believes that the taxpayers should know exactly where their money is being spent and in what amount. There is no requirement for such a committee in the city charter and the action of Mr. Werlein in asking the council to appoint an auditing committee is entirely voluntary.

## IT'S A "CINCH" NOW TO "GET ON THE JURY"

All Summoned on Special Venire Are Entitled to Two Dollars a Day Whether or No.

A new expense to the county has been caused by the laws passed by the last session of the legislature, and it adds to the difficulty the sheriff encounters in obtaining special venires of jurors to try cases in the circuit court. The provision is that all who are served with summons on special venires are to be paid \$2, whether they serve on juries or not. Judge Fraser yesterday found it necessary to order 18 special jurors in order to secure a jury to try Beatrice Lewis, a colored woman. Of the 18 men whom the sheriff served, six were accepted. Judge Fraser, when he saw how many of the special veniremen were being disqualified, commented on the expense to the county, and instructed the clerk to tell the sheriff to send only men who were available for service. The sheriff threw up his hands in despair when these instructions reached him.

"What is there to do?" he asked. "If I serve a business man with a special venire summons he regards it as a personal insult. It is hard enough now to get special veniremen, but if we have to choose only men who are taxpayers, and citizens of the state and county, we will have to go over Portland with a fine-toothed comb to get the men." Under the old law special veniremen were paid only if they were accepted to serve. The new law gives each man summoned \$2, and if they are accepted as jurors they get \$2 a day.

## WASHINGTON SUPREME COURT DECISIONS

Olympia, Wash., June 6.—In the case of Charles Vletsen and wife, appellants, vs. J. T. Otis and wife, respondents, the supreme court has laid down the principle that it is illegal to sell real estate in this state at sheriff's sale in any county of the state other than that in which the real estate is situated, and it must be sold by the sheriff of that county.
