Among Other Features Jennie Johnson, Talented Contralto, Will Sing. Early Morning Blaze Followed by a Dangerous Explosion.

Miss Jennie F. W. Johnson, the talented contralto soloist of Chicago, will sing at the Chautauqua during the second week of the assembly, which begins July 9 and closes July 21. Her first appearance will be July 15, at the afternoon session.

The firemen were handicapped in reaching the source of the blaze, and the successive shocks of exploding chemicals made their positions on the ladders one of extreme danger. Half an hour after the fire started, a portion of the roof fell in and the heavy eave crumpled with terrific noise to the floor, completely demolishing a portion of the building.

Nearly all chemicals in the building were stored on the third and fourth floors, the third floor being also the operating room. Here the damage was heaviest, nothing but a case of cod liver oil remaining in sight. Laths and plaster are torn from the ceiling and wreckage is all over the floor. The third and fifth floors are scarcely less damaged.

What goods were not damaged by flames fell victim to thousands of gallons of water poured into the windows by the firemen. All this morning water poured from the ceiling and ran down the basement to shut off the flow. Such articles as porcelain operating-table dental instruments, and other materials impervious to water can be saved, but the proportion to the loss is so small as not to be considered by the owners.

The flames assumed a peculiar course, making it impossible to determine the exact point of beginning. When the police officers noticed the flames they were issuing from the top of the building. On the first and second floors there were evidences of fire, making the probable source a matter of speculation. The flames might have originated on the first or second floor, or on the basement, but probably never be known.

INTERURBAN PROJECT IN CHEHALIS COUNCIL Important Action Will Probably Be Taken Tonight on Chehalis-Centralia Electric Line. (Special Dispatch to The Journal.) Chehalis, Wash., July 1. B. J. Weeks of Tacoma, representing the Centralia-Chehalis Electric Railway & Power company, has been in conference with members of the city council to discuss the ordinance which his company has before the council for a franchise for an interurban line to connect Chehalis and Centralia. The privilege includes five acres of land at the northeast corner of the Donahoe farm for a park, there being a pretty grove at that place.

The general route of the carline in Chehalis will be on First street to West street, across the Northern Pacific Centralia street, thence to Boistfort, thence via Boistfort and Chehalis avenue to the court house, thence up North street to Cascade avenue, thence to Market street, and down to the river. This line as outlined would contemplate that if the line is eventually extended to the south and east it would use lower Cascade avenue. The franchise matter will come up at tonight's council meeting and Mr. Weeks gives assurance that if his franchise is granted he will continue the work on the line with actual construction, being willing to put up a \$1,000 check as a cash forfeit to the city in the event the line is not in operation within a year.

PENDLETON REDEEMS OLD LEVEE BONDS (Special Dispatch to The Journal.) Pendleton, Or., July 1.—Following the action of the finance committee of the city council, the \$40,000 of matured levee bonds have been taken up and the city has now no outstanding levee bonds other than the \$10,000 issue made last year. This \$40,000 represented the original cost of the old levee. They were sold 20 years ago and fell due today. The bonds redeemed draw 7 per cent interest while the new issue bears 5 per cent. The work of repairing and strengthening the levees will begin soon.

PORTLAND SHOPS ARE CLEANEST

Rose City List of Requirements Adopted by Jamestown Convention. High Compliment Paid Health Board. List Will Be Printed to Be Known as "Portland Board of Health Rules" for General Circulation Throughout United States.

In her monthly report on conditions of Portland groceries and meat shops, Mrs. Sarah A. Evans states that the convention she attended at Jamestown adopted the Portland list of requirements for a clean shop as a standard and recommended that the list be printed and sent to every city in the United States, to be known as the Portland board of health list.

The convention which Mrs. Evans attended represented an organization of 500,000 women and was one of the most notable ever held for the purpose of municipal sanitation. Local conditions have been very good in the past month considering the warm periods that prevailed and only three notices were sent out to dealers.

Some Bad Fruit Used. Following a complaint that the canneries were using poor fruit, Mrs. Evans began an investigation and found at once that some very bad fruit was put up and graded for sale. The manager claimed that the heat necessary to cook the fruit killed all the unhealthy portions and sent it to dealers.

Conditions on Front street were bad in warm weather because water used in scrubbing the waiting rooms of the S. W. B. at Front and Alder streets was run into the gutters and remains until evaporation carries it away. Mrs. Evans recommended that a catch basin be installed as soon as possible to carry the water away.

Laying of track on Front street made conditions bad. Dunes rises in huge clouds, settling on the fruit and food in the shops. The merchants were unable to remedy this condition and it was necessary to call in the aid of the street sprinkling department.

Mrs. Evans made the following inspections last month: 24 grocery stores, 41 fish and meat markets, 2 restaurants, 3 creameries, 45 commission houses, 2 factories, 13 bakeries, 23 miscellaneous shops. A total of 153.

UNCLE SAM NEEDS COLLEGE BRED MEN. College and university trained men only are eligible to a civil service examination just announced by the civil service commission. The examination will be for the position of chemist aid in the bureau of chemistry, department of agriculture, at a salary of \$1,000.

Other examinations announced by the commission are assistant in civil standardization, assistant steam engineer and assistant in arboriculture, on July 19; veterinary inspector and repairman July 24; apprentice, mint and assay offices, July 29; special agents and examiners, August 1; railway mail clerk, August 6.
