Lumber Company Offered to Settle With Employe Who Lost Hand.

By bringing suit against the North Pacific Lumber company Adam Granda lost not only a life position at the mill as foreman, but also the amount that he will have to pay his attorneys for

he will have to pay his attorneys for bringing the suit. In the circuit court yesterday he was awarded a verdict against the company for \$2,500.

Attorney R. W. Wilbur, who appeared for the lumber company, said after the trial that he had offered on behalf of the company to settle with Granda, giving him \$2,500 in cash and a position for life at the mill as foreman of the drying sheds or as head tallyman, at wages equal or more than those he was earning when he was injured.

At the trial a letter written by the At the trial a letter written by the company to Granda offering him a position was introduced in evidence. The offer of \$2,500 cash is said to have been made orally by Attorney Wilbur. At the time he was injured Granda was earning \$2,500 a day. The offer of settlement was rejected by Granda and he brought suit against the company for \$20,000. The jury gave him \$2,500. Granda lost his right hand by having it mangled between two cog wheels connected with the off bearing rolls at the main saw in the mill. aBy bringing the suit he loses the guarantee of a position for life, and will have to pay his attorneys with part of the money, \$2,500, awarded him by the jury.




