

GOVERNMENT TO RUN EVERYTHING

Knox Smith Suggests Federal Control of Corporations' Business.

(United Press Leased Wire.)
Chicago, Oct. 24.—Herbert Knox Smith, commissioner of corporations, addressed the National Civic Federation today. He made a plea for the establishment of an effective system of federal supervision of corporations. He said:
"The industrial machinery is so complex that it cannot be adjusted by an occasional remedy of judiciary proceeding. Establish a simple system of regulation by supervision, to be administered by a federal officer, who shall receive reports from corporations doing a certain amount of business yearly."
"The federal government is the only power that could carry on such a system of regulation."

THUNDER STORM DOES DAMAGE TO RAILROAD

Southern Pacific Roadbed Washed Out and California Crops Ruined.

Santa Paula, Cal., Oct. 24.—A terrible thunderstorm, accompanied by hail, struck this section yesterday injuring crops, washing away sections of the Southern Pacific roadbed and causing damage that will reach thousands of dollars.
The heaviest downpour was at Fillmore, a station seven miles from this city. There the rain amounted to a cloudburst. Two inches fell in less than an hour at Satway.
All the unthreshed bean crop is ruined. Hail did considerable injury to fruit and vegetables.

KAISER IS FORCED TO APPEAR IN COURT

JOURNAL'S EDITION BRINGS NEW PEOPLE

IRELAND MAY HAVE AMERICAN LIBERTY

Ambassador Bryce Has a Scheme for Home Rule Bill for Emerald Isle.

London, Oct. 24.—It is stated in well-informed circles that the British government has again taken under consideration the preparation of a new Irish home rule bill, based on a modification of the American system of state government. The idea, which has not progressed beyond the stage of informal discussion, is to make Ireland a state of the United Kingdom. It is declared that Mr. Bryce, who before he went to Washington as ambassador, was Irish secretary, has suggested the scheme.

S. C. Flint Dead.

About a month ago he was taken ill and was not expected to live but rallied and it was thought he was on the road to recovery but last night had a relapse and died suddenly. He leaves a wife, and three sisters. Mrs. Helen A. Flint, born, 329 West Park street, Portland; Mrs. R. E. Swick, Dayton, Oregon; and Mrs. S. E. Morgan, East Orange, New Jersey.
Mr. Flint was well-known in southern Oregon. For many years he was engaged in the banking business at Roseburg.

PRESIDENT SAVES LITTLE BOY'S LIFE

Youngster Had Crawled Under Passenger Train About to Move.

Lynchburg, Va., Oct. 24.—Quick work by President Roosevelt saved a boy's life yesterday. The president was standing on the platform of his car, which was being hitched to a passenger train while the rest of the train turned around in the yards. A boy, unnoticed by everybody except the president, crawled under the passenger train.
"Take that boy out of there," shouted Roosevelt to the trainmen. The wheels started to move close to the youngster when he was dragged out.

MORE COMPLAINTS OF SHORTAGE OF CARS

Salem, Or., Oct. 24.—Car shortage complaints continue to come with almost every mail to the office of the railway commission. A letter received yesterday from J. S. Landis of Myrtle Creek complains both of delay in supplying a car and 30 hours delay in removing it after his notifying the local agent that it was loaded, which resulted in the loss of 25 of his poultry. He also thinks he was illegally compelled to pay his fare while traveling with his stock.
A letter has been received from J. H. Pounds of Umatilla, saying that as the result of the action of the commission, conditions at that point have much improved and that he has no further cause of complaint.

the best. This is the time for action, not talk.
The loaning section of the stock exchange was the scene of excitement today. The National Copper bond, priced \$200,000 at 50 per cent, a syndicate of local bankers loaned \$2,000,000 at various percentages, while Rockefeller was loaning at 5 per cent. The First National bank loaned \$2,000,000 at 50 per cent.

Money loans are being called in all over the street and collateral sold because of the inability of borrowers to respond to the call.

The prices of many stocks were today at the lowest point in years.
It is conceded that Morgan has won the most important financial battle in his career. Assisted by Secretary of the Treasury Cortelyou and John D. Rockefeller, he has restored confidence to such an extent that normal conditions will be in evidence before the end of the week unless unforeseen things happen.

Superintendent of Banks Skinner estimates that \$200,000,000 was withdrawn from local banks in the past week or two. The Trust Company of America had paid out over \$1,000,000 when its doors were closed at the regular hour this afternoon, and has taken in deposits of more than \$1,000,000. The bankers say another day will see the end of the scare.

DECIDE NOT TO OPEN.

Pittsburg Exchange Will Wait for Flurry to Subside.

ize said assessment rolls, or to give the same any legal form or vitality.

"Pretended" Board.
At the outset of the petition, which is filed under the name of the Oregon & California Railroad company, by which name the Southern Pacific lines in Oregon are designated, the board of equalization is addressed as a "pretended" board. The petition then recites that the road owns extensive tracts of land known as congressional and railroad grant lands, and that the figures fixed by the assessor are "excessive, unjust, illegal and disproportionate to the assessment of other taxable property in said Multnomah county owned by parties other than your petitioner."

The tracks of the Southern Pacific in this county, with the rolling stock, improvements on the public levee and other personal property, have been assessed for \$700,000, in round figures. This does not include large tracts of real estate located throughout the county. The railroad asks that the assessment on this property be reduced about one half.

Regarding the assessment of its tracks and right of way, the road asks for the same figures as appeared on the rolls in 1906. There are 5.50 miles of track of the main line in this county, assessed for \$20,000 per mile. Reduction is asked to \$11,000 per mile.
The west side line consists of 8.93 miles, assessed at \$20,000 per mile. The railroad asserts that a proper figure for this section of track would be \$8,000. The same figures apply to the Yamhill division of 5.93 miles. On its congressional and railroad grant lands the company requests that the figures be cut from \$27.67 per acre to \$10.95.

THOUGHT WIFE WAS ONLY BANK FROM WHICH TO DRAW BOOZE FUNDS

Continued carousing and thirst for strong drink are ascribed as the reason for brutal acts of which S. E. Hamilton is accused in a suit for divorce filed by Mrs. Maggie Hamilton. The wife is the landlady of the Laporte lodgings at Third and Yamhill streets, which she inherited from a former husband, D. J. Smith.
The story told in the divorce complaint is one of repeated demands for money by which the husband desired to keep supplied with funds for carousing. It is alleged that he frequently borrowed sums up to \$50 that he squandered in drink, and that on one occasion, after a loan of \$50 had been refused, he drew a revolver from the bureau drawer and loaded it, with the remark, "I will show you if you will give me that \$50 or not."
On October 17, the wife alleges, after demanding more money to spend for liquor and meeting with refusal, Hamilton left the house and has not since returned. This did not end the demands for money, however, for the wife charges that since then he has written letters threatening her life if she does not supply him with cash. She says he has made several investments with money that is her own, Hamilton contributing nothing to her support. They were married on New Year's eve, 1902.

LOVE FLEW OUT THE DOOR WHEN HUSBAND KICKED WIFE OUT OF BED

Advised by her husband to go to the traditional and scriptural hot place when she asked him to pay the electric bill, Mrs. Mary A. Carey has begun suit for divorce from H. C. Carey, to whom she was married at Lafayette, Yamhill county, on June 3, 1897. She says that Carey has a habit of putting when around the house. For a month at a time, she says, he would be surly and scarcely speak to her.
Once when she tried to "make up" and restore her good humor with caresses he roughly pushed her against the wall, she says, and another time, in the month of January, she alleges that she was kicked out of bed into the cold. The Careys have two children of tender years, and the wife says that their father is not a fit person to care for them.
