

ONLY ONE BANK OPEN

Faro Bank at Milwaukie Club Still Cashes Checks but Pays Out Very Little—Sheriff Beattie Remains Hopeful.

Webb—I hear all the banks in Oregon are closed this week.

Foot—Yes, all but one.

Webb—And what's that?

Foot—The faro bank.

This fiendish joke is being perpetrated by those who have been in the neighborhood of the Milwaukie club this week. With every other institution in the state more or less short of ready cash because of the legal holidays, the proprietors of the gambling house in Milwaukie which is being run with the connivance of Sheriff Beattie of Clackamas county are widely spreading the "tip" among their friends that they have all the money they need, and will cash all checks drawn on their faro bank promptly.

Faro and card games which the astute Sheriff Beattie searched for in vain during his last memorable raid on the club are being operated as openly as ever. For a day or so after the last "raid" quiet prevailed in the club. Emboldened, however, by the evident farcical character of the sheriff's visit and the immunity which is guaranteed by the district attorney and other county officers of Clackamas county to the gamblers they resented and no attempt is being made to enforce the law.

When the fact that gambling is going on is brought before Sheriff Beattie he says that he can't find it.

District Attorney Gilbert L. Hedges, whose brother is the attorney for the gamblers, says he can't act if the sheriff doesn't.

So the law of Clackamas county allows the notorious resort to operate continuously without the slightest attempt to enforce the statutes. Occasionally, goaded by the expenses of the law and the demands of the law abiding people of the county into a pretended raid, Sheriff Beattie pays a friendly visit to the club.

The large building of the Milwaukie club is kept open daily and nightly, and the cars are stopping in front of its doors to allow players to reach the club more and more frequently. The rear room on the second story, where the faro bank is operated is crowded nearly every night. Poker and blackjack games are the favorite form of amusement downstairs, in the cardrooms in the rear of the bar.

PENDLETON DOES NOT FEAR WOOD FAMINE

CHADWICK MAKES FULL CONFESSION

Tacoma Thief Tries to Place Blame for Crime on Railroads.

(Special Dispatch to The Journal.)

Tacoma, Oct. 30.—"No greater school for criminals exists than railroading in Washington on the Northern Pacific and Great Northern railroads.

"Men are worked to a point beyond human endurance, generally from 15 to 20 hours on a stretch. When they rebel and refuse to work longer, they are blacklisted and then it is all up with them so far as railroading in this part of the country is concerned."

Claiming that he was driven to desperation because his sick wife and two children were starving and that because the Northern Pacific railroad had blacklisted him, making it impossible for him to secure work on any railroad in this section, James Chadwick today confessed to having robbed the home of Charles Funk, a local carpenter, of \$500 on September 22, and offered the above story as excuse for the crime.

Three pals of Chadwick plead guilty and are now serving terms in Walla Walla for aiding in the robbery. Not until today would Chadwick give in, his confession having been brought about by the statements of the county physician to the effect that Chadwick's wife has consumption and can live only a short time.

After pleading guilty Chadwick told how the robbery of the Funk home had been planned and executed. One of the quartet of robbers had learned that Funk had a can of gold pieces secreted in a bathroom in the Funk home. While two men decoyed Funk from his house, Chadwick and another looted the home. "My wife was sick and a preacher who owns a logging camp had swindled me out of a lot of money and left me without resources. I came to Tacoma to look for a job and tried the railroad," said Chadwick. "The railroad men informed me that I had been blacklisted and I could work no more for any line in this part of the country."

"Why do you think I was blacklisted?" "It was because after having worked 31 hours breaking freight I was ordered to go on to Seattle with the train. I was half dead from the long hours I had worked and refused. They fired me and then fixed me so that I could not get to work on the other roads. What is a man to do? If he holds his position he becomes little more than a beast, slaving without privileges of home and family and with an occasional spree as his only reward. If he is fired, then he is all to the bad."

Chadwick states that he turned a trick or two in Seattle, "but none that the cops are wise to." He fears it might go hard with him if he were found out. Shortly before committing the robbery in Tacoma Chadwick opened a restaurant adjoining the Eagle bar at Auburn. The man claims that railroad men are daily driven to crime, either against the railroad or outsiders, by the long hours they are compelled to work and by the fact that the blacklist operates against them once they are discharged.

GIRL PRESENTS BULLET TO MAN

Grete Beier Confesses to Murder at Berlin of Man She Was to Marry.

(United Press Leased Wire.)

Berlin, Oct. 30.—Confession of a crime of the most brutal character has been cautiously made by Grete Beier, a good-looking girl of 22, the daughter of the late mayor of Brand, in Saxony. For cool deliberation on the part of the perpetrator, who shared her victim with a joke, the story is one almost without parallel in criminal annals.

On May 14 a chief engineer named Pressler was found lying dead in the furnished room which he had rented in the great industrial center of Chemnitz. A bullet had passed through his head by way of the mouth, the revolver from which it had been fired was at his side, and appeared to point to suicide. His landlady, however, insisted that the dead man had never possessed a firearm, but the police scoffed at her assertion, and came to the conclusion that he had taken his own life.

There the matter was allowed to rest. It was remarked at the time, as an especially sad feature of the case, that Pressler was shortly to have been married, and among his papers was found a will leaving his entire possessions to his fiancée, Grete Beier.

She, however, soon consorted herself with another lover, a merchant named Menkel, living in Dresden. Subsequently her father died, and a few days ago she, her mother, and her new lover were all taken into custody on a charge of forging the will of the late chief engineer. In connection with the accusation the house was searched, and a number of papers were discovered which suggested that the girl must have had a hand in the death of her former lover.

On being confronted with these evidences of her crime the girl confessed to it in the most heartless manner, telling the story as though it was a good joke. She said she had called upon Pressler, and with a great show of emotion and high spirits, told him that she had just been to the fair and bought him a beautiful present. It was, however, to be a "surprise," so he must allow himself to be blindfolded. To this he good-naturedly submitted. Then she told him to open his mouth, and this he also did. The girl then whipped out a revolver, and coolly placing the barrel between his teeth, blew out his brains. She had taken with her fellow visit to the unfortunate man the will that was found leaving everything to her.

KENNEWICKERS MEET OPEN RIVER BOOSTERS

Kennewick, Wash., Oct. 30.—The Kennewick Commercial club has returned from an excursion to Priest Rapids, White Bluffs and Hanford as the guests of the Columbia River Steamship company. The club viewed with much satisfaction the progress of the Hanford Irrigation company's power plant at Priest Rapids, where 300,000 horsepower will eventually be harnessed and made to turn wheels in factories 100 miles away. Two steam shovels, several locomotives and a small army of men are at work. Those in charge say that the plant will be turned into the Hanford company's ditches in the early spring. Thirty thousand acres of excellent land will be irrigated, cut up into 16-acre tracts and sold to actual settlers.

While at Priest Rapids the Commercial club met for an evening session on board the Moundain Gem. Addresses were made, Dr. Blalock, speaking of the importance of an open river, mentioned that plans were under way for increas-
