The constitution declares that no new county shall be created that no new county shall be created with a population of less than 2,000 nor shall the county from which, it is taken be left with less than 4,000 population.

The act creating the new county pro-vides that the question of population shall be ascertained by a judge of the superior court 'in the nearest judicial district to the county of Chehalis,' etc. The supreme court holds that in this provision the legislature has attempted to delegate power which it should ex-arcise itself. The legislature, says the court, is required to know that it is meeting the requirements regarding Grapple

population. Judge Mount, in his dissenting opin-ion, holds that the question of popu-lation is sufficiently safeguarded by the provisions of the act, and that the legislature made ample provision for the creation of the new county.
