Mr Manning's opinion reads as fol-

lows "Replying to your favor of November 6, 1907, as to whether the county (lerk should record instruments at this time, I desire to say that section 1005 of Bellinger and Cotton's code provides that the county clerk shall keep his office open for the transaction of business on every judicial day from 8

to 12 o'clock in the forenoon, and from 1 to 5 o'clock in the afternoon. And section 946 of the statutes, as amended by the laws of 1893, page 103, provides that January 1, February 22, May 30, July 4, the first Monday in September, and December 25, and any day on which an election is held throughout the state, or any day appointed by the president of the United States or by the governor of this state, as a day of fasting. to 12 o'clock in the forenoon, and from of this state, as a day of fasting, thanksgiving or holiday, shall be non-judicial days, except for certain pur-poses therein mentioned, which, in my judgment, does not in any way apply to the county clerk.

"This section appears to be the last enactment of the legislature on the sub-ject of non-judicial or holidays. I am. therefore, of the coinion that you are not authorized to receive or record in struments or do business as a county clerk on this day."




