

COUNTRESS VISITS ADMIRAL SNOW THE FAR NORTH OUT OF SERVICE

Meherene de St. Pierre Arrives at Seattle From Alaska on Way South.

Commandant at Charleston Navy Yard Placed on Retired List.

Seattle, Wash., Nov. 18.—Two thousand miles through the wild region north of Edmonton, with only Indians for her companions much of the time, the journey completed recently by Countess Meherene de St. Pierre of St. Briac, Brittany, France, who is now a guest in this city. The trip consumed the greater part of three months during which time the French countess traversed treacherous streams in canoes, penetrated vast forests on foot, climbed barren mountain slopes and performed numerous other difficult feats that fall to the lot of those that answer the call of the wild and get close to nature.

Tiring of the continuous round of social duties that falls to the lot of a titled woman in gay Paris, the countess determined to make a journey through the practically unexplored part of North America. From Seattle Countess de St. Pierre goes to San Francisco and thence to Mexico. Before returning she will stop at the residence of President Roosevelt and at his request will give him a brief account of her journey.

Execution of Japanese Soldier Who Became Gambler, Leaving Regiment.

Tokio, Oct. 14.—Deserter and incendiary, Iwanatsu Zenzo, aged 24, was shot yesterday by order of court-martial. He died displaying all the traditional fortitude and courage of the Japanese.

Zenzo belonged to the Fourth regiment of the second army division, stationed at Sendai, in the north of Japan. He deserted the regiment and joined a party of gamblers. Hunted by the police, he took refuge in an inn and early next morning set fire to the place, taking what valuables he could lay his hands on. He was arrested and sentenced to death. He was told of the court's decision, and burst into frenzied protests. When his emotion had subsided they told him again that he must be shot and advised him to prepare for the end. A change came over the man's face as he listened to their words. Rising from his seat in the cell, he held up his arms that they might more easily strip his khaki uniform from him.

"I am ready to die," he said, simply, and was moving from the cell when his aged father and mother came to the door to bid him farewell. Zenzo turned his head away, saying, "I do not fear death, but if I see my father my heart will fail me. I want to die bravely."

Overnight he had composed a poem, in which he regretted that he had ever been led to join the army, for he had proved himself unworthy of serving the emperor. Translated the words ran something like this:

I err in my heart for the sake of my country.

The penalty is death, but I do not fear; Yet how bitter it is to fall like a felon, Riddled to death by the guns of my friends.

Many spectators were allowed on the execution ground. The aged parents, holding each other's hand, stood with bowed heads among the crowd. Zenzo, singing the verse that he had written, walked bravely from his cell into the open yard. A white wooden cross had been erected in one corner. He walked up to the cross, stretched out his arms as though to measure the length of the crossbar, then turned again to the officials. He asked and obtained permission to say goodbye to Captain Nakamura, under whom he had served. In silence the two men gripped hands.

Then Zenzo turned to the squad of six riflemen who were drawn up 20 paces from the cross. A cup of water was handed to him that he might moisten his lips before he spoke. "You must shoot me," he said without a tremor, "because I have been disloyal to those who were in authority. If my death serves as a warning to others I shall not have died in vain. Comrades, goodbye."

He stepped back to the cross, threw out his arms, and a white linen cloth was drawn over his face. "Good-bye, Owar!" ("I am ready") he called. "Banzai! Banzai!"

The rifles cracked. The wooden cross shivered, and Zenzo's corpse hung limply from the bar. A priest offered up a prayer, and the spectators, weeping loudly, knelt down before the corpse and prayed for Zenzo's soul. The body was handed to the relatives for cremation. Washington, Nov. 18.—After 46 years' service under Uncle Sam in the United States navy, during which time he rose from the rank of ensign to one of the highest positions in the navy, Rear Admiral Albert S. Snow, United States navy, who has been commandant of the Charleston navy yard for several years, was placed on the retired list today, having reached the age limit of three score and two years. He is succeeded in command of the Charleston navy yard by Captain William Swift.

Rear Admiral Snow leaves the service with a brilliant record. He is a native of Maine and entered the naval academy in 1861. He served with the Asiatic squadron from December 1, 1869, to March, 1873, and took part in the attack on the Korean forts. In 1880 he reached the grade of lieutenant commander. He was on the coast and geographical survey from 1883 to 1887. He was promoted to the rank of commander in 1890, and was inspector of the light-house district from 1895 to 1897. He was then appointed commandant of the naval station at San Juan, Porto Rico, commissioned as a captain in March, 1899, and commanded the New York during the following year. From 1901 to 1905 he commanded the receiving ships Hancock and Vermont.

Captain Swift, who succeeds Rear Admiral Snow at Charleston navy yard, is a Connecticut man, 59 years of age, and has been in the navy since 1863. He has served in all parts of the world. He is one of the ordnance and torpedo experts of the navy, and was one of the officers prominently identified with the building of the present yard. He has been head of the war college at Newport, at the ordnance bureau, and was ordnance officer and director at New York during the Spanish war.

NEW YORK HORSE SHOW BIG AFFAIR

New York, Nov. 18.—The annual exhibition of the National Horse Show association, which is looked upon as the beginning of the winter's social season in the metropolis, opened today in Madison Square Garden, the immense amphitheatre being gorgeous in decorations of orange and black, the colors of the association.

The big exhibition is much the same as in the 22 years of the show's earlier history, the list of exhibitors announced including about all the well-known names of exhibitors in other shows of recent years. The entries in almost every class are as numerous as usual, and the horses are said by experts to be unusually high, insuring keen competition for the blue ribbons.

Several changes have been made in the premium list, among the new special prizes offered for competition are the Forest King cup, the Gold Lace cup and the Macley cup. The Forest King cup is probably the most valuable trophy yet given for a show ring competition in America. It was donated by William H. Moore to replace the Waldorf-Astoria cup, won by him last year with his noted hackney high-stepper, Forest King.

Two women are among the amateur whips who are to try for this trophy later in the week. Mrs. Jarvis Hunt, a new exhibitor from Chicago, is to drive Golden Flash, a novice horse, and Miss Emily Bedford of Brooklyn will show the Hildray hackney mare that won the Waldorf cup in 1904.

The list of other prominent exhibitors includes Reginald C. Vanderbilt, J. W. Harriman, C. W. Watson and Harry D. Holloway of Philadelphia.

DUTIES OF VARMINT KILLER ON RESERVES

Helena, Mont., Nov. 18.—Henry Hackett and Charles Williams, both of Dillon, have been appointed as hunters and trappers in the Big Hole forest reserve. They have spent years as trappers and hunters of wild animals and are considered among the best in southwestern Montana. They will be furnished with ammunition, poison and traps and will be paid \$75 per month and will be permitted to receive a bounty on animals killed and to retain the pelts. Their duties will be to hunt down stock-killing animals and no other duties of the forest service will be exacted.

The assistance of the government in exterminating these animals is highly appreciated by the livestock interests of this state and will be still more when the work shall be extended throughout the various forest reserves, gradually extending until all are included.

NICHOLAS BOLEY'S BUSY LIFE ENDED

He lived in Benton county, Oregon, until 1870. In 1873 he removed to Salem, where he practiced dentistry. In 1880 he was elected treasurer of Grant county, and was re-elected in 1882. He held the office again for two years in 1886 and 1891. He was also county judge for a number of years. He is survived by his wife, two sons and five daughters.

START COAST LABOR FEDERATION SCHEME

Seattle, Wash., Nov. 18.—Organized labor in Seattle has started a movement that is expected by prominent union men to result eventually in the formation of a Pacific Coast Labor council which will direct union matters on the coast and have a large share in the work of the American Federation of Labor. The Bakers' union gave definite direction to an agitation that has been in evidence for months by voting last Saturday night in favor of a Pacific Coast Federation of all the unions embraced in this trade. This action will be followed by a vote on the question of a Coast Federation by the Bakers' unions in all the large cities at least and probably in all cities where the bakers are organized.

EUGENE BANKERS PUT OUT PAPER

Eugene, Or., Nov. 18.—The Eugene Clearing House association, recently organized, has decided to issue \$10,000 in clearing house certificates to relieve the present money shortage, and the certificates will at once be placed in circulation, they having been printed in Portland last week. They are in denominations of \$1, \$2, \$5 and \$10.

Portland and San Francisco clearing house certificates have been pretty generally circulating for some time, but two weeks, and have been accepted by all business men, but not enough of them have appeared in Eugene, so the local clearing house decided to issue certificates of its own.

HUNTER FIGHTS VICIOUS EAGLE

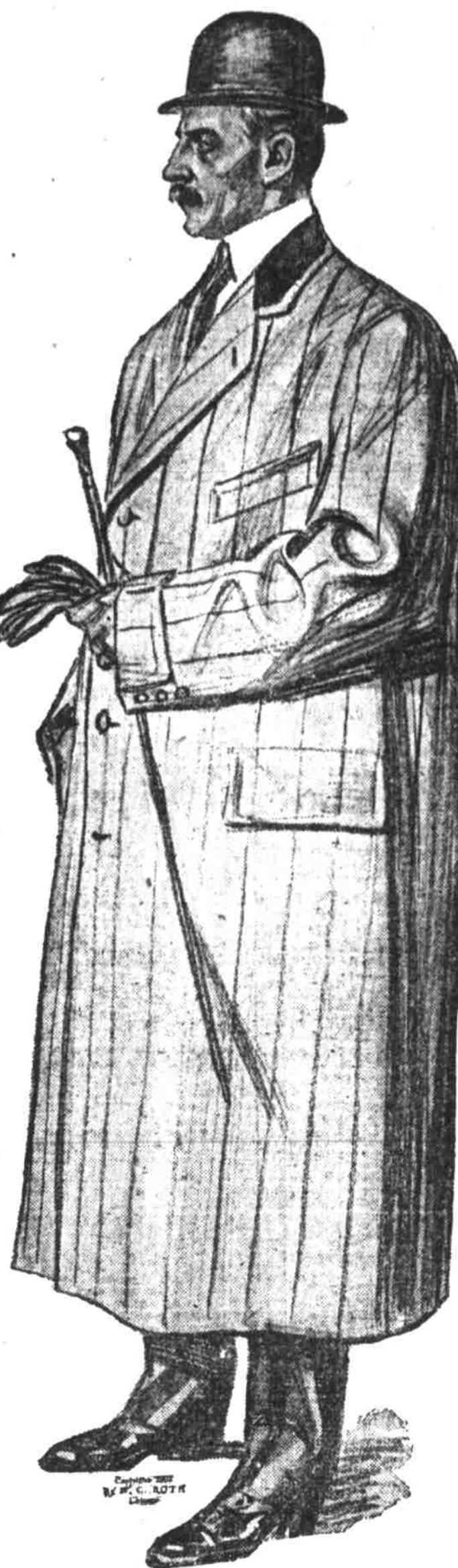
Single Tax Conference.
