## M. A. C. LOSES TO SPOKANE MEN

### Edgar Frank Loses to Adams on Decision After a Long Struggle.

Multnomah lost the boxing and wrestling tournament to Spokane last night, before one of the biggest crowds that has ever turned out to an entertainment at the club. It was undoubtedly the best exhibition ever held at the club, and the crowd appreciated the fact and applauded to the echo. Four good boxing bouts, two of them intercollegiate, and two preliminaries, together with two fast wrestling matches, kept the crowd on their feet continually.

Multnomah men were keenly disappointed in the defeat of their favorite, Edgar Frank, but their feelings did not prevent their appreciating the good work of the visiting clubmen. Spokane made a clean sweep of the wrestling matches, Adams won from Frank on aggressiveness and although he weighed eight pounds more than Frank he was unable to put the lighter man's shoulders on the mat.

They struggled through two 15-minute rounds, with Frank always on the defensive. Adams used a foot hold that wore Frank out but he was unable to put the Multnomah boy on his back. Elley of Spokane, won from Dennis on a trip-fall, lost the second to Dennis on aggressiveness and won the third on a fall. This made two for Spokane and practically saved them the tournament.

Slugging all the way through the four rounds and weakened by the loss of three pounds to make the weight, Ed West staved off Gene Sullivan, the Spokane boxer, for three and one half rounds, finally succumbing to one of the visitor's punches. In the early rounds West had the Spokane lightweight all to the bad but lacked the wallop. This was one of the best matches from a slugger's standpoint, that has ever been seen in the club gym.

Although he was compelled to give his opponent 13 pounds Henry Niecken also gave Earl Rickey, the Spokane man, a haymaker that he will remember for years to come.

It took but one minute and 47 seconds for "Mike" to put the kibosh on the man with the gin-like name. The victor drove a hard right to the solar plexus, which lifted Rickey off his feet and, as he was descending to terra firma, the Portland lad shot over a quick jab to the point of the jaw. That was enough to send Rickey to the land of nod.

There were two preliminaries. The one between Bud Hughes and Miller was awarded to Hughes, after a spirited match. Handley won against Crosby after a stunning exhibition. Crosby's muscular development elicited much applause.

## OVER MILLION TO BE SPENT ON STAKE RACES

New York, Jan. 1.—By agreement entered into for stake races for the spring meetings in 1908, the best of the Brighton Beach and Sheepshead Bay tracks, the closing of the stakes will take place promptly at 2:30 o'clock. The closing for fall stakes and fixtures for the next two years will be announced. The value of the combined stakes which will be closed exceeds \$1,000,000. Among the spring stakes are the three great events of the turf, the Brooklyn handicap at Gravesend, the suburban at Sheepshead Bay, and the Brighton handicap at Brighton Beach. It has been decided to raise the value of the Brooklyn handicap and the suburban to make them of equal value with the Brighton handicap, \$25,000.

## ONLY SIXTY-TWO CAN HUNT ON NEW YEAR'S

### Few Duck Shooters Obtain Licenses—Four Thousand Were Issued Last Year.

Only 62 persons in Multnomah county are authorized to hunt ducks today. That is the number of game permits issued at the office of the county clerk in the last two days, since the licenses for 1908 have been obtainable.

Under the reading of the law anyone who hunts ducks or other protected game must obtain a new license for the year, contributing \$1 to the state for the privilege, and failure to do so subjects the hunter to prosecution if he is detected.

A steady stream of applications for licenses is expected from this time on, over 4,000 being issued in 1907. The great rush does not come, however, until after the opening of the season for the chief game birds, which is September.

### Accused Man Must Face Circuit Court on Charge of Killing Oscar Allen.
