GRAFTER RUEF SHOWS ABJECT FEAR ON STAND

EX-BOSS HAS JAIL IN SIGHT

Eyes Bloodshot and Face Bloated He Faces Court and Gives Evidence of His Weakness Under Fire.—Fears Conviction.

State Senator George Keane, Schmitz' Henchman and Ex-Secretary of Board of Supervisors, Acts as Counsel.

San Francisco, Cal., Jan. 20.—Abraham Ruef, defiant and sulled, but unable to conceal his fear, this morning appeared before Judge Lawlor in the preliminary skirmish of the battle which is soon to begin to place him in prison. Judge Lawlor ordered the case set for trial on Wednesday, but at that time it is probable that a continuance until some time next week will be granted, when the prosecution of Abraham Ruef upon one of the trolley cases will be vigorously pushed to an early completion.

Through his attorney, State Senator Keane, he whined out his defiance to the prosecution and at the same time complained of his treatment at its hands, alleging that it had broken faith with him. He still refused to break his silence concerning his plans but for the first time in many months his air of confidence and cheerfulness deserted him. His eyes were bloodshot, his face bloated and his entire aspect was of a person in a deadly fear.

When the United Railroad cases were called this morning all doubt as to the change of the graft prosecution in regard to Ruef were quickly set aside as District Attorney Langdon immediately asked that the case of Ruef be set for trial next Monday. In reply Attorney Keane, ex-secretary of the graft board of supervisors, in behalf of Ruef, made the following objection:

PLASTERERS GO OUT ON STRIKE

Refusal of Contractors to Continue \$5.50 Scale Results in Walkout.

A general walkout of union plasterers took place this morning as a result of the refusal of the master plasterers and contractors to continue the \$5.50 wage scale. The plasterers were working under an agreement made early in December that the wages should be \$5.50 a day until January 18, when the scale would be reduced to \$5. This agreement was made at the time wages were reduced from \$6 to \$5, the master plasterers agreeing as a compromise to pay \$5.50 until today, when a further reduction of 50 cents was to go into effect.

THAW'S WIFE ALLOWED TO TELL STORY

Great Victory Won by Defense When Court Rules That Evelyn May Repeat Her Experiences With Her Husband's Victim.

Jerome Protests Against Admission of Horrible Tale in Evidence But Court Sustains Lawyer Littleton's Contention.

New York, Jan. 20.—Evelyn Thaw was recalled to the stand this morning when the trial of Harry Thaw was resumed. She will complete her story before other witnesses are called.

As soon as Evelyn Thaw was called to the stand by the defense, District Attorney Jerome renewed his motion to have the public excluded during the time she gave her testimony. After giving his reasons, Justice Dowling denied the motion, and Attorney Littleton plunged into the examination of the witness relative to an interview with Harry Thaw in Paris, in which she confessed she couldn't marry Thaw because of the alleged wrongs done her at the hands of White.

She said the next time she met White was in the same apartments, she having accepted an invitation to attend a dinner there after the show. When Evelyn Thaw was asked if she told Thaw about her mother she said she told him that White sent Mrs. Holman to Pittsburg and that she defrayed all his expenses on that trip. At this juncture Jerome objected with the declaration that the witness was indulging in too many after the fact explanations. The district attorney asked the court to instruct the witness to tell all she told Thaw. Justice Dowling ruled to this effect over the protest of Attorney Littleton. Evelyn continued by saying that she told Thaw all she knew about her mother's trip, stating that White sent her to the depot in a cab and later took the witness to the Madison Square tower in the same vehicle.

Then the witness told the story of her posing in a Twenty-second street gallery for pictures. On the following night she accepted another invitation from White to attend a dinner party in the tower. When she arrived, White was alone, although the table was set for four. Evelyn testified that White suggested that before they sit down at the table she show her the rest of his apartments. She accompanied him to the mirror room, and when they reached the bedroom White insisted that she drink a glass of wine.
