Likeness of Ben Holladay
May Soon Hang in the
City Hall.

Councilman Belding will introduce a resolution in the city council this afternoon requesting that space be allowed for the hanging of a huge portrait of Ben Holladay, at present in the custody of Curator George H. Himes of the Oregon Historical Society.

Holladay was the pioneer in the transportation movement west of the Mississippi river and the first to have had what was known as the pony express carrying mails across the plains.

An interesting incident in this connection is that Himes, who was at that time in the printing business, printed the first railroad time card ever used in the United States.

Mr. Belding has been anxious to have the portrait hang in conspicuous place instead of allowing it to remain hidden in a dingy record room, where it is stored at present.

It is stated that the portrait of Holladay in his prime, the painting was done in 1868. In speaking of Holladay and his work today, Mr. Belding said:

"No other man did so much to bring transportation facilities to the Pacific coast as Holladay. He was the pioneer and for that reason I believe his portrait should be placed in one of the light walls in the city hall, where it can be seen by all visitors."

"When I was a young man Holladay was the greatest man on the coast. His energy and ability won him recognition everywhere, and that he is so little known to the present generation is a great misfortune. Holladay struggled for the people of the coast in a way that deserves better remembrance. All of his life's work was along the transportation line, and the present development of the coast is due largely to his efforts."

It is being erected on the same ground, but it is to be more of a skyscraper than the old hotel, which was known around the world."
