## CONFESSES MURDER TO FELLOW PRISONER

### JOE ANDERSON UNFOLDS PLOT TO FOIL POLICE

#### Revolver That Was Used to Kill Harry Logan Found Where Jacob Hilt Said Anderson Told Him It Would Be Discovered—Witnesses Were to Be "Done Up"

By the recovery of the revolver with which Engineer Harry M. Logan is thought to have been killed and admissions made to a fellow prisoner by Joe Anderson, whose trial for the murder of Logan is to begin February 11, the shadow of the gallows has drawn close to the accused man.

On last Sunday, just three months from the date of Anderson's arrest, acting on information furnished by Jacob Hilt, to whom Anderson made admissions, Detectives Tichenor and Jones recovered the revolver from the slough on the east side at exactly the point where Anderson told Hilt it would be found.

Anderson also confessed in Hilt that he had fired the shot that killed a conductor of the Rose City Park car line and that he had a part in numerous holdups previous to his arrest. The proposals which Hilt says Anderson made to him show that startling plans for wholesale murder have been concocted by Anderson, by which he proposed to kill witnesses who are to be called to testify against him and to revenge himself on the officers who have built the chain of evidence around him.

Anderson also confessed in Hilt that he had fired the shot that killed a conductor of the Rose City Park car line and that he had a part in numerous holdups previous to his arrest. ### PRESIDENT TO SEE UNFAIR LIST

#### Manufacturers Will Appeal to Roosevelt to Aid Them in Fight.

Washington, Feb. 4.—As a result of the sweeping anti-boycott decision by the United States supreme court yesterday a movement has already been started among manufacturers who are represented on the "unfair list" of the American Federation of Labor to petition Roosevelt for relief.

Daniel Davenport, counsel for Loewe, upon whose complaint the case was decided, is authorized by the statement that the matter will shortly be brought to the attention of the president. He points out a paragraph in the recent message by the president in which Roosevelt states that he would enforce the law against a labor union as quickly as he would against a corporation.

### TEN THOUSAND MOORS DIE IN BATTLE WITH FRENCH NEAR SETTHA

Tangiers, Feb. 4.—Ten thousand Moors were killed or wounded yesterday in a battle with the French troops near Settha. The French army lost 160 men in the clash.

Reports of the battle were received here from the front today.

### CHICAGO CHIEF TO RAID REDS

#### Shippy Declares Anarchists Must Make Home Outside of Windy City.

Chicago, Feb. 4.—Chief of Police Shippy today held a conference with Corporation Counsel Brundage on ways and means to stamp out the colony of anarchists now living in Chicago. The chief declared that the recent events in Chicago almost duplicated the events that led up to the Haymarket riots of a decade ago. "They begin by holding indoor meetings, demanding the right of free speech; then they demand the right to hold outdoor meetings, and when refused start riots, defy the police and trouble follows."

Shippy declares that there are at least 50 anarchists here, including some from the Paterson, New Jersey, colony and some from Germany and Russia.

### HEAD OF MANUFACTURERS' ASSOCIATION HOLDS OLIVE BRANCH TO UNIONS

### FORTUNE MAKING TIRESOME WORK

#### Kings of Finance Beginning to Grow Weary of Coin Chasing.

New York, Feb. 4.—Are the high financiers of the country gradually turning over their troubles to their heirs? Wall street seems to think so, and incidents are cited showing that Morgan, Carnegie, Rockefeller and others are stopping the financial pace that overtakes the dollars and letting the "young fellows" do the work.

Recently there has been a tendency on the part of the very rich men of the country to ease up on the strenuous life of making money. Rockefeller does not give so much personal attention to the affairs of the Standard Oil company that he did in past years, and 1905 opens with less aggressive action on the part of the big oil monopoly than formerly. This may be because the Rockefeller interests are now so widely spread over the world that the "young fellow" cannot handle them so well as the "old man."

### FAIRBANKS MINERS LOSE

#### Union Faces Complete Defeat in Fight Started Last Year—Card System Established by Employers Effectually Shuts Out Organized Labor.

Fairbanks, Alaska, Feb. 4.—After a fight which started on April 26 last year and which has been prolonged ever since, the miners' union is about to face complete defeat, for the strike which was ordered for February 1 has been a dismal failure. What few men went out were quickly replaced.

Today the mine owners established a card system by which no union man employed in the mines can obtain employment. No union men will be given cards. Many of the men who were and are still strong advocates of the union condemn the officers for calling the strike, saying they won their point when the operators agreed to a scale of \$5 a day and board and lodging for eight hours work.

Since it has been seen that the strike is a failure a number of operators who shut down have declared their intention of opening up as soon as they can get enough men to make up a crew. The outlook now is that this district with the labor troubles settled will produce \$15,000,000.

### ALICE MAY BUY YARMOUTH OFF

#### Earl Willing to Drop Fight Against Divorce If Wife Pays Him Enough.

London, Feb. 4.—Legal advisers of the Earl of Yarmouth and the Countess of Yarmouth, formerly Alice Thaw of Pittsburgh, are meeting today in a conference in which it is hoped that the question of financial settlement may be arranged whereby the earl will withdraw his contest for the wife's suit for divorce and secure a certain monetary return. The suit for the annulment of the marriage is set for tomorrow.

It is generally understood that the earl would have no objections to his wife's suit beyond the fact that the loss of his share of her income would leave him poverty stricken.

Prior to his marriage Yarmouth was a very poor man, who gained a rather uncertain living as a vaudeville actor in the United States and the English colonies. He has no desire to resume his acquaintanceship with the stage.

### REFUSE TO REDUCE RATE

#### Louis Hill and Howard Elliott Declare They Would Lose Money Hauling Lumber Under Old Tariff and That They Will Not Compromise.

Seattle, Wash., Feb. 4.—The northern lines will have no compromise to offer the lumbermen on the question of rates and while President Louis Hill of the Great Northern and President Howard Elliott of the Northern Pacific will meet with the conciliation committee, they declare that nothing can come of it.

"There is no money in hauling lumber at the old rate," said President Hill last night. "The lumbermen will find that they will have to pay a reasonable tariff. We shall be glad to meet with the committee of business men but I believe it will be labor lost so far as the question of freight rates on lumber goes."

The lumber dealers of the east have put their prices down a little and it is likely that they will go down to some extent here. Everybody would be glad to see a resumption of business but the railroads cannot afford to haul lumber at the old rate.

### THAW WILL NOT STAY AT ASYLUM

New York, Feb. 4.—Attorney Littleton made it plain today that he did not intend to take up the matter of securing Thaw's release from Mattawan at once. At the same time he expressed an opinion that the board of lunacy would soon transfer Thaw to some other institution.

### RELIEF FUND DISAPPEARS

Providence, R. I., Feb. 4.—The city council of this city would like to know what has become of the \$5,000 check which was sent to the San Francisco relief fund in April, 1905, and which has never been acknowledged or the canceled paper never returned. A stop order has been put on the check until the mystery of its disappearance has been cleared up. As the San Francisco relief committee is now practically out of existence the money will probably be retained in the city treasury.

### ICE MAGNATES SENT TO JAIL

Toledo, Ohio, Feb. 4.—R. A. Bard, B. Demmons and Joseph Miller, convicted as members of the Toledo ice trust, were sentenced to six months in the county jail today by Judge Kincaid. The men were convicted in a long trial before Kincaid in 1905 and were sentenced to the workhouse. They appealed to the supreme court and their case was remanded for a hearing. The original sentence carried a fine of \$2,500, but the judge remitted this and fined them the costs of the suit in connection with their jail sentence.

### EDITOR SUSPECTED OF CAUSING DEATH OF PORTUGAL'S KING

Washington, Feb. 4.—Upon motion of Congressman Cousins of Iowa, chairman of the committee on foreign affairs, the house of representatives today adopted a resolution of sympathy with the people of Portugal over the assassination of King Carlos and the crown prince.

Lisbon, Feb. 4.—The bodies of the late king and the crown prince lie in state in the chapel of Nossa-Senhada da Saude. Many masses have been celebrated for the souls of the departed members of the royal family, and the mourning throughout the city appears to be general and genuine. Politically the condition of the state is still in a ferment. Out of the cabinet chosen yesterday by three ministers remain. The new ministers are: Manuel Moreira (Finance), Henrique Gouveia (Interior), and Augusto Duarte (Public Works). Duarte is a member of the cabinet.

### MILLION FOR GREAT INDUSTRY

#### Official Confirmation of Report That Schwartzchild and Sulzberger Will Establish Packing Plant in This City.

Louis Zimmerman Will Transfer His Interests to Big Chicago Concern—Firm Buys Large Tracts of Land.

Arrangements have been completed by Schwartzchild and Sulzberger, the greatest of the independent packing companies, to use the plant of the Zimmerman Packing company, in South Portland, as a temporary plant until they can complete the enormous stockyards and plant they are planning to construct in Portland.

Louis Zimmerman of the Zimmerman company announced today that his plant would be used by the Schwartzchild and Sulzberger company and would probably be finally taken over by the big packing concern.

As was exclusively announced in The Journal two months ago, that Schwartzchild and Sulzberger was going ahead with preparations to eventually make Portland the headquarters for the Pacific coast, but the announcement made today by Mr. Zimmerman is the first statement of their actually beginning work in this city. The plant which they are planning to erect here will cost \$1,000,000.

General Manager Elderidge of the Schwartzchild & Sulzberger company has secured options on several large tracts of land in South Portland and one on the Peninsula. It already owns considerable land on the peninsula.

"There is no doubt that Schwartzchild & Sulzberger will establish a packing plant in Portland," says Louis Zimmerman of the packing company located in South Portland and bearing his name. "The big eastern concern has already made arrangements for slaughtering temporarily at its plant, but the company intends to invade this field with one of the largest and most up to date plants in the United States."

"There has long been a great need for a large independent packing company on the Pacific coast, and Schwartzchild & Sulzberger will find a hearty welcome from the butchers, because they have been forced to pay too high a price for everything they bought from the killers in control of the market."

**Has Land Options.**

"I know positively that Schwartzchild & Sulzberger, have options on several tracts of land, and the company can get all it needs and will not have to pay holdup prices."

It is understood that the Schwartzchild & Sulzberger company will absorb the Zimmerman company at an early day—in fact, there is direct information to the effect that the local company has already been secured by the big independent packers, and that complete charge will be taken in the near future.

"We have not been absorbed yet," says Mr. Zimmerman, "and will hold our identity for awhile, but it is quite likely that we will be taken over after a short time."
