Translated It Means "Happy New Year"—Chinatown Brushes Up to Enjoy Two Weeks' Spread in Honor of Birthday of Every Native of Celestial Kingdom.

Chinatown is celebrating the Chinese New Year and all the inhabitants from the tiny silk-dressed children to the sedan, dignified, mandarin-like fathers are happy. Even the wives and women of the peculiar city within a city have dressed for the occasion and joined in the festivities of the event.

"Gong hay may fait toy," which means "Happy New Year," is the salutation heard by all Caucasians who are fortunate enough to get within the inner gates of the "clubs" and homes of the Chinese. The joss houses are decorated in the Chinese fashion, while appetizing Chinese dishes have been set before the images of Confucius and the ancestors of the mortal who became a god more than 4,000 years ago. Decorations, expensive and intricate in the most intricate style, are everywhere in the wealthiest joss house to the humblest home in Chinatown and some of them are certainly humble.

Second Week Coming.

This week is one of rest in which the celebrants spend the time in their homes, smoking, drinking and eating while waiting for the more strenuous celebration of next week when Second street will ring with the sounds of iron beating on iron, the rattle of the Chinese cymbals, and the shrill squeaking of the oriental fife. Then firecrackers will be exploded, fires built in the street where devils and other spirits of evil tendencies will be consumed for the salvation of the adoring and reverent Chinamen.

To the accidental visitor, the New Year's celebration did not impress him so much as the type of homes and method of living of the Chinese. Under the guidance of Dr. H. G. Parker, deputy city health officer, several newspaper men toured Second street, visiting the stores, clubs, homes and even the queer old Chinese hospital.

Make Health Improvements.

From place to place went the inspection party, and everywhere was noted a willingness on the part of the Chinese to "clean up." After nearly every house, restaurant and store in Chinatown had been visited Dr. Parker said:

"Well, the change is really surprising. It hardly seems possible that the places which rankled with filth and disease several weeks ago could be made so clean and hospitable. Of course, the Chinese are not American and Americans visiting it for the first time would find many objections to live in them, but they are clean, are in accord with all the city ordinances and the Chinese live in amity, which I do not think Americans could do were they placed in such close communion with one another."
