JUDGE ASKS JUDGE TO PRONOUNCE SENTENCE
An echo of the affray in which Patrolman N. H. Suttler shot Herman G. Burkhardt while attempting to place the latter under arrest last November was heard in the circuit court yesterday afternoon.

Burkhardt was convicted in the municipal court on the charge of resisting an officer, but Judge Cameron has postponed sentence January 30. Burkhardt's attorney demanded that sentence be pronounced, as he desires to appeal the case to the circuit court, and cannot do so until sentence is imposed.

Judge Cameron has not yet acted, and the writ of mandate was resorted to by the attorney.

Burkhardt is suing Suttler in the United States circuit court for \$10,000 damages for unlawful shooting, and he is also determined to see the case through in the state courts. He claims that under the circumstances he can secure a reversal of the municipal verdict in the upper court, and he is fighting for a vindication on that point, to show that the shooting was unjustified.

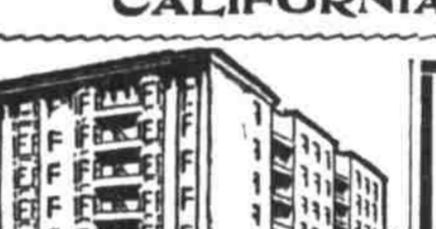
