Cardinals Will Enter Eight in Freshman Regatta Against California.

(Special Dispatch to The Journal.) Stanford University, Cal., Feb. 17.—Stanford will enter an eight in the freshman regatta, against Berkeley in April. The question has been agitated very much of late and Manager Knapp appeared before the executive committee this morning and asked for permission to secure a suitable shell. It was understood that he would rent a shell from the University of California. The matter was read and the regatta committee added that California add the oars and rudder. The representatives of California wish to have the race set forward a week on account of examinations. This would bring it about April 20.
