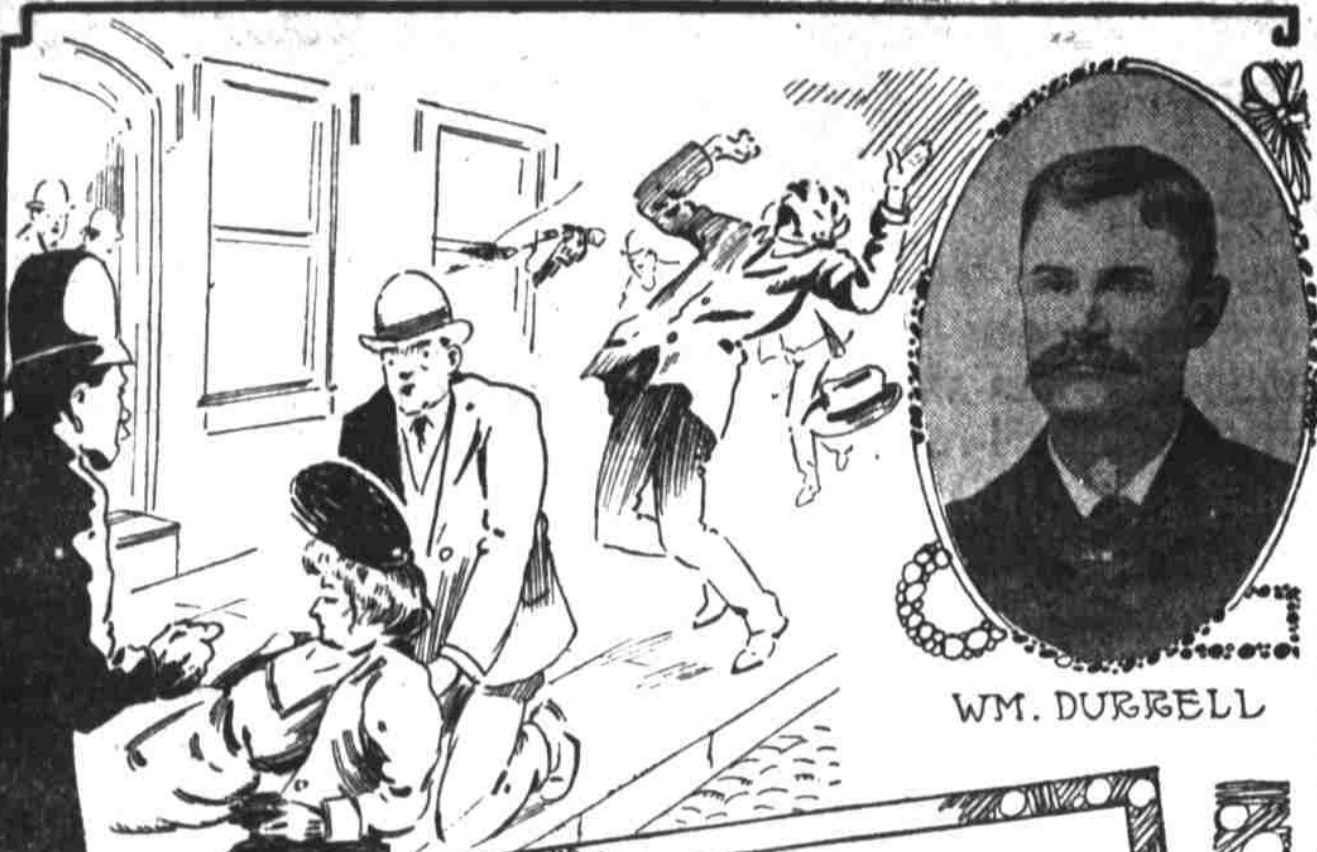


DURRELL DIES FROM SELF-INFLICTED WOUNDS—MRS. KLUM WILL LIVE

In his efforts to kill Mrs. Marie Klum in the presence of her husband, the woman with whom he was infatuated and who had spurned him, and then destroying his own life, William Durrell of Oregon City was partially successful. Mrs. Klum will live. Durrell is dead.

Soon after the tragedy yesterday afternoon in Eleventh street, near Stark, just in front of the New Nortonia hotel, Mrs. Klum was taken to the Good Samaritan hospital with two bullet wounds in her body. One of these struck the woman's spine, but owing to her strong constitution it is the opinion of the surgeons that she will recover.

Omar Klum, a butcher, the woman's husband, owes his life to the fact that Durrell exhausted the chambers of his revolver in firing at Mrs. Klum and then directing the bullets at himself in his efforts to rid himself of the burden of love and in which determination the enraged man was entirely successful.

Struggle for Pistol.

After the first shot had been fired into the woman's back, Klum made an effort to take the gun away from Durrell. His endeavors were without result, however, and so determined upon revenge was the man that he evidently did not think of killing the husband until he was satisfied that Mrs. Klum had been fatally wounded and that the bullet fired into his own body would bring the results he had anticipated.

As the men fought neither of them spoke. Durrell snapped the cartridge-less revolver at the husband of the woman he loved repeatedly. Mrs. Klum was lying on the sidewalk and screaming for help. Durrell ran several yards away to where Klum had wandered in the excitement, snapping the revolver all the while. Seeing that this was useless and realizing that all the cartridges were gone, Durrell returned to the form of the woman and, with a tragic struggle, fell upon her, gasping for breath. Soon afterward persons attracted by the shooting began to gather and the wounded woman and dying man were carried into the Nortonia.

In Love for Years.

Durrell, it seems, had been in love with Mrs. Klum for several years. The Klums have been living at 95 Eleventh street. Willie Durrell, who was a horse trader, made his headquarters at Oregon City; he was in Portland every few days and frequently engaged a room in the same house at 95 Eleventh street, so that he might be near the woman of his choice.

In his farewell statements and according to a note found in Durrell's pockets, he blamed the woman for everything. He referred to her as "the woman who had ruined his home."

LIQUOR FIGHT AT LA GRANDE

Prohibition Will Be Question to Be Decided at the Next Election.

(Special Dispatch to The Journal.) La Grande, Or., Feb. 27.—A candidate in Union county is slimmering. That it is not boiling is perhaps due to the fact that candidates for city offices are watching it very carefully. The city election takes place March 9.

Politics, except from the standpoint of the Socialists, who are quite strong in La Grande, plays very little part in the city election. The fight, if there is one, will be due to differences of opinion among the electors on the liquor question. For some months there has prevailed the general opinion that Union county will go dry in June. Even the saloonmen here in La Grande have voiced the sentiment and it is reported that some have made arrangements to enter other lines of business. But that there will be a fight is becoming more evident every day.

Dr. A. L. Richardson, the present incumbent of the mayor's chair, is a candidate for reelection, and is an advocate of law and order, with a record for more effective regulation of the saloons than any other in the county. B. P. Lewis, Socialist, has been put on the ticket for the same office. It is almost certain that the fight will be between the mayor and the Socialist. Dr. Richardson and those of Dr. M. K. Hall, who was the last to enter the race and is regarded as the candidate of the liquor interests.

CITY MUST PAY FOR DEATH OF EMPLOYE

(Special Dispatch to The Journal.) Walla Walla, Wash., Feb. 27.—A big verdict for damages for the death of her husband was awarded Mrs. Hattie Hilgar against the city yesterday evening, the jury fixing the amount at \$9,533. Mrs. Hilgar sued for \$20,000.

Hilgar was employed on the new pipe line which was recently completed up Mill creek. While working in the ditch a cave in occurred and Hilgar was crushed to death beneath a pile of mud and stones. The city will probably appeal the case to the supreme court.

FULTON WANTS BILL REPORTED

Threatens Committee With Dire Vengeance Unless Action Is Taken.

(Washington Bureau of The Journal.) Washington, Feb. 27.—Senator Fulton today made a vigorous demand on the senate committee on interstate commerce to report speedily on his bill amending the rate law referring to the proposed increased rates.

"I introduced the bill December 4 of last year," he said, "and have besieged the committee to take action, but there has been no action. It is time a report was made."

Senator Clapp interposed the objection that Chairman Elkins was not present, hence Fulton should not call for the committee's attitude on the question.

"I know he is not present," said Fulton, "but if I wait until he is present I may wait until adjournment. If action is not taken in the immediate future I shall adopt other tactics."

This sent an electric thrill through the senate, because every one knew he meant that if no action was taken he would move to discharge the powerful committee from consideration of the bill.

VOTERS DEMAND STATEMENT ONE

Eastern Oregon Candidates Will Abide by Choice of the People.

(Special Dispatch to The Journal.) Salem, Or., Feb. 27.—Colon E. Eberhardt of Joseph has filed his petition for joint representation on the Republican ticket, and will be the nominee of the party as a Statement No. 1 candidate if at all. The people of eastern Oregon are feeling very strongly on that subject, he writes his friends at Salem, where he was educated for the bar, and it is doubtful in his mind if a single member from east of the mountains will come to the legislature who is not a people's choice man.

FIVE-STORY BRICK BUILDING AT EUGENE

(Special Dispatch to The Journal.) Eugene, Or., Feb. 27.—Eugene is promised a five story brick office building this year. The local lodge of Odd Fellows last night voted to build such a structure on the lot which they own at the corner of East Ninth and Oak streets. The lodge now owns a handsome three story brick building on Williams street, but the hall is too small, and a new and larger hall has been a necessity for two or three years.
