WHITE SOX START ON LONGEST TRIP

Two Teams Left Chicago Today in Special Train for California.

- Yests About White Sox Training Trip. Destination—Los Angeles. Mileage, first team—7,223 miles. Second team—7,408 miles. Total number of exhibition games—Sixty-seven. Number of players taken on the trip—Thirty. Estimated expense of trip—Fifteen thousand dollars. Return to Chicago—April 13.

(United Press Leased Wire.) Chicago, Ill., Feb. 29.—What is believed to be the greatest training trip ever taken by a baseball club began today with the departure of the Chicago team of the American league for Los Angeles.

The club, accompanied by many press representatives and a delegation of enthusiastic fans, makes the trip in a special train that is one of the finest ever pulled out of Chicago. The train is due in Kansas City tomorrow morning and will reach El Paso at 10 p. m. Monday. From El Paso the train will proceed direct to Los Angeles, which city will be reached Tuesday evening. Both sections of the team will play games in Los Angeles and San Francisco, and one of the other of the teams will be seen in Oakland, Vallejo, Santa Barbara, Salinas and Bakerfield.

Practically every state in the southwest and the majority of the southern and middle western states will be invaded by one or the other of the squads during the month that will be spent in jumping from city to city on the special train.

Closer home stops will be made to allow exhibition games at Evansville, Terre Haute, Indianapolis, Cincinnati, South Bend, Champaign, Fort Wayne, Galesburg, Peoria, Bloomington, Decatur and Springfield.

W. S. C. COACH WANTS A CONFERENCE MEET

New Wisconsin Man Declares Heartily in Favor of Cleanliness.

(Special Dispatch to The Journal.) Spokane, Feb. 29.—K. H. Kiesel, half-mile runner and formerly coach at the University of Wisconsin, has come to Spokane from Des Moines, Iowa, to see the Pullman, where he will take charge of the Washington state college track team, which has in its ranks several promising sprinters.

Kiesel is heartily in sympathy with the movement for cleaner sports in the northwest and will give every assistance to those at the head of the campaign. The first thing will be to ascertain that every member of the college squad is a bona fide amateur. He said:

"What I want to see is a big conference track meet in the northwest, either in Spokane or a city on Puget sound or the coast and I will do all I can to assist in bringing it about. It would be of great benefit to athletics in general and bring the various teams and clubs into closer association. Since my arrival in Spokane I have discussed the matter briefly with some of the leading advocates of pure amateur sports and they have promised to cooperate with us in every possible manner."

POMONA HIGH JUMPER EXCEEDS COAST MARK

(United Press Leased Wire.) Claremont, Cal., Feb. 29.—Elliott Munger, Pomona's varsity high jumper, exceeded the coast record last evening in practice by clearing the bar at six feet, three inches.

Munger has been in the high jumping game for Pomona the four years of his college course and previous to that won the interscholastic championship while at Santa Paul high school. This is Munger's last year in college athletics and the tall high jumper is out for a new record.

KELLY HAS CHANCE TO SHOW SPEED TONIGHT

Forrest Smithson, who broke the world's record in the 60-yard hurdle race last night, and Dan Kelly, champion sprinter, will be the Oregon entries in the Spanish war veterans games in New York tonight.

An invitation 75-yard race has been arranged for Kelly in which all the runners will start from the scratch. Lawson Robertson, Charles Setz and Nat Cartmell, the intercollegiate champion, will compete against the Oregon man. The race was arranged to show that Kelly is really the man he is reputed to be.

ATTELL WINS IN SEVENTH ROUND

Hebrew Champion Makes Short Work of Little Eddie Kelly.

(United Press Leased Wire.) San Francisco, Feb. 29.—The defeat of Eddie Kelly by Abe Attell last night was not unexpected, despite the desperate efforts of the press agents to make it appear that the easterner is a most dangerous man and had a good chance of taking the championship back to Buffalo. As a matter of fact, Kelly has little more than a good set of muscles and a pug nose to recommend him as a fighter.

Before the fight there were rumors of a "frame-up" and the promoter wanted the bets called off, but this the referee refused to do, contenting himself by giving the fighters a warning. Attell fought bravely in defending his title. It was evident from the start that he was the master of the younger before him and the outcome was never in doubt.

When they came up for the seventh round it was evident that Attell was ready to win, as he dropped his boxing tactics and started to fight in earnest. He opened with a couple of hard rights to the head and followed with light and left to head. Kelly went down from a hard right to the jaw. He staggered to his feet only to get another right and left to the jaw, which sent him down again. He was up and at Attell again only to be knocked down for the third time.

The full 10 seconds had just been tolled off when the police jumped into the ring and ordered the fight stopped. During the first two rounds Attell blocked and sidestepped the newboy, seeming content to test the merits of his adversary. It was early evident that he was the master of the new force necessary for a knockout blow and he correspondingly eased up on his defense. Kelly was quick to take advantage of this fact and landed several stinging blows on the Hebrew in the third and fourth rounds.

Attell grew somewhat angry in the sixth round when a punch on the nose brought first blood for Kelly. Attell went for Kelly's head and stomach and resorted to end the fray in the seventh. Four times the Buffalo lad measured his length on the floor from the force of Abe's wallop.

It was the hardest hitting of any battle he has been in recently and demonstrated to the critics that he still retains the punch that gave him the featherweight title. Kelly showed his gameness all the way through.

The Fight by Rounds. Round One—They shook hands and missed with left leads. Kelly shot his left to the ribs and was rewarded with two lefts and a right to the face. A clinch followed and Attell swung a wicked right to the jaw and Kelly shot to close quarters, mixing it. Kelly landed right and left to the head and face. It was an even round.

Round Two—Abe hooked his left to the face and then lightning shot his right and left to the face before the Buffalo boy could get any wind. He astonished the crowd by his cleverness. The bell rang with Attell enjoying a slight advantage.

Round Three—Kelly swung two lefts to the face and Attell shot a short-armed right to the jaw at close range. The men fought shoulder to shoulder in the center of the ring. Kelly having all the better of a vicious mix. They kept up at the fast clip. Kelly landing right and left to the jaw and body. Attell swung his left twice to the face and the gong rang. It was Kelly's round that he was vigorously cheered as he took his seat.

Round Four—Kelly sent his left to the face and some in-fighting followed. Kelly hit Attell's head with several arm jolts as the round ended. Kelly had the advantage of a round of fast mixing.

Round Five—It was an even round, both displaying great cleverness and light-hitting power. Attell hooked two wicked rights to the jaw and followed it with a scorching left to the same place. Hiding Kelly back with one hand Attell turned loose with his right to the face and body. Both were mixing it furiously at the close of the round and a clinch was the result.

Round Seven—Attell swung his right straight to the jaw and then brought his left to the body. He shot his right straight to the jaw and then swung with terrific force to the head. Attell went in sending his right and left to the jaw with unerring precision. Kelly was groggy, but fought back like a wild man with a hard right to the jaw. He was up, but Attell sent him to the floor twice with a right and when Attell floored him again, Police Captain Duke stepped into the ring and stopped the contest. Attell was given the decision by Referee Jack Welch.

MUSCATINE PLAYERS WIN FROM OREGON "U" WINS FROM SEATTLE

Crack Iowa Basketball Team Captures Exciting Game Has Week's Tour of Oregon Towns.

(Special Dispatch to The Journal.) University of Oregon, Eugene, Feb. 29.—The Y. M. C. A. team from Muscatine, Iowa, defeated the Oregon team in the second half of an exciting game of basketball last evening by the score of 30 to 20. During the first half the Muscatine men had difficulty in finding the baskets and were bothered by the canvas floor, while the Oregon team played splendid ball. The half ended in favor of Oregon, with a score of 13 to 10.

From the start of the second half, however, it was easily Muscatine's game. During the whole game Muscatine maintained splendid team work, while that of Oregon was often ragged and open. There were several close decisions which called forth protests from the spectators, but on the whole it was a clean game. There were no particular stars on the Muscatine team. Hathaway and Strong started for Oregon.

Besides being the last varsity game for Oregon this year, it was also the last time that Hathaway, Stevenson and Moors will represent the university, as they graduate next June. Van Scoy and Ramp will also be lost to the squad, as they are seniors.

With this game the Muscatine team has won 50 out of 59 games since they started on their trip December 3. They will play O. A. C. tomorrow night and have two games with Dallas next week. They will play about 25 more games before returning home.

F. C. SMITHSON BREAKS WORLD'S RECORD

(United Press Leased Wire.) Trenton, N. J., Feb. 29.—Forrest C. Smithson, the Portland, Oregon, boy who won the national championship in the hurdles at Jamestown last spring, last night broke the world's record in the 60-yard high sticks, doing the distance over five hurdles in 7 4-5 seconds. Each hurdle was 3 1/2 feet high and placed 10 yards apart. The previous indoor record was held by S. E. Northbridge, who covered the timber in 8 1-5 seconds in New York, February 3, 1907. Smithson's record is considered phenomenal and some remarkable time is expected of him before the season ends.
