

NO PARADE OF CHILDREN

School Principals of Portland Go on Record as Opposing Stellar Event Planned for Rose Festival in June.

Consulting what they believe to be the best interests of the schools and the school children the principals of the 28 Portland schools met with Superintendent Rigler yesterday morning and by a vote of 25 to 3 declared themselves opposed to the parade of the school children during Rose Festival week.

It was declared by those who were present at the meeting that while the principals are willing to give their own time for the training of the children, they cannot do so without slighting the school work which is most important toward the close of the year.

Opposing Position.

Principal C. L. Stone of the Sellwood school, speaking of the action taken by the principals, said last night: "We have found that all this parading and extra work detracts from the standard of serious work which has been set for us to follow. The children are compelled to work hard enough as it is without having several extra hours a week of unnecessary work to do. The parents as a rule are opposed to their children marching. It would mean that we would have to go out personally and urge the children to march. It is a responsibility that I for one do not approve of and don't consider a part of my duties as a teacher in the public schools. My ideal is to secure a high efficiency from my pupils as possible. I don't believe that parading the streets in the hot sun is going to work towards that efficiency."

The other principals agreed with Professor Stone that the parade would be an undesirable thing for the schools.

Resolves March Work.

"The Festival people are too apt to think only what a pretty spectacle the children will make during their hour's march. They don't take into consideration the training and the drill and the hard work connected with the preparation of those who are going to take part in the parade. It is like a man going to the theatre who sees the performance and thinks of the actor working three hours. He doesn't take into consideration that it has taken months, and even years, of constant work to perfect the performance which it takes but a few hours to see."

Although the principals went on record as against the parade the special committee of which Judge Cleland, the chairman will report back to the school board and await its action on the matter.

TRY WYNN FOR DU PUIS MURDER

Pendleton People to Be Summoned to Testify Against Defendant.

The coming week will be a busy one in the circuit court. Jury trials for the March term will open tomorrow and several important cases are set for the week. One of these is the murder case of John Wynn, who must face a jury for the killing of W. H. Du PUIS in a north end saloon. Deputy District Attorney Haney has prepared an affidavit to secure the presence of three out-of-town witnesses who are needed by the state. Two of these were eye-witnesses of the shooting—Elywn Switzer of Pendleton and A. McLaren of La Grande—and the other is Lester Hicks of Pendleton, who will testify to threats made by Wynn before the murder.

A decision by Presiding Judge Cleland on the demurrers of J. Thorburn Ross and other accused officials of the Title Guarantee & Trust company is expected early in the week. Demurrers in three cases were argued before Judge Cleland, the three other judges, with Judge Gantenbein presiding, hearing the argument on the demurrer in the fourth case yesterday.

WILL ASK FOR NEW TRIAL TOMORROW

Attorneys for Radding and Waymire Claim They Have New Evidence.

Alleging that they have discovered new evidence in the form of statements said to have been made by Mayor Lane regarding the charges on which E. E. Radding and Mrs. Belle Waymire were convicted last week, the attorneys for the defendants tomorrow will file a motion for a new trial.

The defendants' attorneys also claim that an error was made in receiving the verdict of the jury when neither Mrs. Waymire nor Radding nor any of their attorneys were present. They evidently believe they have a good point in this objection, which will be strongly urged as a reason why a new trial should be granted.

Hide Statements.

Just what statements the mayor is alleged to have made that are regarded as giving defendants in court are not disclosed. It is said, however, that these statements are sufficient to carry weight, and they will be set forth in affidavits to accompany the motion for a new trial. Attorney Seneca Routs last night said that the information regarding what the mayor has said reached them too late to use in the recent trial.

Mr. Fouts yesterday secured from Judge Gantenbein a typewritten statement setting forth in detail the facts connected with the returning of the verdict. This statement says that after the jury retired on the afternoon of February 25 the court notified Fouts to bring the defendants in court when the jury came in with its verdict. At 6 o'clock, the statement proceeds, the verdict was received and read in the presence of the court stenographer and other officers of the court, but in the absence of both of the defendants and of their attorneys. Judge Gantenbein directs that this statement be made a part of the record.

Put in Record.

The object in securing this statement from the judge was to have the facts made of record, to be made the basis of the motion for another trial. The defendants were convicted of a misdemeanor and it is admitted that in case of a misdemeanor the trial may proceed without the presence of the defendants. But the court pointed out that in the case of the state against Spores in the fourth Oregon, the supreme court held that the absence of the defendant "if he appear by counsel."

Conversely, it is claimed, if the lawyers for the defendant are not present the verdict cannot be received, because the courts have held that the reception of a verdict is a part of the trial and that the defendant has an unimpeachable right to demand a poll of the jury. If the attorneys for the defendant are absent, it is contended, this right is taken away, they having no opportunity to poll the jury.

Argument of the motion for new trial may or may not be held during the coming week, owing to the preparation to be made by the attorneys before the time at the disposal of the court. Meaning Radding remains in jail, unable to furnish the \$1,000 bond that he proffered, he could not easily supply.

BAKER CITY BOOSTERS MAY FETCH DISTRICT

Mayor Johns Receives Reinforcements at Washington—Prospect for Bill Seems Better.

(Washington Bureau of the Journal.) Washington, Feb. 29.—Mayor C. A. Johns of Baker City was joined today by Attorney Charles Murphy of that town in his effort to push through the bill creating a new federal judicial district of eastern Oregon, the court to sit at Baker City.

Representative Ellis says Pendleton is still urging that the court should sit there, on the ground that more federal business originates in that part of the state, but there is no delegation here from Pendleton. There seemed little likelihood that any bill would pass up to the time of Johns and Murphy's arrival, but it is now thought that, being on the ground, they may succeed in pushing the bill through.

BELL INDORSED BY MANY REPUBLICANS

Candidate for Justice of the Peace Has Backing of Bench and Bar.

J. W. Bell, who has announced himself as a candidate for the Republican nomination for justice of the peace under the consolidated district, is one of the well-known attorneys of the city. He has been engaged in the practice

of his profession in Portland for a number of years and is well known and respected for integrity and ability.
Mr. Bell in his candidacy for office holds the unique position of having the unanimous indorsement of the bench and bar of the city. His petition for nomination, besides being signed by every member of the bar, more than 325 lawyers of the city, is signed by Judges John B. Cleland, A. L. Frazer, C. U. Gantenbein and Thomas O'Day of the circuit bench, Judge L. E. Webster of the county court, Judge George J. Cameron of the municipal court and Justice of the Peace William Reid, himself a candidate for reelection and an opponent of Mr. Bell for nomination. Usually by the members of his profession and stands high in the community as a citizen.

FAKE RAID ON GAMBLERS

Detectives Make Spectacular Invasion of Chinese Quarters When Games and Lotteries Are Shut Down for Reception of Officers.

Pursuant to "arrangements" announced by the police Thursday afternoon, Acting Detectives Kay and Smith raided the Chinese gambling den at 32 1/2 Second street yesterday afternoon. Of course, no one was arrested, for the very good reason that no game was in progress at the time the raid was made, nor had there been any gambling there since 9 o'clock the night before. It is charitable to suppose that the officers were not aware of this, although the fact was patent to everyone with whom the mayor's Chinese quarters are at all familiar.

Wide Open.

Following the publication in The Journal Thursday afternoon of the fact that the hit had been lifted in Chinatown and that lottery and gambling games were being conducted openly—one of them within a few score feet of the police station, orders were issued by someone for a cessation of operations by all of the boss gamblers who are credited with being subscribers to the protection fund. As a consequence the lights were turned out in all of the lottery and fanfan resorts at 9 o'clock Thursday evening. The games did not reopen yesterday morning and at the time Kay and Smith, attracted a crowd of idlers by their spectacular descent on the premises in Second street yesterday afternoon a majority of the boss gamblers of the quarter were in the midst of the court case which is being held in the back office of the store of Bing Gee, 64 Second street.

While the result of the "raid" amounted to nothing more than a demonstration of the completeness of the "arrangements," the same cannot be said of the consultation of boss gamblers. "Ways and means" was the topic of discussion, and it is probable the session was none the less interesting because it was held behind closed doors. The result of the conference is not known definitely and it is by no means certain that a definite line of action was determined and agreed upon. All of the gambling resorts remained dark last night though the word was passed around that some of the lottery games would resume drawings today.

Some time ago the Chinese gamblers announced that they were willing to pay the sum of \$1,800 a month for immunity from prosecution. The negotiations fell through an account of the publicity given the scheme, but in spite of their willingness to pay for the privilege of being permitted to violate the gambling laws has never been called into question. That they are paying a certain stipulated sum for such protection can be given them under existing conditions is an open secret in Chinatown.

The celebration will be under the auspices of the Ancient Order of Hibernians. The committee in charge of the entertainment includes D. J. McLoughlin, Pierce Hailey, James Foley, J. W. McGinn, M. Doyle, E. H. Deery and J. W. Lane. There will be no admission charge.

The address of the evening will be delivered by E. S. J. McAllister. Other features of the program will be as follows: Opening remarks, John O'Hara; song, "The Harp," Daughters of Erin chorus; recitation, "O'Connell's Grave," Master Aloysius; hymn, "A Handful of Earth," Mrs. W. 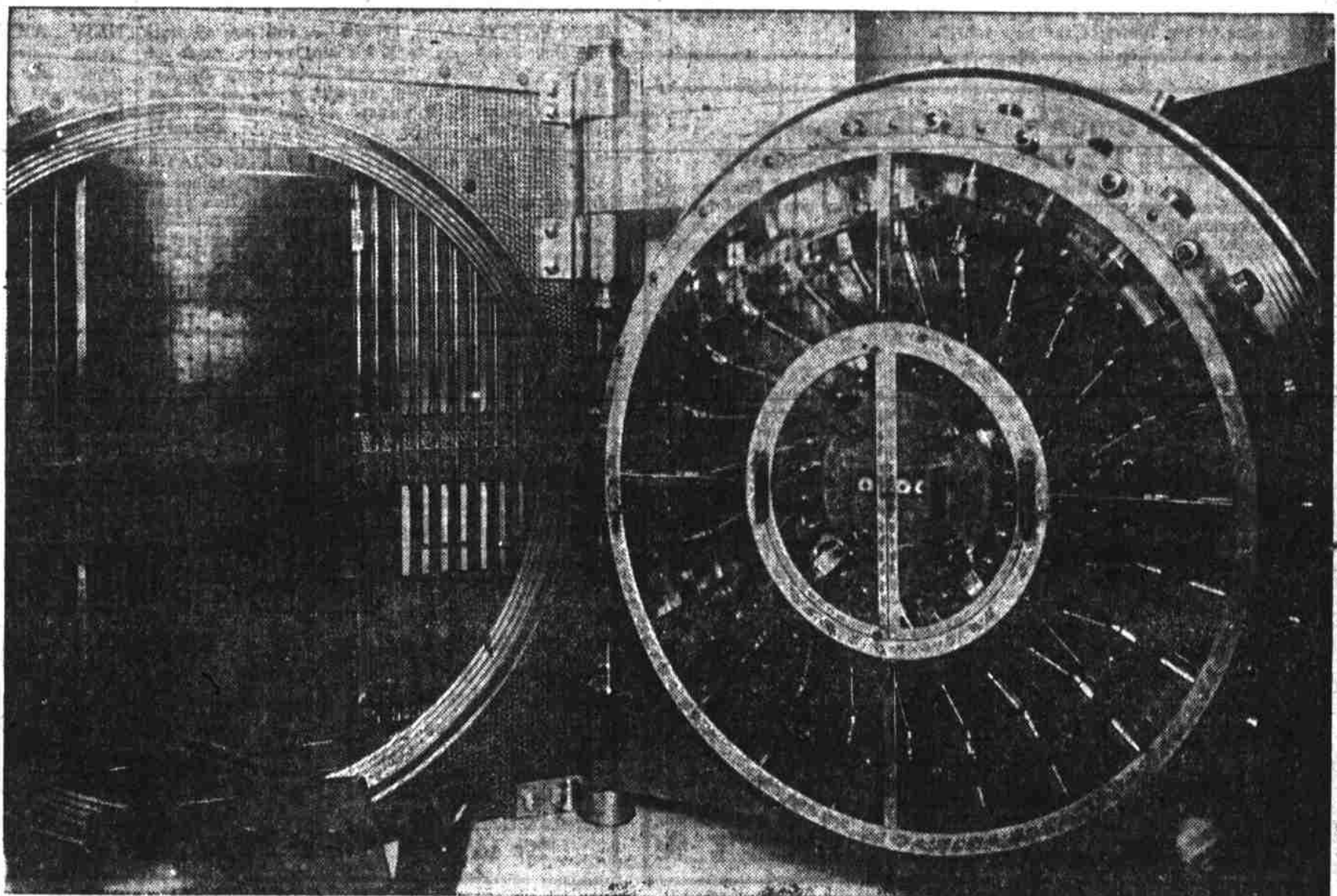
