

# ALASKA SELDS SOLD LEGATION FOR BRYAN

### Leader's Platform Broad of Scope on All Matters of Vital National Importance. Enthusiastic Support for Commoner. List of Delegates for Convention

Omaha, Neb., March 6.—William J. Bryan will have the unanimous support of the Nebraska delegation at Denver next June at the meeting of the national Democratic convention. The Nebraska delegation adopted Bryan's own platform with wild enthusiasm. National delegates, supporters of Bryan, were chosen. The Bryan platform is broad in scope and covers many vital national issues. The platform follows:

**On the Tariff.** We favor an immediate revision of the tariff by the reduction of import duties. Articles entering into competition with articles controlled by trusts should be placed upon the free list; material reduction should be made in the tariff upon the necessities of life; and reductions should be made in such other schedules as may be necessary to restore the tariff to revenue basis. We favor an income tax as part of our revenue system, and we urge the submission of a constitutional amendment specifically authorizing congress to levy and collect a tax upon individual and corporate incomes, to the end that wealth may bear its proportionate share of the burden of the federal government. We favor a national inheritance tax to reach the "swollen fortunes" already in existence, but we believe that it is better permanently to prevent "swollen fortunes" by abolishing the privileges and favoritism upon which they are based.

**On Reclamation.** We sympathize with the efforts put forth for the reclamation of the arid lands of the west, and urge the largest possible use of irrigation in the development of the country. We also favor the reclamation of swamp lands upon the same principle. We favor the preservation of the forests still remaining and the replanting of the denuded districts in all our mountain ranges, as well as the forestation of the western plains.

**On the Panama Canal.** We believe the Panama canal will prove of great value to our country and to the world. We urge liberal appropriations for the improvement and development of the interior waterways, believing that such expenditure will return a dividend in lessened cost of transportation.

**On a Pension Policy.** We favor a generous pension policy, based upon the principle of justice to the surviving veterans and their dependents, because it relieves the country of the necessity of maintaining a large standing army.

**The Philippines.** We condemn the experiments in imperialism as an inexcusable blunder which has involved us in an enormous expense, brought us no increase in strength, and laid our nation open to the charge of abandoning the fundamental doctrine of self-government. We favor an immediate declaration of our nation's purpose to recognize the independence of the Philippine islands as soon as a stable government can be established, such independence to be guaranteed by us as we guarantee the independence of Cuba until neutralization of the islands can be secured by treaty with other powers. In recognizing the independence of the Philippine islands our government should retain such land as may be necessary for coaling stations and naval bases.

**Desiring to prevent war wherever possible, we believe that our nation should announce its determination not to use our navy for the collection of private debts, and its willingness to enter into agreements with other nations providing for the investigation by an impartial international tribunal, before any declaration of war or commencement of hostilities, of every dispute which defies diplomatic settlement.**

**Railroads.** We assert the right of congress to exercise complete control over interstate commerce, and we assert the right of each state to exercise just as complete control over commerce within its own limits. We demand such an enlargement of powers of national and state railway commissions as may be necessary to give full protection to persons and places from discrimination and extortion. We believe that both the nation and the various states should:

First—Ascertain the present value of the railroads measured by the cost of reproduction.

Second—Prohibit the issue of any more watered stock or fictitious capitalization.

Third—Prevent the railroads from engaging in any business which brings them into competition with their shippers, and

Fourth—Reduce the transportation rates until they reach a point where they will yield only a reasonable return on the present value of the roads—such a return sufficient to keep the stock of the roads at par when such roads are honestly capitalized.

**To Prevent Panics.** The injury done by issues of watered stock is more clearly seen and better understood since the shrinkage in value of a widespread panic has precipitated an enormous loss to the country. The panic has also emphasized the necessity for legislation now being drafted by producers from speculation at the hands of the stock gamblers and the gamblers in the present financial stringency.

The present financial stringency furnishes additional proof that the Republican leaders are either unwilling or incompetent to protect the interests of the general public. They have no interest in Wall street that the sins of the speculators are visited upon the entire country. We favor the postal savings bank, and in addition thereto insist upon the passing of laws, state and national, for the better regulation of banks and for the protection of bank deposits. The government demands security when it deposits public money in a bank and that security is the security of the individual depositor who intrusts his earnings to a bank which is as perfect as the government's security.

We oppose both the Aldrich bill and the Fowler bill, and believe that, insofar as the needs of commerce require, an emergency controlled by the federal government, and that it should be loaned upon adequate security and at a rate of interest which will compel its retirement when the emergency has passed.

We demand, further, that favoritism in the deposit of treasury funds shall be abolished and that surplus revenues shall be deposited at competitive rates in any bank which fairly distributed throughout the country.

**Regarding Labor.** We favor the eight-hour day. We believe in the conciliation of capital and labor, and favor every legitimate means for the adjustment of disputes between corporate employers, to the end that justice may be done to those who toil and that society be relieved from the embarrassment occasioned by prolonged strikes and lock-outs. We favor such a modification of the law relating to injunctions as will, first, prevent the issuing of writs in industrial disputes except after notice to defendants and full hearing; second, permit trial before a judge other than the one who issued the writ; and, third, allow a jury to be summoned in all cases where the alleged contempt is committed outside the presence of the court. We favor an employers' liability law applicable to both private and public employees.

**Asiatics and Assassins.** We favor full protection, by both national and state governments, within their respective spheres, of all foreigners residing in the United States under treaty, but we are opposed to the admission of Asiatic immigrants, who

## MAROONED JAPS ARE RESCUED

**American Cutter Saves 11 Survivors of the Satsuma Maru.**

(United Press Leased Wire.) Sitka, Alaska, March 6.—The 11 surviving members of the wrecked Japanese steamer Satsuma Maru were rescued by the United States revenue cutter Thetis from a point seven miles north of Cape Manby, Yakutat bay, on March 5. The Thetis is proceeding with the men and their effects to Seattle. Captain A. J. Henderson of the Thetis, on his arrival here, said:

"The rescue work was facilitated and made possible by a strong northerly gale on the first and second, which smoothed the prevailing heavy ocean swell. The men were taken from a very bad beach with an outer bar on which were only five feet of water 200 yards from shore, along which a strong current set and a heavy surf rolled six to eight feet high.

"The marooned men are all in good health, except First Officer Traud, who has a gangrenous gunshot wound in the left hand.

Larson's rescue was opportune, as the men, wearied by the long stay on the beach, were becoming desperate and were making preparations to embark for Yakutat village, 16 miles across the bay, in a small Indian dugout canoe, which had drifted ashore near their encampment."

It is therefore expected that there will be competition in buying, a condition that has not existed to any great extent in this section for several years.
