DEDICATION OF HISTORIC PULPIT ROCK TOMORROW

Pulpit Rock, Showing Also Luxillo, an Aged Indian Who Was in That Congregation 70 Years Ago.

(Special Dispatch to The Journal.) The Dalles, Or., March 21.—The joint committees of the Good Intent society of the Methodist church and the Historical Society of Old Port Dalles will hold services tomorrow in commemoration of the first sermon preached in this city, seventy years ago, from Pulpit Rock, one of the oldest pulpits in the world. The first preachers were Rev. Jason Lee and Rev. Perkins. In 1838, on March 22, which also fell on a Sunday.

Those intrepid and earnest missionaries spoke to the Indians, and called their audience together by means of a large horn. The Indians flocked to Celilo, Wishram and all the villages around. The services tomorrow will be held out of doors at the base of the ancient pulpit of conglomerate rock. The program will consist of the following: Singing—"Praise God From Whom All Blessings Flow," choir and audience; repeating 23d Psalm, audience; prayer; "All Hail the Power of Jesus' Name," choir and audience; historical address; Professor F. H. Grubbs; "Rock of Ages," double male quartet; historical letters, read by George H. Himes, Soloist.

Jesus Lover of My Soul," W. E. Rose; address, Rev. Daniel L. Rader; unveiling of tablet, Miss E. Walf Grubbs; singing, "America," choir and audience; benediction. The ceremonies will be held at 3 o'clock in the afternoon. A bronze tablet, with the names of the first missionaries and the date of the first sermon inscribed, will be placed on the rock and this will be unveiled by Miss Walf E. Grubbs, a granddaughter of Jason Lee. An iron fence will soon surround the old pulpit for its better protection.

Heard That First Sermon. Not long ago old Luxillo, an Indian from Warm Springs agency called on Mrs. W. Lord of this city and stated that he could remember when Lee and Perkins called his people to hear them preach. He said they called them by the blowing of a horn and that the red men came from Wishram, Celilo and all around to hear those good preachers preach the word. Old Luxillo is very aged, but retains an accurate memory of historical events and can state them with precision. He is, therefore, of great value to history-hunters, for he is not adverse to telling what he knows, which is unusual for an Indian to do.

WHAT IT COSTS TO ENLIGHTEN VOTERS. More Than \$10,000 Is the Total Bill—Citizens Pay \$2,797.34 of This.

(Special Dispatch to The Journal.) Salem, Or., March 21.—The sending out of the pamphlets containing the measures to be voted upon at the general election in June, together with the arguments for and against them, has already cost the secretary of state, already over \$8,000, have been sent out to voters whose names have been submitted to the secretary of state. The total cost of the pamphlets is all at a cost of \$6,378.75. Of this amount the persons submitting the measures and arguments have to pay \$2,797.34 as their proportion, as fixed by law. The total amount collected by the secretary of state from the filers of the arguments is \$2,900. An adjustment will be made on a per page basis, and those who have paid more than their share will receive a refund, while the others who have not paid their full percentage will have to remit the difference.

The postage for the sending out of these arguments will cost about \$3,000, and the cost of \$6,378.75 will have to be added to it before the actual expense of getting out the measures can be ascertained, the amount of postage, the cost for clerks engaged in mailing, about \$250, and the cost of securing the names of voters.

Secretary of State Benson, it is estimated, has saved about \$3,000 in the getting up of the pamphlet by his arrangement of the measures.

BIG CRAFT HOUND TO DEFEAT BILL

Charged That Anti-Racing Measure in New York Will Be Lost in Senate.

(United Press Leased Wire.) Albany, N. Y., March 21.—With the fight over the anti-race track bill bearing the last round in the state legislature a significant change became apparent today in the opinions of the legislative experts as to the chances of passage of the famous Agnew bill. The opponents of the measure are now willing to bet even money that the bill will be killed in the senate.

The basis for these rumors is the report that a large amount of money for illegitimate use in the senate has been raised by the race track interests and the bookmakers. Some persons, who claim to be "in the know," place the amount of this alleged corruption fund at \$200,000.
