

CLUB HOUSE FOR HOBOES

Car Company to Construct \$40,000 Building in Sellwood at Once—New Operating Barn Will Also Be Erected From Which Broad-Gauge Cars Will Run.

Two and a half blocks of additional property at Sellwood have been secured by the Portland Railway, Light & Power company, and plans for the new operating barn for the O. W. P. and the club house for the employees to cost \$40,000 are now being prepared. Work on the buildings will begin as soon as the contracts are let.

The new barn is to be located opposite the station and will have a capacity for the storage of 10 of the broad-gauge cars. The buildings will be so constructed that at any time additions can be built without inconveniencing the operations of the other departments.

The new operating barn at Sellwood is to house the cars of the Casady, Oregon City, the Oaks and the Sellwood cars. All cars will start from this point after the improvements have been completed. Many of the company employees are already living at Sellwood and with the completion of the barn and the club house many others will move their families there.

Brick or Concrete.

The new barn was decided upon by B. S. Josselyn, president of the company, and the other officials some time ago owing to the fact that more operating room was necessary for the system which is gradually being engaged in improving and to which new cars were added during the last few months which in the future is to be done at Sellwood in now being accomplished at the Milwaukee and the east side barns, both of which are crowded. The shops at Milwaukee will remain, however, and are to be enlarged and improved from time to time.

The building is to be either of brick or concrete and 140 by 200 feet. Under roof there will be about 2,500 feet of track for the cars when not in use.

BREWERS' REFORMS GOOD FRONT PAGE ADVERTISING

Lurking Suspicion That Story of Saloons' Alleged Efforts to "Wipe Out Joints" Is Clever Scheme to Cover Up Real Motives and Deceive Public.

Portland, March 21.—To the Editor of the Journal.—In last night's Evening Telegram I notice a line across the top of the front page, in very large type, promising "Brewers Will Wipe Out Joints." Then the next thing on the first page is a double column article, with large headlines, telling the wonderful things the brewers are going to do in the interest of the public and against their own customers. Surely the millennium is about to dawn—surely it is true there's the rub—and the sorrows of life are nearing an end.

In passing and before commenting on the article, let me give voice to a lurking suspicion. I noticed some little time ago that the brewers of the country held a convention in Chicago to devise means to stem the rising tide of prohibition and among other expedients recommended and adopted was the raising of a large fund, a very large sum, for the occasion requires a strenuous effort, and fill the papers full of "their side" of the question. Now I hunted hard for a star at the end of the Evening Telegram article to indicate that it was paid matter, and failed to find it. Could it be that they would run such matter if paid for, but news matter and endeavor to deceive their own readers? Perish the thought! When journalism falls to this level it should be spurned by all decent people, so we will hope that it is simply their simplicity.

Brewers' "Reforms."

The brewers' "platform" in the article mentioned starts off with "reforms." Good, we welcome them so far as they are sincere, there is a mighty need.

Then "no undesirable person" is to be given a license. That cuts the business department out, but let that pass, that is a small matter to people who have their ideas of conformity to law and truth.

Saloons operating "disorderly" houses will be disciplined. That has a familiar sound. Let's see, did not Judge Cameron "discipline" Fritz for his disorderly place? I can see the judge's brewers' push lined up to defeat Cameron for district attorney.

Saloonmen to be prohibited, through cooperation of officials, etc. I presume it will be the same cooperation as secured the closing of all the saloons "the department laid charges against them." One of that whole list, so near as I can gather, two of the worst did lose their license and two had to transfer their licenses to their bartenders. By whose "will were the rest saved"? The suspicion has been that each brewer looked out for his own customers, they probably would not do that again.

No gambling. Well, I would sooner trust Tom Ward for that than all the brewers in Portland.

More Holding of Hands:

City will be distracted to prevent granting of licenses in territory already dry. Pray tell me how licenses could be granted in dry territory no matter how completely the brewer may own the council.

They are going to "discipline" all violators of the saloon laws, and if the officials fail to enforce the laws they will fix the responsibility on their "discipline." "Discipline" is a very broad word. In this case it probably means a \$5 fine. And as to fixing responsibility on the people where it belongs now.

"Brewers will work hand in hand with city liquor license committee," etc. Sure if they don't work hand in hand with that committee they are losing their cunning. What the people are trying to do is to stop this holding hands.

Saloonmen who refuse to maintain order will have supplies cut off. But the subcommittee of the judiciary of the city court, and decided that it would be unconstitutional to retard the movement of liquor from one state to another, and they would get supplies all right.
