

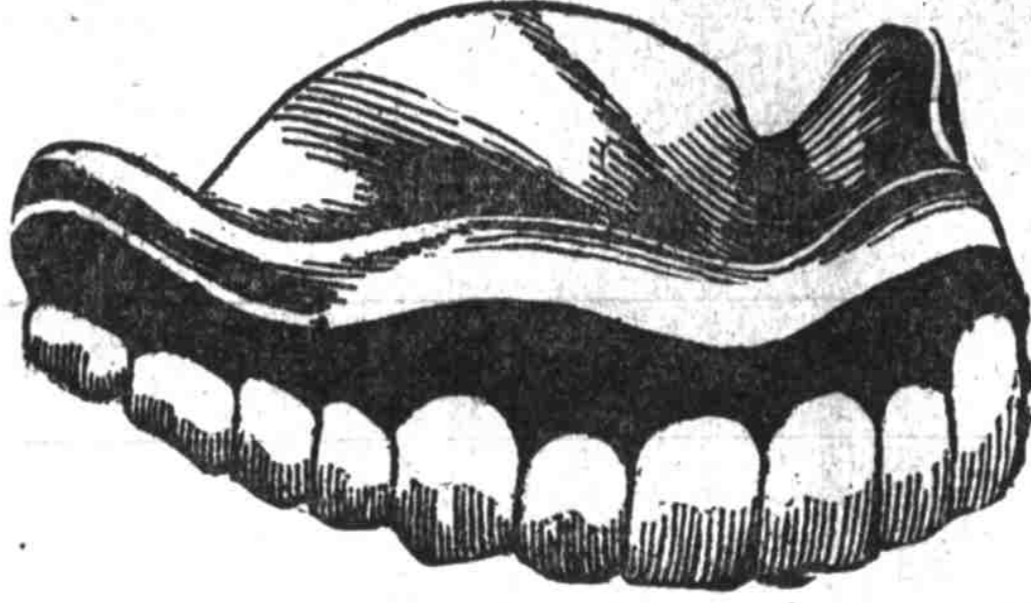

Lumber Manufacturers Are Relieved by Dispatches From Washington Regarding Fulton-Hawley Resolution.

Portland lumber manufacturing interests were advised yesterday afternoon through The Journal that there is no further cause for alarm by reason of the passage of the Fulton-Hawley resolution directing the attorney general to proceed against the Southern Pacific company with a view to forfeiting its Oregon and California land grant. It is said from Washington that an agreement has been reached in committee that, although the Fulton-Hawley resolution is passed in its original form, the committee has gone on record as favoring relief for innocent purchasers of railroad lands.

Another Resolution. "It has been agreed in the committee," said George M. Cornwall, "that another resolution will be immediately drawn, and passed by congress, providing that if any suit is brought against an innocent purchaser to dispossess him of his title to railroad lands bought in good faith, and if judgment is rendered by the courts against him, a stay of one year shall be had, during which time congress shall pass such remedial legislation as will give him a clear title. This is in the opinion of the lumber interests a fair and reasonable solution of the problem and makes all legitimate investors and operators safe."

It should be kept in mind that a speculator has no play role. While some of the big lumbering industries affected by the threatened proceedings of the attorney general have purchased more lands than were stipulated in the terms of the original grant to the railroad company, they bought these lands in good faith and have no right to complain. Small Tracts Valueless. "They certainly could not have engaged in legitimate manufacturing industry had they not bought these lands," a manufacturing concern cannot employ 700 men at \$2 to \$2.50 per day manufacturing lumber from a tract of 10 acres of timber, while the small speculators and squatters have been after the lands for the purpose of trafficking in them at a profit. While some of the industries founded upon former railroad timber lands have been giving employment at good wages to hundreds of people, and have been actively engaged in opening up and developing the country, it is but just that these industries, and developers along with them, should have full protection in any proceeding the government may undertake against the railroad company.

The committee of the house goes on record as favoring such protection, and this will be satisfactory to the lumber interests, as they believe it was the best solution obtainable under the circumstances.

WALNUT FLOAT TO BE BUILT FOR McMINNVILLE

J. C. Cooper, representing the Walnut club of McMinnville, is in Portland arranging for the construction of a large walnut float to represent McMinnville in the Rose Festival parade. It is planned to have a large half-shell of a walnut, filled with a number of McMinnville's pretty girls. Mr. Cooper visited the plant of the Rose Festival association in the transportation building, at the fair grounds this morning in order to secure details for the float. The Portland Rose society held a meeting Friday and discussed plans for the prizes and classification of the rose exhibits for the Oriental building exhibition next summer. In order to prevent prizes all going to a few exhibitors the society adopted a rule that although exhibitors would not be restricted to one rose of each class each exhibitor could not secure more than one prize in each class.

There will be 32 classes for amateurs, with silver cups to be awarded as first and second prizes. For nurserymen, the best display of roses and shrubbery will receive a prize of \$100, second prize \$50 and third \$30. It was decided that two judges of the amateur exhibits should be from out of the state. The third judge is W. S. Gibson of Portland.

The Rose society is interested in the attempt to have 5,000 rose bushes, given the city for park purposes, transplanted and placed in permanent beds, ready for blooming. The first crop of roses is due next month and the society is anxious that it be not retarded. It is claimed that the present superintendent has not had half of the bushes transplanted and set out for blooming.

DR. ALEXANDER REID

The Saturday afternoon excursions of the realty board to the various new residence districts was inaugurated yesterday afternoon when something like 150 members of the board and friends besides four automobiles filled with ladies left the Chamber of Commerce for a trip to Rose City park.

At the annual meeting of the realty board last Tuesday night, H. W. Fries, the newly elected president, suggested that the board visit one of the new residence districts each Saturday afternoon during the spring and summer. Immediately upon the adoption of the suggestion a representative of Rose City park extended an invitation to the board to make its first excursion to that place.

It was in response to this invitation that yesterday afternoon's trip was taken. The owners of Rose City park, Hartman & Thompson, furnished transportation and cigars for the party. The realty board had prepared a folder, giving a complete description of Rose City, which was distributed among the excursionists for their information.

Much astonishment was expressed by a number of the excursionists at the remarkable development which has taken place in the vicinity of Rose City park, where in one year an immense area has been converted into a beautiful and attractive residence center. The official photographer was on hand and took a picture of the large party grouped on the brow of the hill overlooking the natural amphitheater in the country club grounds.

While returning to the city a short business session of the board was held in one of the cars, which was presided over by the board and was voted a splendid success and it was voted to visit Overlook next Saturday afternoon.

NOTABLE LECTURE. TWO ORDINANCES WITHOUT AN O. K. Mayor Permits Laws to Become Effective Without His Signature. Mayor Lane allowed two ordinances to become laws yesterday without signing them. While both are contrary to views held by the mayor he allowed them to go into force. One is the ordinance permitting H. D. Winters three months in which to alter his building at 60 1/2 Grand avenue, where stairs extend out over the sidewalk contrary to city ordinance.

The other ordinance is one ordering the mayor and city auditor to draw warrants on the general fund in favor of the Cascade Power company for \$1,000. This amount was put up by the Cascade company to guarantee good faith in the matter of installing a municipal heating plant. As nothing came of the movement the council voted to restore the bond deposited by the power company.

WYNNE'S PENALTY ONE YEAR IN PRISON. One year in the penitentiary is the penalty that John Wynne will pay for the death of W. H. Du Puis, whom he shot to death in a Fourth street saloon on the night of December 11. Sentence was pronounced by Judge O'Day in the circuit court this morning. This being the lightest punishment possible under the verdict of manslaughter returned by the jury.

Wynne heartily thanked the judge when he was sentenced. He had expected a heavier sentence, the maximum punishment being seven years. Judge O'Day said he had investigated Wynne's record and was convinced that he was not one of the class of men whose confinement for a long term is required for the good of society. The killing of Wynne, while not justified, was not without provocation, the court said, and he characterized Du Puis as a vicious man, who had made an unprovoked attack on the man who killed him.

LAW WRITTEN IN TABLETS OF FLESH. Dr. George J. Fisher, the greatest physical director in the United States, who is at the head of the physical work of the Y. M. C. A., will speak to a men's mass meeting at 8 o'clock on "The Law of God Written in Tablets of Flesh."

Dr. Fisher has been in California holding institutes for the strengthening of the gymnasium work in the local associations. He is coming to the northwest for the same purpose. After leaving Portland he will visit all the associations in Washington and on March 27 will hold a conference of physical directors of the northwest at Seattle.

Besides the address of the afternoon there will be a number of stereopticon pictures showing child labor conditions throughout the United States. Some of these slides were made from pictures taken in coal mines, others in glass factories, cotton mills, and a number of street waifs and newsboys.

A. G. Rushlight

A. G. Rushlight, councilman of the Seventh ward, has followed his intentions to become a candidate for the nomination of county assessor on the Republican ticket. Mr. Rushlight has made a good record for himself in the city council. His platform is as follows: "If I am nominated and elected I will during my term of office exercise the functions thereof for the best interests of the county and the taxpayers thereof. I shall favor a strict business administration irrespective of any person, corporation or other interest, whether political or otherwise; I shall endeavor to make a just and equitable assessment of all property within the county. Words to be printed on ballot: 'Honest and just assessment without fear or favor.'"
