MONDELL RESOLUTION SUIT BLOCKS LUMBER SUIT

Fulton Measure to Open Immense Tracts Now Held by Oregon & California Railway in Western Oregon Handicapped by Joker Attachment.

To the Editor of The Journal—The Fulton resolution authorizing the government to include the claim for forfeiture in its suit soon to be filed against the Oregon & California Railroad company is proper.

Under the acts of congress of April 10, 1879, and April 18, 1879, the Oregon Central Railroad company, east side and the Oregon Central Railroad company, west side, two separate corporations were made out of government land.

The Oregon & California Railroad company is under obligations to sell the 2,000,000 acres of land at the maximum price of \$2.50 per acre.

But any application to buy presented to the railroad company by a person not a bona fide settler will, of course, be ignored by the railroad company, and it should be ignored by the court.
