LEWISTON FRUIT ON EXHIBIT HERE

Clearwater Growers Request Space in Chamber of Commerce Rooms.

Request has been made by H. L. Powers for the Associated Fruit Growers of the Clearwater basin, for permission to install a Lewiston fruit exhibit in the exhibit room of the Portland chamber of commerce when the Oregon exhibit is rebuilt and completed. He asks that space be provided for the Lewiston grape, peach and apple growers, and that they be permitted to pay for their share of the expense of maintenance.

The question will be submitted to the trustees. It is believed the enterprise of the Lewiston people will receive consideration, as the chamber of commerce and other Portland organizations have not had the most encouraging experiences with some of Oregon's fruit growing communities in the matter of assisting to supply the chamber's exhibit.

It is of the highest importance that the Portland chamber of commerce should have its permanent exhibit kept up to the highest state of perfection, with never a lack of the choicest fruits produced in the state. Only with great difficulty and expense has the chamber been able to secure exhibits, and these are not of the best quality. The exhibit as at present is run down to the lowest condition it has been in for years, because the growers do not respond to the chamber's appeals for exhibits.

Thousands of people who have been brought to the state by the advertising done by the commercial bodies, come to the chamber of commerce to examine the state's products and convince themselves of the truth of the claims made by the various communities. An effort will be made this year to reorganize the entire exhibit, and build up to the proportions of a representative Pacific northwest exhibit.
