WILL YOU

Washington, D. C., April 6.—The substitution of legalized trusts and combinations has been proposed seriously, and a bill actually is before congress.

Another remarkable thing is the federal supreme court's decision Justice Harlan dissenting that the Minnesota case was valid; which meant that any other state might ask and get from a federal subordinate court a declaration against the enforcement of a state statute.
