### CAMERON LEADS OVER MOSER AND JAMES COLE

George J. Cameron won the Republican nomination for district attorney after one of the hardest fights of the primaries. James Cole was second in the race with Gus Moser third and Roger Sinnott fourth. The other three candidates, Davis, Taggart and Westbrook, were not serious factors in the fight except as they drew strength from one or another of the leaders. The result clearly demonstrates that if the better element of the Republican voters could have concentrated their votes on James Cole he would have won the nomination. He was regarded, however, by all his competitors as a dangerous rival and was in consequence a constant object of attack. It was this combination of the other candidates against Cole that beat him for the nomination. Out of 89 precincts, for which complete returns have so far been available, the vote on district attorney for Cameron, Cole and Moser, the three leading candidates, is as follows: Cameron, 1,965; Moser, 2,195, and Cole, 2,187.

### Hurlburt Ahead in Multnomah, but His Opponent Carries Every Other County in the District—Loucks Is Third Man.

Clyde B. Atchison won the Republican nomination for railroad commissioner for the second district, after one of the hardest fights of the primary campaign. W. H. Hurlburt, his principal competitor, appears to have carried Multnomah county by a small margin, but Atchison was victorious in every other county in the district. In eastern Oregon Atchison rolled up substantial pluralities, more than overcoming the vote of Hurlburt in Multnomah. C. C. Loucks was third in the race. Complete returns from 85 precincts in Multnomah give Atchison 1,711; Hurlburt 1,215; Loucks 864. The following table gives the results as far as received from the outside counties:

### ADMINISTRATION ANNIVERSARY OF EXPECTS FIGHT FRISCO FIRE

#### President and Root Seek Bay City Celebrates Day by Larger Navy Because Working Hard as Ever to Restore Buildings. They Fear Big War.

(United Press Leased Wire.) Washington, April 15.—That there has been some emergency in the international relations of the United States which has convinced the administration of the urgent need of squeezing out of congress every dollar possible for the navy, is being known, as inferred from the steps that have been taken to inform a very few public men. The president wrote a private letter to Speaker Cannon, urging the four battleship measure. It did not accomplish its purpose, and no statement of its contents has been made public, despite much effort to discover the facts. Today Representative Hobson, now the spokesman of the White House on naval matters, held a conference with Senator Perkins of California. After the discussion Hobson said an effort would be made to insert the senate consent provisions for money for the immediate commencement of work on the two battleships which are certain to be authorized. Although all the authorities studiously avoid any such admissions it is very well understood that the emergency now given is a very real one. ### WRECKED SHIP MAY BE THE BABCOCK

(United Press Leased Wire.) Vancouver, B. C., April 15.—The name of the luckless craft wrecked on the coast of British Columbia has not yet been ascertained. The intervening country is very rough and debris is difficult to secure. ### RUSSIA WILL FIGHT TURKEY

(United Press Leased Wire.) Tiflis, April 15.—War between Russia and Turkey over the former's troubles with Persia is said to be nearer to day than at any time since talk of hostilities was first started. That the czar fully realizes that the sultan is preparing to strike is evidenced by the fact that today he directed General Mischenko, the Russian governor-general of Tiflis, to rush to the Kars district to take charge of the mobilization of troops in anticipation of the Russian advance. General Mischenko started immediately after the order was issued.
