

# STATEMENT SUCCESSFUL

nominees, Farrell and L. E. Crouch, the two anti-statement No. 1 candidates ran in ninth and eleventh places respectively.

For joint representative C. N. McArthur won the nomination over Dr. W. C. Belt with a majority of 3,108. McArthur did not sign Statement No. 1. He received 5,718 votes in Multnomah county and 758 in Clackamas. Belt received 5,905 votes in Multnomah and 463 in Clackamas.

**Machine Is Downed.**  
The sweeping victory for Statement No. 1 in Multnomah county is taken as an omen of no opposition in the future. The overwhelming defeat of the Hodson-Beach-Balley-headed combination in the county is taken to mean by politicians as a definite warning from the voters of the county that no juggling will be tolerated in the future with the rights which the people have voted for themselves in the past. The result has shown in a very clear light that the voters will not allow themselves to be deprived of a right once they have enjoyed it for a season. It is believed, therefore, that there will be no organized fight made on Statement No. 1, the direct primary and the direct election of United States senator in this county in the future.

It now stands the Multnomah delegation will have 15 members pledged to Statement No. 1 in the next legislature and five opposing the principle. A. A. Bailey, senator from Columbia, Clatsop and Multnomah, is pledged to Statement No. 1. S. C. Morfit, holdover from the county, is pledged to Republican choice. Coffey, McArthur, Crouch and Farrell are all pledged to Republican choice. All the remainder of the delegation, with the two holdover senators included in the total list, will give 15 for Statement No. 1 and five against it.

## NEWELL AND HAINES MUST STAY AT HOME

Forest Grove, Ore., April 18.—One decided surprise of the election was the defeat of W. K. Newell of Dilley, candidate for representative on the Republican ticket. Two years ago he was emphatically against the measure this campaign and delivered an address before the students of Pacific university against the statement. He is one of the most popular men of Washington county and it is thought his attitude toward the statement was solely responsible for his defeat.  
Another surprise was the slump of E. W. Haines, president of the Oregon senate at the last session. It was thought by Haines opponents that he would give Dr. W. D. Wood a hard race, but present returns show the latter

leading by over 350 votes. Haines was the lowest man on the ticket and led by E. S. Fisher of Beaverton, by 135 votes.  
Haines' bank failure is said to be responsible for his defeat. A few months ago the institution went to the wall and its affairs have never been straightened up. The people turned the excess of the Oregon senate down, it is said, because they thought he should stay at home and straighten out bank matters instead of going to Salem to pass laws.

## JACKSON COUNTED IN CAKE COLUMN

(Special Dispatch to The Journal.)  
Medford, Ore., April 18.—Jackson county has swung into line for Cake by a majority of 190 over Fulton. Medford is the only town in the county carried by Fulton, who lost Ashland by 65, Central Point by 23, and Woodville by 13, and tied in Jacksonville and Eagle Point. Fulton had three majorities in Medford. By one of the largest majorities in the history of the county E. H. Mulkey was nominated by the Republicans of Jackson county for the office of district attorney of the first judicial district. Mulkey's majority approximates 400. His majority in Josephine county is approximately 70. It is impossible to secure exact results until Monday. The race between Eggleston and Dunn for county judge has been a close one, with indications that it may take the official count to determine the result, with all precincts except those of Trail, Florence, Rock and Lake Creek in, Dunn is reported to have a small lead. These precincts are strong for Eggleston, so that the result is in doubt.  
Ed M. Andrews has been defeated for nomination as county commissioner by James Owen by a small margin. J. W. Lawton has also been defeated by W. L. Greive for nomination as assessor.  
The vote was the highest on record. Mulkey carried Ashland by 234 majority, and Dunn by 96. Mulkey carried Medford by 71 majority, and Eggleston by 71.

## Turns Demon Loose in Police Court

Pittsburg, April 16.—"I will set death on you white devils. Sting them, Nupangle!"  
When these words were shrieked aloud by Lillian Frank, alias Lillie Ling, arraigned in central police court today with her Chinese husband, Harry Ling, even the magistrate braved a shudder that the fumes of opium were in the woman's brain. But in a moment even the stalwart policeman fled in terror. With a quick movement Lillie Ling had reached up on the magistrate's desk, forced open a box of charred opium called "yehshoo" and there flashed therefrom a gigantic red spider, composed principally of 80 hairy legs and a glibbering mouth. The awful creature, in appearance not unlike a miniature red octopus, seemed demoniacal with rage, flashing up and down the rail, while the Chinaman and his wife screamed helplessly. Heavy books were thrown at the strange creature, actually like the phantasmagoria of an opium dream, but the demoniacal spider easily escaped the missiles.  
Just when Policeman Joe Williamson attempted to throw a cloth over the creature it leaped up and bit him on the index finger, clinging savagely. After a fight Williamson succeeded in killing the spider.  
Harry Ling testified that the creature is found on the poppy flower in China and is as deadly as the drug. It came a tiny insect in a "suey" of opium six months ago, he said, and, becoming attached to the strange pet, he called it "Nupangle," or "honorable ancestor."  
Ling and his wife were both fined.

## DIPLOMATS GET FIERCE DRUBBING

Congressman Harrison Declares Secretary Root Is "Prince of Gullibles."

(United Press Leased Wire.)  
Washington, April 18.—The diplomat and consular bill passed the house late this afternoon, but not before American diplomats got a fierce drubbing. Representative Francis Burton Harrison, New York Democrat, held up Secretary of State Root as the "prince of gullibles" because he permitted English missionaries to "stuff him" about Belgian atrocities in the Congo Free state, verbally pronounced Ambassador White at Paris because of the report that he attended court in knee breeches, and likened First Secretary Carter, at London, to the white rabbit in "Alice in Wonderland," after declaring the secretaries are merely appointed because they "belong to the degenerate aristocracy." Hitchcock, Bennett and Cooper defended Ambassador White and Mr. Carter.  
Representative Slayden took occasion to score the Conger family for "looting the Chinese" during the Boxer rebellion. Representative Nicholas Longworth made a plea for the purchase of embassies abroad, declaring this government should be represented by a man and not a pocketbook, but his amendment was defeated.

## PRUSSIA AND U. S. TO EXCHANGE TEACHERS

Instructors to Be Paid by Foreign Government for the Work.  
New York, April 17.—Plans for an exchange of teachers between schools of the United States and Prussia, under the supervision of the Prussian imperial department of instruction and the Carnegie foundation for the advancement of teaching, were announced today.  
The exchange will begin on October 1, and it is expected that 25 to 50 teachers will avail themselves of the opportunity to visit Prussia as guests of the government. That government will pay the visiting teachers \$25 to \$27.50 per month.
