

COME OUT STRONG ON STATEMENT NUMBER ONE

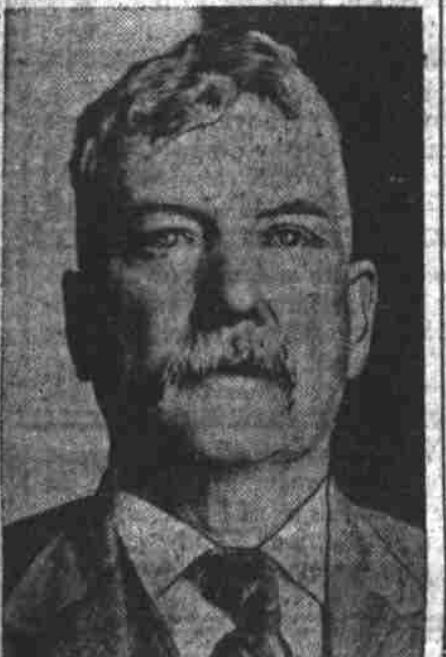
Active Candidates for the Legislature Will Battle With Men Put Forward by Old Line Machine Leaders in Different Parts of the State

Voters of the state of Oregon are flocking to the support of the principle of direct election of senators as it is embodied in the language of Statement No. 1. From every part of the state, as the campaign progresses, comes the report that added support is gathering daily under the Statement No. 1 banner.

In a large number of the counties and legislative districts of the state the fight for or against Statement No. 1 was settled at the primaries. In some counties, however, the battle will not be over until after the votes cast at the general election June 1 are counted. In these counties where the old line machine leaders controlled the primaries, resulting in the nomination of men opposed to Statement No. 1, the battle is now being waged either between the regular nominees and the independent candidates or by the Democratic nominees.

This condition is true in Yamhill, Washington, Wasco, Sherman, Gilliam and Wheeler and other districts and counties. Here independent candidates are opposing the regular nominees, and from the reports which come from these districts the Statement No. 1 candidates are practically sure of election in June.

In Yamhill and in Washington counties the candidates were put in nomination by mass meetings of the voters called for the purpose of selecting strong men to enter the race for Statement No. 1 candidates. Photographs

Supporters in Yamhill.

Sam Laughlin, candidate for joint representative in the Fourteenth representative district, composed of Yamhill and Tillamook counties, is a well-known resident of Yamhill county. He was born near North Yamhill 24 years ago, his father, William Laughlin Sr., being one of the pioneers of this county. Mr. Laughlin was raised on a farm, where he worked, and attended the common school. Later he attended the State Normal at Monmouth and the Agricultural college at Corvallis.

The Laughlin family, which contains a large number of voters, has always supported the Republican ticket. When the attempt was made to defeat Statement No. 1, Mr. Laughlin stood by the decision of the people who passed the primary law, and would not consent to wresting any privileges from the people they now enjoy. He has always taken a deep interest in building up his home town, where he is held in high esteem by the business men. His connection with the Bank of North Yamhill as cashier for the past six years has demonstrated the fact that he can be trusted to do the right thing, should he be elected. He believes that United States senators should be elected by direct vote.

He is strictly opposed to extravagant appropriations that have no merit, and believes that the present system of collecting state taxes is unjust and should be remedied, as a great many counties

decided to hold about 15 meetings during the last two weeks of the campaign. On this tour the large towns will not be given so much attention as the smaller places and the rural districts. It is intended to hold most of the meetings in the schoolhouses of the county districts.

For the People's Choice.

N. I. Burnett, of Greenville, Washington county, was nominated to try for election as representative in Washington county. He was born near Bangor, Maine, December 29, 1847. At the age of six years he moved with his parents to Jackson county, Iowa, where he grew to manhood. At the age of 24 years

he was married to Miss Mary L. Baker and started to face life in real earnest. Possessed of nothing but a pair of willing hands he started farming on a rented farm, but after five years finding this to be a very slow way of gaining a permanent home, concluded to face the blizzards. In the spring of 1880 he moved to Clay county, Minnesota, where he took a homestead on which he remained for the next two years, until 1900, when he moved to Oregon and purchased a farm near Greenville, Washington county, where he now resides.

In politics Mr. Burnett has always been a Democrat, but now, and for many years, has firmly believed that if the great masses of the people ever free themselves from the grasp of the trusts and combines they must do so by casting party prejudice to the winds, working and voting for principal instead of man or party—therefore his voters of Washington county Mr. Burnett wishes to say that if elected he will cast his vote for the candidate for United States senator receiving the largest number of votes at the coming state election, just as freely for the one who did not vote at the general election as for the one who did.

On No. 1 Platform.

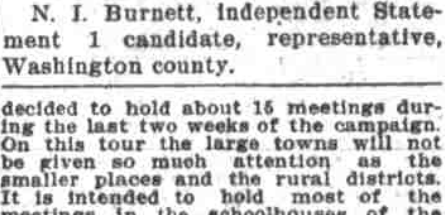

LOUISIANA LEGISLATURE. (United Press Lined Wire.) Baton Rouge, La., May 12.—The biennial legislative assembly of Louisiana convened today and was opened with the customary ceremonies, and the session already gives promise of being one of more than ordinary interest and importance to the public. The three leading measures that are to be brought up are the proposal to abolish the race-track in Louisiana, a bill for state-wide prohibition with the exception of New Orleans, and the measure aimed against the Cotton Exchange. Governor Sanders, the new chief executive of Louisiana, will be inducted into office next week.
