

WIRELESS TELEGRAPHICAL FROM EXCURSION BOAT

S. S. Roanoke, by Wireless to The Journal, May 20.—The Atlantic fleet has been greeted by Oregon. The Roanoke and the Alliance met the ships off Tillamook rock at 12:30. The fleet is steaming in single column, the Connecticut leading, sufficiently close to shore to be seen plainly from Seaside and North Head where the hills are lined with people. The fleet passed within a few hundred feet of the excursion steamers. The weather is fine. A strong southeast wind with heavy squalls is making the trip a thrilling one for excursionists.

The fleet has encountered severe weather since out of San Francisco, but it has moderated today.

CHURCH DISCIPLINE IS TOO LAX, SAY PRESTES

Episcopal Clergymen Declare They Need Power of Excommunication to Enforce Rules of the Church—Remarriage of Divorcees Is Discussed.

Divorce, failure of members to attend communion, and the purely English problem of the marriage of deceased wife's sisters were the principal subjects of discussion at the international clerical of the Episcopal church which convened in the pro-cathedral this morning.

This irritated Bishop Robinson of Nevada, Bishop Robinson is the newest bishop in the church, and he declared that the bishops did support the clergy in their discipline, but that the clergy did not support the discipline.

English Prelates Rapped. The meeting touched upon the discussion of creating such excitement in England, namely the marriage of a deceased wife's sister—briefly, but Rev. H. G. F. Clinton of Vancouver, Dr. Clinton took a rap at the mother church and the English prelates, particularly the archbishop of Canterbury who, he said, had behaved in a very weak spined manner with regard to the marriage.

Dr. Arthur A.
