PROPHECY AS TO RESULTS IN LINN

Statement No. 1 Men to Win—Closing Rallies—The Anti-Saloon Fight.

Albany, Or., May 30.—The campaign in Linn county is rapidly drawing to a close and the final rallies of the respective parties will close it tonight. A close canvass of the county has been made by all candidates and the indications are that much-mixed tickets will be voted on election day. It is conceded that a full Statement No. 1 delegation will be sent from Linn county to the Oregon legislature. The county officers will be hotly contested and possibly the fruits of victory will be divided. The greatest possible interest centers in the question of "wet" or "dry" and the campaign has become one of great bitterness. Literature of all kinds is being mailed to voters. Both sides are working night and day. The drys are calmly confident that they will win with a greater majority than that of two years ago. The farming element is almost a unit against the proposition of an open town and wet county.

Local Option Circulars.

In a large circular mailed to each voter in the county by the Good Citizens' league of Linn county the names of those signing the petition for an election were published, with the amount of taxable property represented by each, as shown on the tax rolls of the county. In opposition to these petitions a remonstrance was also circulated showing the names of men prominent in business who said they were satisfied with the law as now enacted and opposed to a return to the open saloon. In addition the tax valuation of the property of these men was set forth and a comparison was made with the men anxious for the present conditions to be reversed. The object was to show it was not the taxpayers that were demanding a return to the licensed saloon regime.

Matter From the Circulars.

A direct quotation reads as follows: "As you know, Linn county has been without saloons for about two years. A desperate effort is being made by the Liquor Dealers' association not only to restore saloons to the towns of our county but to break down the present local option law in the state that it will be impossible to have a majority rule in reference to the liquor question. We desire that you give earnest consideration to the bearing of this matter upon your best interests and the best

interests of your fellowmen, and if the saloon has never done you any good; if the saloon has never done your friends any good; if the saloon has never done your town any good, we ask that you vote against the return of it to Linn county, for it has done somebody some harm.

"The Liquor Dealers' association through its subsidized newspapers and other literature has claimed that the local option movement was a movement of religious fanatics, who pay no taxes and have no care for the financial side of the question. That this is not a fact so far as Linn county is concerned no one will deny who reads this circular through.

"The Liquor Dealers' association had never employed for over a month to go over this entire county to get a petition signed by as large a number of citizens as possible. Every man who was known to be in sympathy with the saloon system was canvassed. They did their best to make a good showing on that petition.

"With the exception of a few men who did not understand the nature of the petition when they signed it (some of whom have signed the indorsement of the local option law and will vote for its maintenance), the names of the men on this petition are the names of all the men who are really anxious for the return of the saloons to Linn county. They represent the \$21,000,000 worth of property in Linn county? Are they the men who are carrying on the business of the county? Have you seen any of these names among the Albany Boosters?

Taxpayers Compared.

"Of the 703 persons who signed this petition \$44 pay no taxes into the Linn county treasury, although a few of them have paid as high as \$200 apiece on a valuation of less than \$500 taxes.

"Of the 727 signers of the indorsement of the law, 518 pay taxes in Linn county on a valuation of \$2,004,980 worth of property. These men are not round among the 'knockers' of Linn county. They are not supporting papers that are circulating the false reports that there are empty business blocks in the heart of the city since prohibition went into effect. You will find them among the 'boosters' who are spending their money to advertise the Willamette valley that legitimate business may be increased, that farm land may advance in value and that farm produce may bring a better price."

The Indorsement.

"We, the citizens of Linn county, Oregon, do hereby express our most hearty approval of the local option law, by virtue of which our county has been without saloons for two years. During this period business has been on a steady increase. The towns of the county were never so prosperous as they are today, and while the law should be much better enforced than it has been, we believe that it should be maintained for business as well as for moral reasons.

"We call your attention to the fact that with the exception of a few reputable druggists, the men who have been holding government revenue stamps for the retail of intoxicating liquor in this

MARION COUNTY'S DRYS IN PARADE

Nearly 3,000 Women and Children—Little Citizens in Carriages.

Salem, Or., May 30.—Local optionists had a big demonstration on the streets of Salem this afternoon. Nearly 3,000 women and children carried banners in the parade, which was five blocks long, and three times as big as the recent Republican demonstration. Nearly every precinct in the county was represented. The parade was led by Mayor Matlock of Eugene, who spoke to a large audience at G. A. R. hall after the demonstration.

Children bearing banners with "Am I a business proposition?" and similar inscriptions were numerous. Willamette university was represented by both girl and boy students, its banners and pennants flying. There was a large percentage of men of all ages in the parade, and a large number of women wheeling their babies before them in baby carriages.

A conundrum is printed on the front of the circular that reads as follows: "If the statement of the liquor men is true, viz: that the 'blind pigs' sell more 'good' under a law that prohibits the saloon than the same 'blind pigs' sell when we have saloons, why did every man in the county who has been for the resubmission of the question?"
