

VOTERS AID UNIVERSITY

Every Indication Is That Popular Appropriation Measure Will Receive the Support of the People—College Great Benefit.

(Special Dispatch to The Journal.) University of Oregon, Eugene, Or., May 29.—As election day approaches it becomes apparent that the university appropriation bill, which was held up by referendum petition for approval or rejection by the voters of the state, will be approved by a safe majority. For the past six months friends of the institution have been waging an effective campaign for the passage of the bill and if surface indications count for anything, the measure should receive a majority of from 10,000 to 15,000 votes. The work of the campaign has been under the direction and personal supervision of three of the alumni—C. N. McArthur of Portland, L. R. Alderman and A. H. Easton of Eugene—who have been assisted by Registrar A. E. Tiffany, who is also a graduate of the university. The alumni and friends of the university in all the counties of the state have rallied to its support and no stone has been left unturned in the matter of educating the voters to the needs of the institution.

Advertising College.
The alumni campaign committee has handled more than 300,000 pieces of literature in addition to the pamphlets sent out from the office of the secretary of state, and it is estimated that 25,000 letters have been written in the interests of the bill. The work of organizing the newspapers of the state in support of the bill has been carried on by Mr. McArthur, with the result that 133 newspapers have recommended the bill in their editorial columns. Not more than 10 newspapers have opposed the bill and some of these have done so only in a minor way. Mr. McArthur has also directed the general campaign in Multnomah county, where the university expects to roll up a very large majority.

Alderman Speaks for Bill.
L. R. Alderman has had charge of the work of interesting the public schools and high schools throughout the state in the university appropriation bill and has also taken the stump for the bill. He has made no less than 50 speeches in various parts of western Oregon during the last two months. Mr. Alderman has been connected with the public school system of different counties of the state for the past 10 years and realizes probably more than any one else the importance of the university to the public schools. A. H. Easton, representative from Lane county, and father of the appropriation bill, has had general charge of the work of organizing the campaign in the various counties of the state and has carried out his part of the program successfully. The university has active campaign managers in most instances an alumnus, in every county in Oregon these managers have distributed literature, spoken at public meetings and have done everything possible to enlist the support of the voters of their counties.

The business men and citizens of Eugene have been most loyal in their support of the appropriation bill and have written thousands of letters to voters in various parts of the state.

Friends of the University Believe That They Will Secure Between 45,000 and 50,000 of These, and Will Have a Clear Majority of Between 10,000 and 15,000.
They count upon carrying every county in eastern and southern Oregon, and expect an overwhelming affirmative vote in Multnomah county. Lane county will, of course, roll up a tremendous majority for the bill, and favorable reports have been received from Columbia, Clatsop, Tillamook, Umatilla, Coos and Douglas counties. The opposition to the university has come principally from the counties of the Willamette valley, where most of the signatures to the referendum petition were secured. An active campaign has been made in all of these counties, and, while some of them may go against the university, a majority of them are doubtful. Linn county, the home of the referendum movement, has been the battle-ground of a vigorous campaign, and friends of the university have high hopes of carrying that county.
Among the counties in eastern Oregon which promise to roll up a big vote for the bill are Baker, Union, Umatilla and Wasco, but it is freely predicted by members of the campaign committee that every county in eastern Oregon will go two to one for the bill. Students and friends of the university have been busy during the past two weeks sending out postal cards to friends in all parts of the state, asking them to vote "Yes" on the bill.

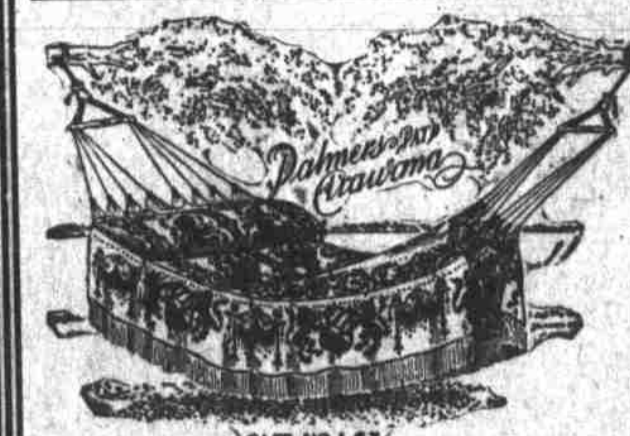

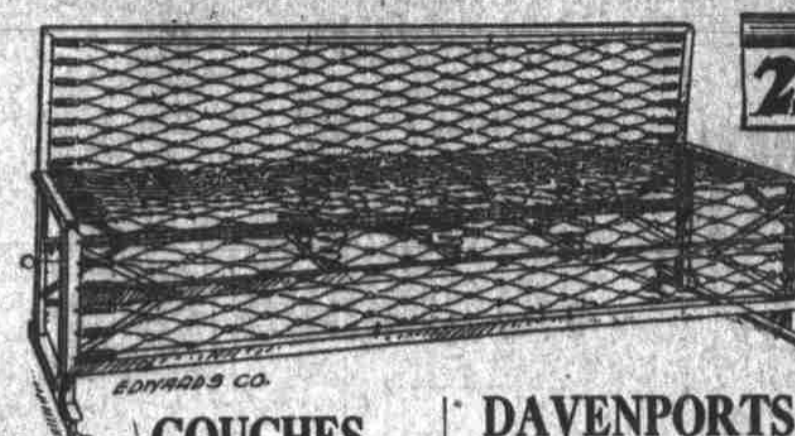

CLINTON'S BODY IS RE-INTERRED

Fitting Funeral Oration Delivered by Former Senator David B. Hill.
(United Press Leased Wire.) New York, May 30.—With all the honors due the high estate he occupied in life, the body of General George Clinton, first governor of New York state and twice vice president of the United States, was re-interred here today. It was a fitting day and a fitting place. The funeral oration was fittingly delivered by the last surviving Democratic governor of the state, former United States Senator David Bennett Hill. Senator Hill sketched at length the life of General Clinton as a warrior and officer of the Revolutionary army. He continued: "As a statesman, Clinton was far-sighted. He was never hysterical in either public or private station; he knew and represented the limitations upon his official authority. And above and beyond everything, he possessed the most admirable quality in a public man, he knew enough but knew that he did not know it all."

HEFLIN ARGUES FOR HIS BILL

Wants Government Grafters Punished for Giving Out Official Secrets.
(United Press Leased Wire.) Washington, May 30.—Representative J. Thomas Hefflin of Alabama, who recently won notoriety by shooting at a colored man in Washington, and hitting a white man, made an effective appeal today to have passed his bill providing penalties for government officials and employees who give inaccurate or advance statistics of crop yields and acreage.
The bill has been favorably reported and is on the house calendar, but the speaker will not grant recognition to have it taken up for passage.
"Your failure to act," said Mr. Hefflin to the Republicans, "will plague your candidacy in the agricultural districts this fall. It puts this year's crop reports at the mercy of the gamblers in New York, Chicago and New Orleans."
Representative Calderhead interrupted to say that Mr. Hefflin was out of order in that he was not speaking to the bill under consideration which was to grant pension to three Civil war veterans in Kansas.

JACOBS PUNISHED UP TO THE LIMIT

Eugene Booze-Seller Fined \$500 and Sentenced to 30 Days in Jail.
(Special Dispatch to The Journal.) Eugene, Or., May 31.—Joseph Jacobs, the Eugene merchant who was arrested a few days ago and found guilty by a jury of selling liquor in violation of the local option law, was given the maximum fine by Judge Bryson in Justice court yesterday afternoon. He was fined \$500 and given 30 days in the county jail. This is Jacobs' second conviction. The first time a fine of \$100 was assessed against him. At that time he promised the judge that he would observe the law, but there was evidence for several weeks before his second arrest that he was selling liquor. It was shown at the trial that he sold it at his residence, often in the presence of his children.
Jacobs' attorney has filed a notice of appeal to the circuit court.
