

TRES TO SAVE BUCKLEY'S LIFE

Police Captain Duke Declares He Believes China Copeland Guilty.

(United Press Lined Wire.)
 San Francisco, June 15.—Police Captain Thomas S. Duke today swore to a statement that will be presented to Governor Gillet with a petition for the pardon of William Buckley, now facing the gallows at Folsom prison on the charge of having been implicated in the murder of George W. Rice in this city in 1901. Rice was beaten into insensibility by four men at the time of the teamsters' strike and then shot by a fifth man. The city was in a chaotic condition at the time and the crime aroused the entire population.

Buckley was convicted as the man who fired the shot, although Rice failed to identify him when he was brought before the dying man.

Edward Dunson is serving a life sentence in San Quentin for complicity in the crime, and Thomas Moran is serving a 20-year term in the same prison. Charles Donnelly, died in San Quentin while serving a 20-year sentence.

Buckley's case is now pending before the United States supreme court but it is hoped that a pardon may be obtained for him before it is disposed of there. Captain Duke says in his statement today that he is convinced that China Copeland, a notorious thug who disappeared on the night of the murder, is guilty and that Buckley is innocent.

JURORS TENDER TOWARD INSANE

Three Hang Out, and Bud Barnes Must Be Tried All Over Again.

 Walla Walla, Wash., June 15.—Hopeslessly disagreed, the jury in the Barnes murder case was discharged this morning at 9:50. The vote stood 9 to 3 for conviction of murder in the first degree and the three men could not be won over. The jurors agreed not to tell how individual jurors stood, but it is understood that the three intractable men on the jury have had insane relatives. It is alleged that the father of one of them was cleared of a murder charge on that defense.

The Barnes case is set for trial again June 24.

The judge censured the jury for taking the punishment into consideration.

"It is none of your business what the punishment is," said the judge.

Barnes smiled as the judge discharged the jury. He is confident and is taking things easy.

Barnes is charged with having murdered Mrs. Aldrich on the night of the gulch near Dixie, beating her head in with a pick handle and dragging her from the creek up the hill and burying it in a hole by her ranch. Later he took possession of her ranch.

LOOKING FOR MEN WHO SHOT FLUME

Detectives Busy at Hood River—Weather Lightens Losses of Growers.

 Hood River, Or., June 15.—The action of dynamites in blowing up 150 feet of the flume of the farmers' irrigating ditch, which waters the big strawberry fields on the east side of Hood River valley, has caused widespread consternation and indignation among berry growers and residents here, who state that prompt action will be taken to locate the guilty parties.

So far no arrests have been made and officers of the company refuse to divulge the names of suspects. It is expected, however, that the rigid investigation which has been put on foot will locate them.

Lack of water yesterday cut down the berry shipments to less than half of what they were the day before and they will be far less today.

It is thought now that the flume may be repaired by tomorrow evening, as an additional force of men has been hurriedly secured and gangs have been placed at work that will rush the repairs day and night until they are completed. With this expectation in view and the fact that the weather today is much cooler, the loss to growers is expected to be cut down to \$15,000 or \$20,000. The damage to the flume not only means a heavy loss to the growers but will also mean thousands of pickers out of employment for several days.

CHAPEL DEDICATED AT TRAINING SCHOOL
