UNION OF C. E. OF U. B. CHURCH

Movement Started at Annual Convention Held at Oregon City.

(Special Dispatch to The Journal.) Oregon City, June 22.—At the first annual convention of the United Brethren Christian Endeavor societies of the Oregon conference, which met at the United Brethren church here last week, M. A. Crall of Philomath presiding, delegates were present representing the Portland, Otterberg, Philomath, Plainville and Astoria and a movement was started for organization into a state union.

Rev. W. Reynolds was elected chairman of the business session and a committee consisting of H. P. Cooper, Mrs. Faith K. Fugatey and M. A. Crall were appointed to prepare a constitution for the government of the new state union. The constitution that was reported was, after some discussion, unanimously adopted.

The following officers were elected by the convention: President, B. A. Martin, Portland; 1st vice-president, Professor L. B. Baldwin, Philomath; 2d vice-president, Mrs. C. F. Blanchard, Astoria; 3d vice-president, Pastor H. Medley, Oregon City; secretary, M. A. Crall, Corvallis; treasurer, T. L. Burns, Philomath.

The Philomath society presented to the convention for ratification a new constitution for the government of the Christian Endeavor societies of the United Brethren church, to be sent as a petition to the general conference of the church. The constitution met the unqualified approval of the convention and was heartily approved by Bishop Barkley.

Lexington, Ky., June 22.—The crude justice of the mountains, which has made notorious the name of Breathitt county, has dealt with men and their feuds, not with husbands and their affinities—until now. Here is how it operates on this social canker:

Thomas Murrill recently became enamored of Mary Terry. Mrs. Murrill is 35, muscular and intrepid, as becomes the life of a mountaineer. She was once pretty, too, as comely as the plump Mary Terry, with her 19 years, the last two of which have been spent in college in Lexington. But toil and industry have made the wife less attractive, and Murrill tired of her. He spent so much of his time visiting the daughter of his widowed neighbor, Mrs. Terry, that Mrs. Murrill and the children were left to do all the work about the farm.

After replacing the rifle in the gun rack at home, Mrs. Murrill walked to the home of Magistrate L. C. Terry, an uncle of the girl she had killed, and surrendered. She was placed in jail at Jackson today.

PEASANT GIRL BEATS ARCHDUKE
