

BISHOP POTTER AT DEATH'S DOOR

Recent Improvement Annulled by Breakdown Due to Extreme Heat.

(United Press Leased Wire.)
New York, June 30.—After lying at the point of death throughout the night, Bishop Henry Codrington Potter, who has been ill at his Cooperstown home since June 5, had not improved today, and it is feared that he cannot survive.
Fresh air rides, walks and frequent sailing trips on Onondago lake had made a marked improvement in Bishop Potter's condition, and hopes for his complete recovery were entertained until the extreme heat, which broke down under the bishop was confident of early recovery. His work at his office in the Clark Estate building almost daily and was exceptionally active for a man in his 75th year.
When the bishop's liver and stomach trouble, aggravated by the heat, forced him to retire to his bed, Dr. J. E. Jarvin of New York and Dr. Bassett of Cooperstown were called and have been in almost constant attendance since. A bulletin issued by Dr. Jarvin today announces that the bishop's condition remains unchanged and is extremely critical.

FIRECRACKERS SET PASO ROBLES ON FIRE

Paso Robles, Cal., June 30.—A premature celebration of the national birthday yesterday nearly resulted in the destruction of the entire town of Paso Robles. Over three hours the fire department, aided by every available man in town, fought the flames.
The fire had its inception in a grass and brush fire that was started by exploding firecrackers. One building caught fire and a strong wind blew cinders all over the town and the Paso Robles Hot Springs hotel.
Several other dwellings caught fire and the firefighters had a hard time extinguishing the flames. After the flames had been put out the residents in the southwest section of the town, where the fire started, gave the firemen a generous donation.

STATE REFORM SCHOOL TO BE INVESTIGATED

Los Angeles, June 30.—Serious allegations of mismanagement in the care of the Whittier State Industrial School for Boys and Girls have been made against Superintendent J. F. Greeley, at a meeting of the board of trustees, dismissed and the board decided today to lay the case at once before Governor Gillett.
The principal charge brought against Greeley is that he is unable to enforce discipline at the school. It is asserted that as a result a shockingly immoral state of affairs exists at the institution. Damaging exhibits in the form of obscene letters, indecent postals and notes, are said to be in the possession of one of the trustees, who says he will produce them later.

WERKED INTO FIRE BY A KINKED HOSE

Two Firemen at the Nozzle Victims of Most Extraordinary Mishap.

San Francisco, June 30.—Lieutenant Joseph Dolan and Joseph O'Brien of Company 10, fire department, were injured today in a peculiar accident at a fire in a Mission street restaurant.
Dolan was not badly hurt, but O'Brien was rendered unconscious.
The men had hold of the nozzle when the hose became kinked in the street, and shut off the water supply. When someone straightened out the kink the hose gave a sudden kick and threw both firemen into the kitchen of the place, which was scorching from flames.
Dolan scrambled out, but O'Brien had to be rescued.
Damage by fire was about \$2,000. Lodgers in a hotel next door rushed out into the street in their night robes, but were sent back to their beds.

DECLARE WAR ON COCKNEYS

Englishmen Form Pure Speech League With View to Reforming "Mother Tongue."

London, June 30.—Professor Brand's repeated statement that English English is not English is amply confirmed if one listens to the average Cockney murderer's mother tongue. The Cockney atrocities have lately come up for discussion in the newspapers, apropos of the foundation at Hoxsey, a North London suburb, of a "Pure Speech League."
George Bernard Shaw is one of the most strenuous opponents of Cockney speech, which he has attempted to translate into print as it is really spoken. He declares that even society people say "dah tah" for "down town" and "cowcow" for "cocoa."
The long a in words like dance and glass is characteristic of Londoners of every class, but a true Cockney pronounces the words something like "dahnce" and "glahrs."
Many quaint specimens of Cockney English are quoted in the campaign against Cockneyism. Here is one "Bib's nime's Jimes, pline Jimes." Substitute a for l and you see what was meant.
A leading barrister in the London courts was heard to say to a witness: "Bibler eye yo sayer in, on the question which the witness, being a Cockney himself, was able to translate as "Did you say you saw him in the laze."
An alderman of the city of London, who lived in the suburb of Highbury, said to a cabinet minister: "D'ye think 'Ighit pretty?" When the statesman replied that he had not noticed any chance in the alderman's appearance the latter, bewildered, said: "I'm not talking about myself. I said 'Ighit.'"
"In English public schools most of the attention is devoted to Latin and Greek. In American colleges English takes the first place in language studies. The students are taught the pronunciation of Anglo-Saxon and Middle-English, and modern English is taught to have a matter of course. Constant attention devoted to the phonetic history of words does, of itself, encourage a precision and nicety in the use of those words as employed today.

GIRL ROUTS BURGLARS WITH FIRECRACKERS

Young Woman Alone in Home Drops Bunch in Hall When She Hears Noise.

Pittsburg, Pa., June 30.—Ignoring even the thought of pistols or gaffing guns, Miss Isabel Pontefract, a social leader in Sewickley, routed a couple of burglars this morning with a bunch of firecrackers.
While alone in the house, she heard a noise in the dining-room. Getting a bunch of firecrackers she walked to the head of the stairs, touched a match and dropped the bunch into the hall below.
Believing that the noise was not loud enough, she went to her room and got a couple of cannon crackers.
These did the work. Amid the noise of the explosion, the sound of running feet was heard.
When the servants appeared, Miss Pontefract was busy putting out a number of small fires started by the crackers.
The burglars had disappeared, and the demand for firecrackers in the Sewickley valley has increased considerably.

SPIRITUAL ATTACK ON WOMAN BY PROPHET

Disciple of Arkansas Elijah Says There Was No Physical Struggle.

Fort Smith, Ark., June 30.—Elijah Skaggs, who claims to be the reincarnation of Elijah the Prophet, sent here as a vicarious atonement for those who do not believe in Christ, was put on trial yesterday on a charge of attack on Mrs. Margaret Irene Taylor, of Dallas, Tex., a disciple.
At the preliminary hearing Mrs. Taylor told of a physical struggle, but on taking the stand today she declared the attack was merely spiritual and in accordance with a covenant made between her and Skaggs, that he might be hanged and rise on the third day. She offered to get a rope if the people would hang her and there.
Cross-examination could not shake her story. She was arrested for perjury and is in the county jail.
Skaggs declared he was guilty in his heart and was ready to hang, but would plead not guilty because he was not hanged and did not wish to go to the penitentiary.

BOY SETS FIRE UNDER WOMAN; SHE WILL DIE

Steals Up Behind Victim Sitting on Bench, and Touches Match to Paper.

New York, June 30.—Stealing up behind a bench in Roosevelt park near Fordham station, on which Miss Catherine McCormick, 38 years old, was sitting, a boy dropped a pile of papers, touched a match and was gone.
As the flame sprang up Miss McCormick's light summer gown ignited. With a scream she leaped to her feet and stumbled wildly across the lawn, tearing at her burning garments with her hands.
Before she had gone 20 feet she fell, with her hair ablaze and her clothing flaming from her in a score of places. The woman was terribly blistered from head to foot. Her hair was scorched entirely away.
She was just able to whisper her name and address, and then she fainted. Physicians said she would die.

BEDROCK MACHINE FOR DOGIE RIVER

Gold Deposit on Stream's Bed to Be Mined—Placer Yield.

Grants Pass, Or., June 30.—The big bedrock mining machine, which is being built by the Gilman Mining company, is nearing completion and will be placed on Rogue river by July 15. The barge for the machine is being built in Grants Pass, but the main portion of the equipment and machinery is under manufacture at Sacramento.
The machine is a patent of L. F. Gilman, president and manager of the company, and will introduce a new phase of mining in southern Oregon. It is a well known fact that the bed of Rogue river is rich in gold, but there has been no available method of obtaining it. The gold could not be dredged in the ordinary way because of the bedrock bottom of the river. This machine drives a portion of the river bed, exposing it for mining.
The appliance consists of a conveyor, made of steel slides working in grooves. There is also a double dome arrangement, one working inside and independent of the other, so that it will adapt itself to all irregularities on the bottom of the river. The machine will work between two ponderous barges, 18 by 80 feet, being hung to an overhead frame in such a way that the domes can be readily lifted from the bottom of the river and shifted from one point to another.
Placer Mines' Output Heavy.
The hydraulic placer mines of southern Oregon have nearly all completed their annual spring cleanup. There has already been brought in for exchange at the banks for shipment to the mint over \$500,000. It is believed that the total output of the placer mines of the southern Oregon district for the season will approximate three quarters of a million. Several of the bigger mines produced them, among them the Sterling, Deep Grave, Columbia, Royal Group and Simmons & Logan, will clean up from \$20,000 to \$50,000 each. Besides these larger ones there are a number of small placers that will clean up from \$5,000 to \$10,000 each.
There is also considerable platinum being cleaned up with the placer gold in southern Oregon. Three fifths of the total output of platinum in the United States comes from southern Oregon. This platinum is carried to the mills with the gold, and is secured by careful panning in vats and tubs of still water.
As the hydraulic placer mines of southern Oregon are never-failing in their returns, the yield from these forms is most important to the placer men. The several thousand men engaged in the mining business in this part of the state, as it is pure gold, and passes the same as coin, it goes immediately into the channels of trade, and insures continued "good times," no matter what the financial condition of the country at large may be.

Escaped From Sanitarium.

Edward H. Nodie, an inmate of the Mountain View sanitarium, escaped from the institution yesterday afternoon and the aid of the police has been asked in finding him.
As soon as he left the sanitarium Nodie made at once for the office of an evening paper, and said that he had discovered an infallible cure for consumption. He was not detained and soon went his way.

Damage Done by Vandals.

Vandals last Sunday damaged the Idaho building at the fair grounds by upsetting a barrel of paint and two five-gallon cans of the liquid on the floor. It has been reported to the police that the mischief was done to spite the owner, Paul Weesinger.

Organized Labor is soon to have a newspaper system covering the entire country.

A syndicate has been formed and the enterprise capitalized. It is said, to the extent of issuing a paper in the cities of New York, Philadelphia, Washington, Chicago, St. Louis, Denver and San Francisco. NIPPONS BARRED FROM FISHING

Japanese Cannot Lawfully Hold Licenses as Fishermen.

(Special Dispatch to The Journal.)
Olympic Wash., June 30.—A ruling made by the attorney-general, if it is sustained by the courts, will put hundreds of Japanese engaged in fishing in this state out of business.
The last legislature passed an act licensing fishing and provided that licenses shall not be issued to any person who is not a citizen of the United States, unless such person has declared his intention to become naturalized one year hence.
In order to secure fishing licenses Japanese fishermen have been filing declarations of intention to become citizens, but the attorney-general holds that they cannot legally be admitted to citizenship in this country. Accordingly, licenses issued to Japanese are void and they violate the laws of this state when fishing.
