TAMMANY LEADERS CONCEDE TO BRYAN WILL CONTROL THE FUTURE OF DELEGATION

LET PACIFIC TAMMANY HAVE SHIPS GIVES UP

Bryan's Right-Hand Man Surrenders to Bryan at State Caucuses and Makes Assignments of Delegates—Norman Mack for National Committeeman.

by R. H. Canfield, Staff Correspondent of United Press. Denver, Colo., July 6.—If the Pacific coast delegations work hard enough for it, there is a good chance for a coast defense plank in the Democratic platform.

Naturally, the Democratic leaders realize that such a measure would be good politics, because of the turnout of the Pacific coast defense measure received at the Republican convention at Chicago.

The project needs only strenuous and continued agitation by the delegations from the Pacific coast states to be taken up by the convention.

Major James C. Dahman, of Omaha, Bryan's acknowledged spokesman here, said today:

"I am for Pacific coast defense. I am going to talk it and work for it. If the coast defense measure is adopted on this we will do business. I will go farther than coast defense, and advocate that the fleet be increased in the Atlantic, we ought to build it, not take the battleships from the Pacific."

The movement met with opposition from some of the middle west states. The middle west is not greatly interested in a plan to spend many millions for forts and guns on the Pacific. It would prefer that money be spent for improving the waterways of the Mississippi valley. Consequently the coast defense measure cannot be sent through without a hard fight.

Coast Booms Head or Dying. One Pacific coast boom for the vice-presidency is dead. Another is dying. The defunct boom was the property of Franklin K. Lane, of California. The one that is not expected to live belongs to Theodore A. Bell, also of California. Bell's boom is still alive for the reason that he has better developed than Lane's.

For a few days during the preliminary of the convention, the coast prospects for the vice-presidency were taken seriously. Many delegates pointed to the Pacific coast for geographical reasons alone, there was a good chance for a man west of the Rockies. Lane's boom had an authority in boosterism in Denver, but nevertheless he has frequently been mentioned for the vice-presidency. His intransigent committee would elect Governor Gillett and his antagonism to the Southern Pacific all helped. But it soon became evident that Lane took no personal interest in his boom and refused to consider it seriously. He is said to be a hard worker, but the word that he had started was received at Democratic headquarters all interest in the Lane boom.

Bell's boom, although very sick, is still able to sit up and take a little encouragement from its boosters. When the California delegation gets down to real business it is possible that it will improve, but the opinion grows that the temporary character of the coast nomination is enough honor for Theodore Bell.

norm." Declared McCarran, "In the state convention had adopted, without a delegate hearing, a resolution declaring that the Kings county district conventions were unfair and fraudulent, had disqualified regularly elected delegates, and had elected a committee of thieves and pirates in their places, men who could not carry a single election district in the nation made by each."

"We know this man was made up by Murphy and we insist that our delegates who were the choice of the voters of their districts be seated."

Bird S. Coler answered McCarran. He declared that McCarran and his friends were using a discreditable tactic at the polls and insisted that the gravest of frauds were practiced by the followers of McCarran. He declared that the state convention was absolute in its power.

"We threw McCarran and his delegates out of color concluded and we did so because we will no longer tolerate his methods in the Democratic party of New York."

The subcommittee decided to hold the contests behind closed doors and to report later. The committee then adjourned at a recent late hour, when it will receive the reports.

ON THE SIDELINES AT DENVER

(Hearst News by Longest Leased Wire.) Denver, July 6.—Former Governor Charles S. Thomas of Colorado, member of the committee on resolutions in the Democratic convention, today declared for Roosevelt for vice-president.

"He is by long odds the strongest man we could name," he said, "and I believe that if his name should be presented he would prove a winner, and if nominated he would accept. I don't see how he could refuse."

"Aren't you afraid that if you get to discussing Roosevelt too strongly for any party, the convention will be stamped for him for first place?" a Republican bystander asked.

"The convention will be stamped for Governor Thomas. A worse thing might come upon us."

GUFFEY LOSES HIS TEMPER AND BERATES BRYAN

(Hearst News by Longest Leased Wire.) Denver, July 6.—William Jennings Bryan today received the worst verbal pummeling that ever a candidate for the first office of the land has sustained at the hands of a man in his own party.

Colonel Guffey of Pennsylvania, the national committeeman whom Bryan pilloried Saturday night in Fairview park, came back in a long statement in which he called Bryan an ingrate, a traitor and "the most imprudent and arrogant loss the Democratic party has ever known" and defied what he calls Bryan's "absorption of the party."

"The intention was given me amid exciting circumstances. Guffey strode about his quarters in the Adams hotel, with tightened fists and face as white as his snowy mustache."

When he handed out the copy of his statement to the press representatives he said:

"Read it and tell me what you think of it. Before any reply was made he nervously strode off, saying as he went: 'If you don't like it, you can substitute for it that Colonel Guffey says Bryan is a blackguard and a liar.'"

HISSES AND JEERS AS BOLTERS IN HUFF LEAVE HALL

Denver, Colo., July 6.—The Pennsylvania delegation today, after a bolt by the Kerr contestants, elected Colonel William J. Guffey as chairman of the delegation and member of the national committee. Former Congressman Kerr himself led the bolters. As they walked out they were greeted with hisses and jeers by the Guffeyites. One of the latter denounced them as cowards, and a Kerr man retorted:

"Come down to the alley and see whether we are."

Guffey was nominated as national committeeman by O'Boyle and received the votes of all the 47 delegates who remained in the meeting.

LABOR ANXIOUS FOR PROTECTION Gompers and Mitchell at Hand to Urge Proper Anti-Injunction.

(Hearst News by Longest Leased Wire.) Denver, July 6.—Samuel Gompers and John Mitchell, former head of the mine workers and also a vice president in the Gompers organization, arrived here yesterday afternoon to take up the fight before the committee on resolutions for the anti-injunction plank which was rejected by the Republican national convention at St. Louis.

Gompers and Mitchell dined together last night and afterward went for a walk in the city. Mitchell, who is the political situation as it touches upon the labor question. It is known, however, that Gompers, as well as Mitchell and other labor leaders, will appear before the committee on resolutions and urge that the convention adopt as part of its platform the anti-injunction plank which Gompers presented to the Chicago convention.

Gompers and Mitchell had a long conference here last night and will confer again today with representative labor men as well as some of the prospective members of the resolutions committee. Mr. Gompers said last night:

"We have had a long conference and laid out our plans there is nothing that can be said except that we shall urge upon the convention the passage of the Democratic anti-injunction plank."

"At the Republican convention," Gompers declared, "we were insulted and our two demands were rejected. We are here to present our demands and to see that they are not rejected. Here, at the Democratic national convention we are hoping for better results."

"We do not want anything revolutionary that labor demands, and we feel that the Democratic convention may grant our demands with good results all around. Certainly, labor is proud to stand by its rights as well as its powers now, and the laboring man at the coming election will vote the ticket that promises the most to his advantage."

FANATICS TAKE CANADIAN TOWN Pierson, Near Boundary of Manitoba, Seized by Horde of Armed Cranks.

(United Press Leased Wire.) Regina, Can., July 6.—Armed with Winchester rifles, revolvers and knives, a horde of religious fanatics swamped down upon the town of Pierson, near the boundary line of Manitoba and North Dakota, and taking possession of the place, defied interference by the police by pointing their guns at the officers and threatening to kill them. They are still in command of the town.

COAST MEN SILENT AT ANTI-JUNCTION

(United Press Leased Wire.) Denver, July 6.—There will be no effort made by the Pacific coast delegation in favor of the anti-injunction plank labor leaders want to insert in the Democratic platform.

The coast delegations are willing to talk Japanese exclusion, which stands no chance of being seriously considered, but are silent when it comes to what they call a "radical" anti-injunction measure. The majority of California and Washington delegates say there ought to be some change in injunction procedure, but that it should be a conservative change. They are not so much in favor of an anti-injunction plank as they are against any attempt to do away with the power of injunction.

The Washington delegation is out strong for a safe, sane and harmless anti-injunction plank. Thomas J. Casey, of Seattle, secretary of the Bryan volunteers, is here to fight for the anti-injunction plank that labor wants. Casey says Charles G. Helfner, member of the Washington delegation and prominent politician of Seattle, has been working hard for nearly a week against organized labor interests. According to Casey, Helfner has been notifying the delegates that Pacific coast labor does not want a radical anti-injunction plank. Helfner says he isn't working against the plank, but that he and his delegation want a modified measure, one that will not destroy the power of injunction.

The California delegation wants as little to do with an anti-injunction plank that looks too friendly to organized labor. If it is possible to let the anti-injunction matter within the jurisdiction of the California delegation will do so. If it is necessary to tackle it, the members will be for a carefully worded plank which will be several degrees less radical than that in the Nebraska platform.

WILLING TO TALK FOR JAPANESE EXCLUSION BUT ARE SILENT ON PLANK THAT LABOR CONSIDERS VITAL TO ITS INTERESTS.

(United Press Leased Wire.) Denver, July 6.—Representing the National Anti-Trust League, H. B. Martin of New York is here prepared to appear before the resolutions committee to urge that the Democratic platform contain a plank in favor of the enforcement of the present trust laws, and against any amendment which would weaken the present trust laws.

"The anti-trust laws are all right as they are," said Martin today. "By means of these laws the people are kept to fall for contempt. All that is necessary is to enforce the contempt law against trust people, just as it is enforced against labor people when they strike."

"There is a blanket injunction now against the big business interests, the railroads in the middle west. These have been passed on by the supreme court. The only way to get the law to bite Mr. Armour and Mr. Swift with certain railroad magnates and put them into jail."

JOHNSON OUT BUT MANAGER DON'T KNOW IT

(United Press Leased Wire.) Denver, July 6.—Governor Johnson's boom for the presidency has collapsed. It was admitted today in his own camp that there is no hope of his nomination and that his supporters are keeping up the fight only as a matter of principle.

Formal assurances that Johnson will be the nominee are still being issued from his headquarters, but this is for a purpose. The Johnson folks are laying plans for 1912.

Phoebus D. Whipple, assistant manager of his campaign and spokesman for the Minnesota governor, said:

"We know we can't win, but Johnson will be presented to the convention. We started this fight to stay in it to the finish, and all this talk that there is no hope of his nomination and that his supporters are keeping up the fight only as a matter of principle. We are going through with it, even though we recognize the fact that there is no hope of his nomination."

When Bryan is nominated and defeated, as he surely will be, there will be a re-organization of the party with Governor Johnson as the leader."

OAKLAND WANTS NO MORE BOMBS

(Salem Bureau of The Journal.) Oakland, Cal., July 6.—Business men of Oakland today decided to put a ban on the use of fireworks at celebrations hereafter, as the result of the accident Saturday night in which Mrs. Annie Ringling and her little baby were killed and a woman believed to have committed the woman's husband to commit suicide.

Mrs. Ringling was standing near Lake Merritt watching the fireworks. One of the bombs suddenly went wrong, as it left the mouth of the mortar from which she fired, and struck her on the breast, killing mother and child instantly. The little one's arm, which was tightly clasped about his mother's neck, was torn from the baby's body and buried in the woman's breast.

Crazed with grief, the dead woman's husband had believed to have committed suicide. The men who were handling the fireworks are not blamed for the accident.

ONE DEAD, ONE HURT IN AUTO SMASH

(Salem Bureau of The Journal.) Santa Cruz, Cal., July 6.—Mrs. O. Scribner is dead and her son Teddy is in the hospital here with a broken leg today as the result of an automobile accident near Boulder creek last night.

O. Scribner, president of the Associated Oil company of San Francisco; his wife, two sons and Maud and Clara Miller, were in the automobile at the time of the accident. Something went wrong with the steering gear and the big machine crashed into a ledge of rocks.

WEDDING PLANS KEPT SECRET

(Special Dispatch to The Journal.) Paris, July 6.—The official mission that is to repay France at the approaching Quebec tercentenary called for Canada today on the cruiser Leon Gambetta. The party is headed by Admiral Jaureguiberry.

The details of the wedding have been kept secret and it cannot be ascertained where the ceremony will be performed or who will be present at the wedding. The party is expected to leave for England in a few days and may go on their way a married couple.

GOVERNOR PARDONS E. L. REMINGTON

(United Press Leased Wire.) Salem, Or., July 6.—Governor Chamberlain today pardoned E. L. Remington, who had been convicted in Marion county of assault with intent to kill. Remington was sentenced to two years and had served nine months of the sentence. The petition for pardon was signed by 13 of the jurors who convicted Remington and also by the district attorney who prosecuted him.

The pardon is considered just. Remington's home is at Woodburn, near which place the assault was committed. His wife, Mrs. William Remington, was shot.
