FINE AGAINST STEAMBOAT.

Captain Goode Will Have to Pay \$600 for Doing Big Business.

Captain James Goode has been fined \$600 by Collector of Customs J. S. Malcolm because on the Fourth of July his steamer Columbia carried 95 more passengers than the number allowed her by the government of inspectors.

The Columbia operates between Washington street dock and Vancouver, Wash., and on the Fourth business was rushing on the river. The Columbia made several trips. Twice she carried more than her allotted number of passengers according to the custom house inspectors who kept tabs. One time she had 37 more than the allowance and the second time she had 32 more than her limit.

A fine in a case of this character is imposed without a hearing, the report of the custom house inspector being considered sufficient evidence.
