Linna G. Richardson, president of the nurses' association, and Miss Bessie De Voe. They are working to create an interest in the enterprise, which only needs to be known to be commended. At least \$750 must be raised to complete the cottage, but \$1000, sufficient for all needs will no doubt be secured. Nurses are brought much in contact with tubercular patients, and many of them are in consequence affected by tuberculosis. A rest cottage where they may stay and be treated will be a great boon to them. It is hoped that the plan may meet with such support that the government may be made in construction before long.

AND BARBARA'S WORK GRATIFIES GARFIELD

Among the first callers upon James R. Garfield, secretary of the interior department, who arrived from San Francisco this morning, was Governor George E. Chamberlain, who submitted to Mr. Garfield his report as chairman of the Oregon state land board.

The governor's report on the project which has been undertaken by the Deschutes Irrigation & Power company in Crook county under the Carey act was highly gratifying to Mr. Garfield, and to the newspaper men who saw the secretary soon after his arrival. Mr. Chamberlain and the work of the state land board most highly.

Mr. Garfield is staying at the Hotel Portland. He is accompanied by F. H. Newell, director of the reclamation service of the government, which comes under the supervision of Mr. Garfield's office.

Asked if the government was contemplating starting any other irrigation projects in Oregon than the two now in course of construction, the Klamath and the Umatilla projects, Mr. Garfield said that it was not, owing to the fact that no money had been appropriated for such work, and that all the allowances held in reserve for the irrigation schemes would not any more than complete the two projects.

ROCK PILE IS GOOD INVESTMENT

Yielding a profit of approximately \$5,000 per month to the county, the rockpile at Kelly's butte is now paying for itself every fourth month. These results are shown in figures of the output of the rockpile for the last few months, computing the price of the crushed rock as 15 cents per cubic yard. In other words, the rock that is being put on the county roads, if purchased at the market price would cost upwards of \$60,000 per year.

AINSWORTH BUYS QUARTER ON GRAND

It is located in a district almost wholly built up and is one of the best remaining vacant corners on the east side's principal retail thoroughfare.

Missouri's Reform Governor Stands High With Democrats at Denver.

(Special Dispatch to The Journal.) Denver, July 2.—Joseph W. Folk, Missouri's famous governor, is persistently mentioned today as the Democrat's probable choice for second place on the ticket. It is of course conceded that the vice-presidential nomination will go to Gray if he will accept, but many believe that under no circumstances will he consent. Assuming that Gray declines, the Missouri delegation would be the unanimous choice of the convention. It is urged in his behalf that his nomination would contribute greatly to the success of the ticket, as it would emphasize the appeal to the reform elements.

OREGON MAN HAS A PLANK

Convention Hall, Denver, July 2.—R. D. Inman, Oregon member of the subcommittee of the resolutions committee, who has been a constant attendant at the sessions since Tuesday afternoon at 8 o'clock, said today: "The platform will be satisfactory to progressive Democrats as well as the honest business interests of the country. All elements of the party have been given a respectful hearing, followed by deliberation and earnest thought, so that no one will appeal to party faith such as will appeal to men who love good government and want to bring it back to the control of the people."

Denver, Colo., July 2.—The New York delegation in caucus this morning unanimously decided to support Bryan on the first ballot. The Connecticut delegation held a caucus and decided that John Walsh of Norwich, should present the name of Archibald McNeil for vice-president. The delegation also adopted the unit rule on the vice-presidency and decided against a second choice, adopting a resolution pledging the delegation to "vote for McNeil until nominated."

Davey, who also claimed the dog, and yesterday Judge Cleveland in the circuit court decided that Wagner must return the dog or "pungle up" \$50, the estimated value of the animal, plus \$5 damages and the costs.

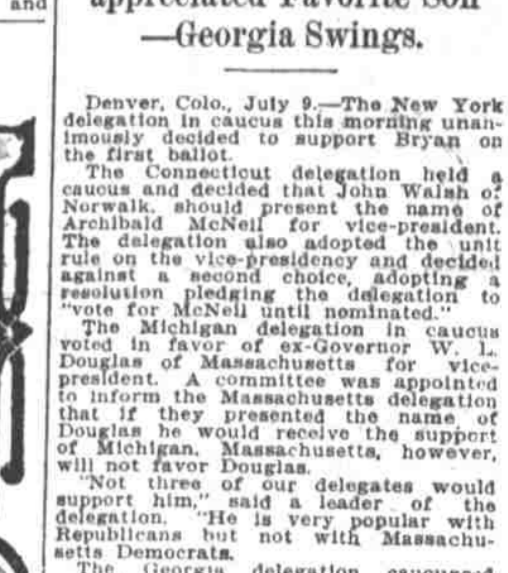

TO TAKE EVIDENCE IN IRRIGATION CASE

(Salem Bureau of The Journal.) Salem, July 2.—Attorney-General Crawford and Judge H. H. Northrup left Salem yesterday for Laidlaw to take evidence in the Columbia Southern Irrigation case. The Columbia Southern directors are being used in the United States circuit court by the state of Oregon for the return of a large tract of land in Crook county which was allotted to them under certain specifications by which settlers were to be allowed to take up the land and pay the company so much for the use of the water for irrigation. It is alleged that the irrigation company violated its agreements with the state and must forfeit its title.



Philo Holbrook Sr., who passed away yesterday, first came to Portland in 1859. Reared in Connecticut and compelled to make his own way from the age of 12, he worked for a time on a farm, then in the coasting trade, and then as a miner. Two years after his arrival here he went to Idaho on foot to work in the mines. For 16 years, from 1862 to 1872, he was employed on steamboats on the Snake and upper Columbia. Returning to Portland he purchased several hundred acres of land on William's slough and engaged in stockraising.

The only office he ever held was that of county commissioner. In 1878 he was elected for 2 1/2 years. In 1892 he was chosen for four years and in 1898 was reelected, serving until 1900. He was of sturdy mold and showed capacity and decision as a servant of the public.

Mr. Holbrook leaves a widow, three sons and two daughters. The widow before her marriage in 1872 was Hannah Wilson, daughter of another pioneer, Samuel Wilson. The children are Philo Holbrook Jr., county surveyor; Millard C. Holbrook, Samuel Holbrook, Helen Holbrook and Emily H. Holbrook. The last named is traveling in Europe.

Funeral services will be held at the Holbrook residence, 211 Fourteenth street, at 10:30 o'clock tomorrow morning. They will be conducted by Rev. J. R. Wilbur. Interment will be in Greenwood cemetery.
