

WHAT PLATFORM HAS FOR COAST

Utterances on Asiatic Exclusion and Navy Beat Nothing—Perhaps.

(United Press Leased Wire.) Denver, July 10.—On the theory that half a loaf is better than none, it may be said that the Pacific coast received some benefits worth noticing from the Democratic convention.

The platform planks wanted by the coast were plain, shaved and whittled until they were nice, smooth planks on which any one may stand without danger of splinters. They are by no means planks with the bark on, but the coast may find satisfaction in the fact that they are better than none.

The original draft of the platform contained several paragraphs relating to the exclusion of Asiatic laborers. These were cut out before the platform was sent to the convention. As adopted by the convention the platform contained this reference to the Asiatic problem:

"We are opposed to the admission of Asiatic emigrants who cannot be assimilated with our population, or whose presence among us would raise a race issue and involve us in diplomatic controversies with oriental powers."

The attitude of the Democratic party leaders was one of trying to please the Pacific coast and at the same time not do anything offensive to Japan. They contended that the nikudo's government would regard any decisive statement against the Japanese as an open insult. They were willing from the first to adopt a conservative plank, but not the radical one, which particularly specified the Japanese, which the coast wanted.

No Aid to Coast Defense.

Coast defense doesn't get any help. There was an attempt to incorporate a coast defense plank in the platform, but it was not successful. The navy plank says:

"We hold that the constitutional provision that a navy shall be provided and maintained means an adequate navy, and we believe that the interests of this country would best be served by having a navy adequate to defend the coasts of this country."

The drafting of this plank hinged upon whether the words "greater navy" or "adequate navy" should be used. Bryan declared for the latter term and cautioned the platform makers not to endorse a "large navy." This plank also is in the nature of a compromise. The Democratic party says there should be a navy "adequate to protect our coasts, but not a 'large' navy."

A strong attempt was made to advocate leaving the ships now in the Pacific in western waters, but nothing was left of this plank except the recommendation that the navy be made adequate to protect our coasts.

Despite the lack of radical anti-Japanese and coast defense measures, the Pacific coast—by comparing the Democratic procedure with that of the Republican party—has not fared badly, even though the planks were trimmed so as to fit snugly into a platform that may not annoy any one with rough edges.

Banking: Two Thirds Rule.

The very last plank to be adopted by the committee was that dealing with trusts and monopolies. The declaration on banks, which includes emergency currency, the emergency bank deposits, and a postal savings bank system, was also the subject of lengthy debate, and was next to the last plank to be agreed upon.

A proposition offered by Governor Noel of Mississippi that thereafter a majority of two-thirds of the members of the committee on any candidate for president or vice-president in the national Democratic convention, in lieu of the two-thirds rule now existing, had been defeated by a rising vote.

Anti-Polygamy Shut Out.

The most interesting incident, however, in the closing hours of the session of the committee was the refusal to put into the platform a declaration in condemnation of polygamy, offered by former Senator Fred P. Dubois of Idaho. In its support Dubois had made an impressive speech. The opposition, no less earnest, were the remarks of former Congressman King, the member from Utah. The proposed plank was defeated by a vote of 29 yeas to 12 nays.

Senator Dubois attributes his defeat directly to the influence of Bryan, who, he claims, personally directed his representatives on the committee to exclude all reference to the polygamy question from the platform.

Charles Bryan, the brother of the nominee for the presidency, heard during the day that Dubois was making these assertions and telegraphed to Lincoln for information. In reply he received the following telegram from W. J. Bryan:

"I have not taken any part or expressed any opinion on the subject referred to in your telegram. There are several states especially interested in that subject, and I think they should all be permitted to present their views, and that the committee's deliberations should then decide the question according to its judgment. It will not be influenced one way or another by me."

Bryan's Will Was the Guide.

This was the only fight in the resolutions committee that was at all close.

All through the deliberations of the platform committee disputed questions were settled by the final statement, "Mr. Bryan wants it this way." There was a lively debate over the tariff plank, which was settled by a long distance telephone message to the Nebraska.

The members of the general resolutions committee who were not on the platform committee that actually drafted the platform were not so docile as the subcommittee had expected when they told the convention delegates that they would have the platform ready for a 7 o'clock session. There were a dozen men who had something to say on nearly every plank, and they said it. Plank after plank was sent back for revision. Several were changed, whole paragraphs left out or sentences injected. There were two factions, which contributed to the delay. The conservatives were greater in the minority. The general committee changes were for the most part on the side of radicalism.

DUNN'S SPEECH FOR W. J. BRYAN

Places Nebraskan in Nomination in Eulogistic Address on Candidate.

Denver, July 10.—Dunn's speech, placing Bryan in nomination, follows: Crises arise in the life of nations which endanger their institutions and, at times, imperil the advance of civilization.

Every people that has left its impress upon history has faced such crises. In most instances, where grave dangers have threatened the safety of the state, some great character, some master mind has been found, produced as it were by the conditions themselves, with capacity to direct aright the energies of the people.

This was true of the ancient world; it has been true of the modern world; it is true of this republic. We have such a crisis to meet today. The favor-seeking corporations have gradually strengthened their hold upon the government until they now menace popular institutions.

The question is, whether this government shall be restored to the control of the people and be administered in the interest of all, or whether it shall remain an instrument in the hands of the few, for the benefit of the many.

In his special message to congress last winter President Roosevelt declared, substantially, that certain wealthy men who have become enormously rich by oppressing the wage-earner, depriving the public and practicing all forms of iniquity, have banded together, and by the unlimited use of money, endeavored to secure freedom from restraint and to overthrow and discredit all who honestly administer the law.

That the methods by which these men have acquired their great fortunes can only be justified by a system of morality that would permit every form of criminality, every form of violence, corruption and fraud.

For many years, and especially during the last 12 years, these very men have been in control of the Republican party; they have financed every campaign of that party for a quarter of a century.

These exploiters of the people, whom the president has so scathingly denounced, have even the enthusiastic support to the Republican candidates and policies. They laid their hands upon the trust funds of insurance companies and other corporations and turned the plunder over to the Republican committee. The money thus secured by the innocent and helpless to purchase Republican victory, has not been repaid.

And where do we find these men today? Where are the "swollen fortunes" of which we have heard so much? Just where we would expect to find them—supporting the Republican ticket and furnishing the means of war for the Republican delegation.

The reform adopted by the late-convention shows what the Republican party in truth represents. Although controlled by the friends of Roosevelt and Taft, in framing the platform every genuine reform which Roosevelt has advocated was scrupulously guarded beneath the iron heel of the predatory masters of the Republican party. The Wisconsin delegation, which favored placing a few reform planks in the platform was denounced with sneers as being Socialistic and Democratic, and the convention by a vote of 8 to 1, repudiated the reforms that the present administration claims to favor.

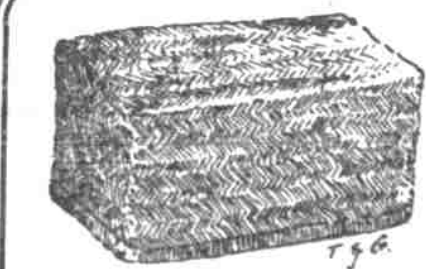
