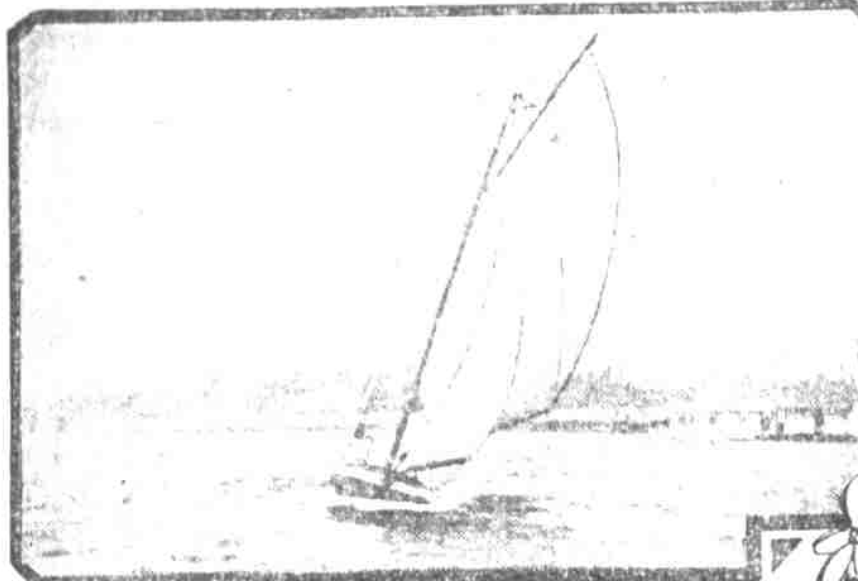

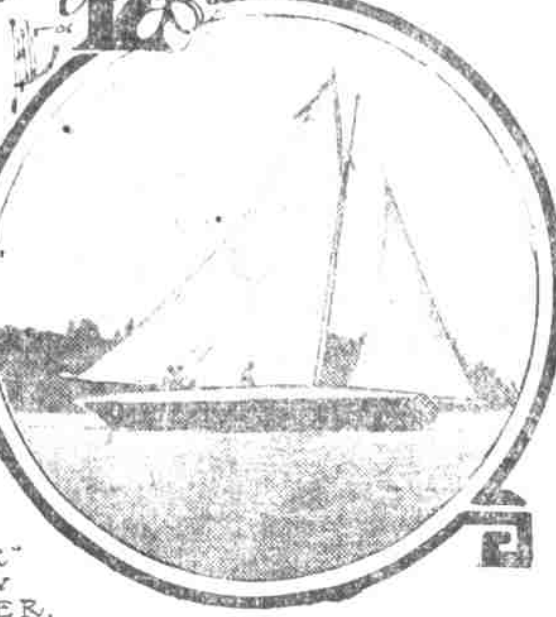


CRACK OARSMEN ROW AT ASTORIA
