THE DAILY MENU.

BREAKFAST. Stewed plums. Chopped beef cakes with poached eggs. Whole wheat bread with coffee.

LUNCHEON. Scalloped salmon. Fried egg plant. Sliced pineapple. Small cakes.

DINNER. Souffle Julienne. Baked stuffed tomatoes. Sweet potatoes. Cucumber salad. Blackberry roll with cream. Sunshine cake. Black coffee.

Stuffed tomatoes—Select large firm tomatoes and wash but do not pare them. The stem portion should be sliced off and the tomato cut out with a spoon, leaving a cup-formed tomato case. The stuffing may be of seasoned breadcrumbs, mixed with butter, and if liked, one or two persons prefer equal portions of finely-minced ham and seasoned breadcrumbs mixed with a yolk of egg and a dash of onion or onion juice. With this the yolk of egg should also be mixed. After the tomatoes have been filled, using the stuffing, cover with crumbs or a spoonful of the pulp of tomatoes laid on. How long these will require to bake brown will depend somewhat on the size of the tomatoes. In a brisk oven over a large tomato will require to be baked for 15, 20 or 25 minutes. There are many kinds of cold meat may be utilized in the stuffing.
