

# FIRST PRIMARY ALLIANCE MEANS IN WASHINGTON WORLD'S PEACE

### No Complications in Senatorial Contest—Local Option Main Issue.

(Special Dispatch to the Journal.)  
Seattle, Wash., Sept. 4.—One of the most interesting and exciting political campaigns in the history of the state of Washington will virtually come to an end next Tuesday with the general primary. As Washington is Republican by a large majority the nomination of the Republican candidates for office is regarded as equivalent to election.  
The direct primary next week will be the first ever held in this state. It will include every office—state, county, judicial and congressional—everything from United States senator and governor down to the county commissioners and constables of the justice courts.  
Practically all of the candidates for the legislature have pledged to vote for the man receiving the highest number of votes for United States senator. Advocates of the direct primary are much pleased with these pledges. It was predicted by the old machine politicians, and many who opposed the law, that scores of candidates would refuse to give the pledge, on the ground that the season of Oregon would show the people it was wrong. However, this belief has not been held by the candidates, and as there is no possible chance of the Oregon situation being repeated in this state, the successor to Senator Levi Ankeny will be named by the legislature in obedience to the will of the people as expressed by their votes next Tuesday.

### Five for Senator.

There are three Republican aspirants for the senatorship, the present incumbent Levi Ankeny, Congressman Wesley L. Jones of North Yakima and Judge William H. Snell of Tacoma. Ankeny is a wealthy banker and owner of farm lands, living at Walla Walla. Congressman Jones is a lawyer and a comparatively poor man, having little beyond his salary. Ankeny and Jones are regarded as the two leading candidates, with many astute politicians predicting the overthrow of Ankeny and the election of Jones. The candidacy of Judge Snell was an unexpected factor in the race and though it has complicated the situation it is not expected to affect the result materially.  
George F. Collier and M. M. Godman, both of Seattle, are the candidates of the Democratic party for the senatorship.

### Eight for Governor.

The Republican race for the governorship is the most interesting contest to be decided at the primary. There are eight Republican candidates, the present governor, A. E. Mead, former Governor Henry McBride, Attorney-General John D. Atkinson, Samuel G. Cosgrove, a popular member of the legislature, Colonel W. M. Ridpath of Spokane, who is counting on the support of the war veterans, Joseph W. Robinson of Olympia, Robert B. Brown of Seattle, and Oscar H. Neal of Bellingham.  
Governor Mead's administration has been free from scandal and is generally regarded as satisfactory. His most formidable opponent is former Governor McBride, who is well liked by the business interests of the state. These two are regarded as the leaders in the race.  
On the Democratic list of candidates for the governorship are John Pattison of Colfax, A. J. Spahn of North Yakima, Patrick S. Byrne of Spokane, William Blackman of Seattle, and "Jimmie" Durkin, a saloonkeeper of Spokane and a picturesque figure in the politics of that city.  
For secretary of state, treasurer, attorney-general and several minor state officers, the Democrats have failed to make nominations. On the Republican side there are two or more candidates for nearly every place on the ticket.

### The Would-be Congressmen.

The congressional situation also is interesting. This is the first year that the state has been divided into districts. W. E. Humphrey in the Seattle district is a candidate for the nomination and will go back, as his record is generally satisfactory. Francis W. Cushman, in the Tacoma district, also is assured of renomination and reelection. The third district is the real battleground. There are seven Republican candidates in this district, four from Spokane and three from the other districts. The Democrats have united upon a single candidate.

### Issues Are Scarce.

Outside of local option there is scarcely an issue in the campaign, unless be an amendment to the railroad commission law, giving greater power to that body. The declarations of the Republican and Democratic state conventions on the liquor question are going to arouse much interest, but the real fight will come in the legislature, when the Republicans will introduce a local option bill and the Democrats a bill for a constitutional amendment for prohibition. It is believed that the anti-liquor element will control the legislature by a big majority, and local option will probably win.

## ABE HUMMEL AS EXECUTOR

### Also a Beneficiary Under the Will of the Late Tony Pastor.

New York, Sept. 4.—Abe Hummel, the disbarred attorney, has been named as executor of the estate of the late Tony Pastor. Hummel is also a beneficiary under the will. His sister, Bertha Hummel, is appointed co-administrator.  
Hummel is now in Paris, after serving a term on Blackwell's island for perjury.  
Pastor leaves behind him a gold watch and a diamond studded pin. Most of the property is left by the deceased to his widow, in the event of her not surviving him. Pastor directed that the property should be divided among the heirs, after \$10,000 was given to the actors' fund.

### Otis in for an Operation.

## Governor of Victoria Rises Higher Yet Than "White Supremacy" Plane.

Melbourne, Sept. 4.—The farewell banquet given by Melbourne to the officers of the Atlantic fleet this evening was a love feast. It was expressive of the strong sentiment of "hands across the sea," with the hands clasped in the warmest grip of friendship and the promise of continued close relations.  
Sir Thomas Carmichael, governor of Victoria, in a splendid address to the departing visitors, expressed the pleasure the visit of the fleet had brought to Melbourne and all Australia. He said he considered it more than a mere passing call or formal attention on the part of one government to another. He voiced his conviction that the incident is prophetic of the alliance of the white nations of the world.

This visit of the American fleet to Australia, said Sir Thomas in conclusion, will lead to more than the assembly of the white race in the Pacific; it is leading to the formation of a great Anglo-American alliance which will be continued to the establishment of peace throughout the world.  
Admiral Sperry responded in a strong speech of appreciation of the people and friendliness of the people of Melbourne and assured the hosts that the feeling of mutual interest and good will was equally strong in the United States. There were many exchanges of compliments and toasts, making the banquet an appropriate final feature of the great reception at this port.

The fleet will steam out of the harbor at 8 o'clock tomorrow (Saturday) morning and start on the cruise of 1,350 miles across the great Australian bight to Albany, which is on King George's sound in the southwest section of Australia.  
The stay here has been marred by three accidents, in which two Americans were killed and one severely hurt by railway trains. Michael Michaelson, a member of the band of the Vermont, was run over and killed instantly last night. Arthur Decker, a seaman from the New Jersey, lost his life while trying to get out of the way of a train which ran him down. Charles Ballman, a carpenter's apprentice of the Minnesota, fell from the steps of a coach and the wheels passed over his legs, crushing them. These accidents were all pronounced unavoidable and no one is held responsible.  
The citizens are preparing to arise early and give the ships farewell cheers as they steam out to sea tomorrow morning.  
The boys had probably the best time here of the entire cruise. They had become accustomed to the ways of the Australians at Sydney and they got acquainted quickly here.  
The fleet is due to arrive at Albany September 11.

## SCREAM BRINGS BURGLAR'S BLOW

### Mrs. W. C. Vincent of Baker City Badly Wounded in Spokane Hotel.

Spokane, Wash., Sept. 4.—A ray of light flashed from a burglar's lantern, penetrating the darkness, struck fairly in the face of Mrs. W. C. Vincent of Baker City, Or., wife of a widely-known banker, as she lay asleep in her bed in room 232 in the Spokane Hotel yesterday morning. With a scream of terror the woman sat up, her eyes centered on the dark form behind the light which had blinded her for the moment. Before she could make another outcry she was struck down by a blow from the thief, who quickly ran to a rear window and made his escape down a ladder which had been placed against the window. The woman was badly injured. The gash over her eye was over two inches long and it was necessary to take a number of stitches in the wound. The thief got no valuables.

## INDICTED FOR EMBEZZLING BONDS

San Francisco, Sept. 4.—John J. Lynch and C. E. Rankin were jointly indicted late yesterday by the grand jury on a charge of embezzling \$40,000 worth of bonds of the Ocean Shore Railway company.  
The alleged felony was in connection with a deal in which Lynch received the bonds as security for a \$10,000 loan. It was charged that he had hypothecated the securities. Rankin admits that he purchased \$10,000 worth of the bonds, but declares he was innocent of any fraudulent intent in the transaction by which they came into Lynch's hands.

## SCHWAB TO LOCATE AT BETHLEHEM WORKS

New York, Sept. 4.—It became known today that Charles M. Schwab, M. C. king, will remove his offices from this city and take up quarters near the plant at Bethlehem, Pa., in order to devote all his time to the company's affairs. For many weeks he has been required to spend at least half of his time there, his private car Loreto making three and four trips a week. While at Bethlehem Schwab has usually lived in the city. Now he is negotiating for a residence at Bethlehem upon which he can secure a year's lease. The Bethlehem Steel company, of which he is president, has spent nearly \$15,000,000 in enlarging its plant within the last year.

## J. PIERPONT NO ANGEL FOR MAXINE

The report that the new playhouse, which will open in December, is to be backed by Morgan, that in other words he is to be its "angel," was positively denied by Miss Elliott.

# MAN'S HEAD IN 12,000 ACRES A WATER PAIL TO BE WATERED

### Horrifying Discovery Made by Mrs. W. G. Alexander at Reno, Nevada.

Reno, Nev., Sept. 4.—The morgue officials are today working with the police in an effort to unravel what is thought to be a gruesome murder mystery revealed in a startling manner yesterday by Mrs. W. G. Alexander. The woman lowered a bucket for water into the old Moor ditch, which runs through the heart of the fashionable residence district of the city, and when she started to raise the receptacle it contained the head of a man. She had not noticed the dead body floating down the ditch.  
The police believe the dead man was a victim of foul play, as the body showed signs of violence, and are investigating on this theory.

### Huge Cooperative Project Is Planned by Josephine County People.

(Special Dispatch to the Journal.)  
Grants Pass, Or., Sept. 4.—Arrangements and plans for the building of a huge irrigating canal, which will take its water from Rogue river, just above the Golden Drift Mining company's dam, and water over 12,000 acres of arid lands above and below Grants Pass, have been made, and construction work will soon begin. Tired of waiting for outside capital to become interested in the project, and upon the government for aid, local business men, ranchers and fruit-growers, have decided to build the big canal themselves. To this end a cooperative ditch company is being organized, the shareholders of which will be the water users themselves. Those who cannot buy shares with cash, can

do so in labor, and in this manner the canal will be constructed.  
The biggest feature of the irrigating project—a dam across Rogue river—is already established. The dam of the Golden Drift Mining company, at the Dry Diggins, three miles above Grants Pass, will be employed. A committee called upon C. G. Ament and G. W. Ament the managers of the Golden

Drift company yesterday, and interviewed them regarding the proposition of securing water from the dam for the irrigating canal. The Ament brothers are heartily in favor of the enterprise and will give every possible assistance in the construction of the canal. In order to secure government aid at a later date, it is necessary to or-

ganize an irrigating district, but as this has to be taken through the courts and will require at least two years, the organization of such a district will be left till after the construction of the canal.
