Fisherman Arrested at Astoria—Held Pending Decision.

Master Fish Warden H. C. McAllister of Oregon was informed last night by telephone from one of his deputies at Astoria that the justice at that place refused to try 18 fishermen arrested by the deputies on the river Thursday afternoon on the ground that the law does not say that it is illegal to fish on that day.

The law reads "from and after September 10." The justice construed this to mean after midnight September 10. Warden McAllister construes the law to mean after 10 o'clock noon on that day, as under the old law that was the time for the expiration of the open season.

The prosecution of the men arrested will be held in abeyance until the action of the justice at Astoria has rendered an opinion on the statute.

SHIP SUNK IN TROPICAL STORM

Grand Turk, N. W. I., Sept. 12.—It is estimated today that between 30 and 40 lives were lost in the hurricane which raged here all last night and early today, devastating most of the town. The streets are blocked with wreckage. Many houses were destroyed. The wind is still high, but the worst of the storm has passed.

The Haytian sloop Telegraph, which had sought shelter at the New York bay, foundered during the night, going down with all hands.

The schooner Lon Leon broke her anchor during the storm and was swept out to sea. Noaking has been heard of her. It is believed that many of the crew must have been lost in the storm.

AGED INDIAN CHIEF REVEALS STORY OF COLD-BLOODED MURDER

Klamath Falls, Or., Sept. 12.—The white man murdered on the Klamath Indian reservation August 26 is found to be Sid O. Jacobs, a horse buyer from Alturas. Willie Barclay, a half-breed Indian, has been arrested by the sheriff of the county and will be brought here for trial tomorrow.

It seems that Little John, an Indian 60 years old, an uncle of Barclay, knew of the crime and helped Barclay to get away. It was placed in a cleft of rocks on top of Yainax Butte and covered with rocks and sticks. Little John could not keep the secret, and finally told the reservation farmer. After a long search the body was found. There were three pistol wounds in the man's back, and the throat was cut. It is supposed that the body was found about two miles from the agency school at Yainax. No one has been named as having been in his first years, but it would be interesting to know if from Alturas with Barclay.

Sherriff Barnes has gone to Alturas to bring Barclay here for trial.

NEWLY DISCOVERED FISH BANKS AT YAQUINA SWARM WITH HALIBUT
