

# ROYAL HONOR FOR ATHLETIC HEROES

## TWO GOVERNORS AND NOBILITY IN PARADE

With the governors of two states and the officers of the Italian washup, real European nobility, in the parade in honor of the three famous Oregon athletes, Smithson, Gilbert and Kelly, the affair takes on a great deal more than local prominence. That the Italian officers should take a prominent part seems fitting, for it was one of their countrymen who made such a memorable run in the famous Marathon race at London last July.

Governor Mead and party of Washington are scheduled to arrive in Portland today for a conference with Governor Chamberlain, and C. F. Berg, on behalf of the entertainment committee, has prevailed upon Oregon's governor to invite the distinguished visitors to participate in the festivities. It is hoped that the Washington officials will see their way clear to accept the invitation of the Portland party and remain over for the procession tomorrow night.

Energetic work upon the part of Mr. Berg's committee, which has in charge the parade features, will probably result in one of the greatest parades ever staged in years in Portland. Decorating by the business houses began yesterday and the time added by the delay in the arrival of the athletes has given an opportunity for some elaborate dressing. Flags, bunting and multi-colored lights are playing a large part in the color scheme for the procession tomorrow night. Most of the prominent buildings were suffused with decorations yesterday.

It is planned to make the reception on Multnomah field a notable display. The field will be lighted by two monster bonfires and a liberal amount of red fire. When the procession reaches the field it is distributed about the speaking stand, the athletes will be brought in as a grand climax. Governor Chamberlain and possibly Governor Mead will make speeches as also will Mayor Lamb. The loving cups will then be presented to the athletes as gifts from the people of Portland. After this presentation the athletes and spectators will retire to the gymnasium of the Multnomah club, where the citizens will be introduced to the athletes, the dignitaries from the

# Asks for Information WILBURTON?

**WHAT IS IT?**  
It is a tract of land just platted into 210 lots of 50x100 and 75x100 feet.

Cement sidewalks will be laid 6 feet wide, the inner edge will be two feet from lot line, with a park strip 8 feet wide between the outer edge of the walk and the curb. 100 feet streets will be improved as follows: cement walk 6 feet wide, the inner edge being 5 feet from lot line and a park strip 9 feet wide between the outer edge of the walk and the curb, leaving a 60-foot drive way between curbs.

# BRYAN MAKES WAR ON TAFT POLICIES

Cumberland, Md., Sept. 12.—Convinced that he has made inroads into the strength of Judge Taft in Indiana, Illinois, Ohio, West Virginia and Maryland, William J. Bryan left here tonight for Deer Park where he will spend Sunday and confer with the party leaders of West Virginia and Maryland. Bryan made two speeches here today and in each of them he charged Taft with refusing to play fair with the voters and with attempting to amend the Chicago platform.

The Democratic candidate tonight elaborated his denial of the allegation of Congressman Hearst, that he had impudently lashed to the support of Hearst for the presidency this fall, he (Bryan) in return promising to support Hearst in 1912. Mr. Bryan said:

"The statement of Mr. Hearst is absolutely false in every particular. I met him at his house and also at the house of Dr. John W. Cox some time last fall or winter, but at neither place nor anywhere else was there any conversation that could by any possibility, be distorted into such a proposition."

Mr. Bryan held half a dozen receptions and found time to confer with the party leaders of this section of Maryland. He was informed that the only point of danger is in Baltimore.

The first week of the invasion of the east has been encouraging to the Democratic candidate. His speech tonight was the thirty-first since he left Lincoln a week ago and in that time he has traversed Nebraska, Iowa, Illinois, Indiana, West Virginia and part of Maryland. Beginning at Baltimore and Annapolis on Monday he will go on into New Jersey, New York and New England and then into Ohio.

**Sure of Middle West.**  
Tonight Bryan is certain in his own mind that the electoral vote of Kansas, Nebraska, Iowa, Illinois and Indiana and West Virginia, Maryland and Delaware has been won over to him. He will now fight for New York, Ohio, Minnesota and Wisconsin and he entertains a faith for Michigan.

The suggestion that state issues be ignored in Ohio, as made by the Republican editors there, pleased Bryan as he regards it as a confession that the state situation is unsatisfactory.

The support of labor leaders like Compton and other heads of the Federation of Labor pleased and encouraged the Nebraska candidate and every report so far received by the national committee and transmitted to Bryan is a better one than the one that preceded it.

Both of Bryan's meetings here were enthusiastic. The attendance was large and there was the usual enthusiasm, especially when Bryan assailed what he termed "Mr. Taft's evasive policy."

The feature of the night speech here was a defense of the labor plank of the Democratic platform. Bryan declared that Judge Taft had been fit to uphold the law which permits the summary punishment of labor leaders in contempt proceedings and this, he declared, was not only unjust but robbed the defendants of needed rights.

The proposition that a prosecuting official could have legislative, judicial and peremptory punishing power, he ridiculed as a leaning toward tyranny and declared so far as he was concerned he could see no reason why the Democratic platform along this line should not meet the approval of all fair-minded men.

Bryan will tomorrow deliver his lecture on the "Prince of Peace" in the church at Deer Park. He will reach Baltimore at 7:30 o'clock Monday morning.

# BIG STICK AWES HUGHES OPPONENTS, SAY POLITICIANS

(United Press Landed Wire.) Saratoga, N. Y., Sept. 12.—"They have the delegates to beat Hughes, but they have not got the nerve," is the way close observers here spoke of the Republican convention situation tonight, while in the big United States hotel.

Even after a meeting of the state committee tonight not one word would be said by the opposition to Hughes say as to their plans.

"I give him just 55 delegates," said Delegate William Barnes of Albany. "That is not enough, but I will not discuss the matter. I will say, though, that the fight has just begun."

"Will you issue any statement as to your stand on Hughes?" was asked State Chairman Woodruff after the committee had ended its session of but a few minutes.

"Not a word," was the reply. "It will be Hughes on the first ballot, or it will not be Hughes at all. It is the statement that is common."

# SOLDIER NOVELIST COMPLETES DETAIL

Milwaukee, Wis., Sept. 12.—General Charles King's four-year detail with the Wisconsin National Guard ended today. It may be his last day in connection with the guard which he has served so long, as the soldier and novelist reaches the age limit, the twelfth of next month.

Taking hold on the militia when it was in chaotic state, he molded it into a military organization. King was a veteran of two wars and scores of Indian fights, born of a military family and trained at the United States military academy, he had done more for the Wisconsin guard than any other person.
