

PROCESSION GEARIN TO BOULDER \$ \$ ROBBED OF LEAD RALLY TO HELP WIFE ALL GLORY FOR TAFT

Former United States Senator Will Preside at Democratic Meeting When Senator Gore of Oklahoma Speaks.

Ex-United States Senator John M. Gearin has been chosen as the chairman of the evening for the big Democratic rally to be held September 25, at which Senator Thomas P. Gore, the blind orator from Oklahoma, will be the principal speaker. The rally will be held in the armory if that auditorium can be secured, if not in one of the other larger auditoriums of the city.

Owing to the possibility of one of the regular drills being scheduled for that night at the armory there is some doubt about securing the place for the rally but the county committee having the arrangement in charge hopes to be able to secure the big hall for the rally meeting.

Senator Gore is one of the noted figures of the nation. He has risen to power and place in Oklahoma, though totally blind, and in high esteem not only by his fellow citizens and townsmen of his home state, but by the representatives of congress with whom he is associated. As an orator he holds high rank among the speakers of the nation, and the Democratic managers here are looking forward to his appearance in the city as one of the important events of the presidential campaign.

Work at the Democratic headquarters is progressing steadily and the state and county chairmen are optimistic regarding the result of the Oregon vote in November. For the past two weeks Bryan and Kern Democratic clubs have been in process of formation throughout the state, and it is expected that by the time the state convention is held in the state which does not have one of these organizations to work in harmony with the state committee in carrying forward the work of the campaign.

State Chairman Sweek is much encouraged by the reports that are coming to the headquarters from all parts of the state, and is growing more and more confident day by day that Bryan will be given the majority of the votes in Oregon on the first Tuesday following the first Monday in November.

KANSAS WHITES CHASE BLACKS

Deputy Sheriff Holds Off Mob and Compels 25 to Act as Deputies.

Brookshire, Texas, Sept. 12.—A negro named Newton, implicated with his brother in the killing of a white farmer, John Buchton, was taken from the jail this evening and hanged to a telegraph pole.

Seneca, Kan., Sept. 12.—A clash between whites and blacks is feared here following an attack on Samuel Murphy, a farmer, by two negroes, Jim and Allice Johnson, Friday night. Murphy was assaulted by a white boy who taunted them about a horse race they had lost, and Murphy intervened in their quarrel. He was stabbed and kicked into insensibility by the negroes in sight of his wife and six children.

A mob quickly gathered and overtook the negroes, and armed with ropes were bent on a lynching, which was only prevented by the quick arrival of a deputy sheriff, who, gun in hand, stood in the door of a vacant house in which the fugitives were, and held the mob at bay, compelling 25 members to act as special deputies and protect the negroes until other officers arrived.

The prisoners are in the county jail.

BOOTH METHOD RAISES DOUBT

Bankers Study Frenzied Finance Which Had Fish for Basis.

Chicago, Sept. 12.—Evidence of the methods employed to promote the finance of "A. Booth & Co.," the firm which practically controlled the American fish market until it went into a receiver's hands, is being collected by banks for future use. Many rumors are circulated as to representations made by persons interested in disposing of the concern's paper. Creditors declare that banks that advanced large sums on collateral supposed to be worth 100 cents on the dollar now find the paper to be worth considerably less.

The assets of the company are said to be \$5,000,000. Liabilities approximate nearly \$12,000,000. The loss will fall on Chicago banks. Booth, former president and chairman of the board of directors, is on the verge of nervous prostration. A year ago he relinquished the office of president and although W. Vernon Booth was at the head of the firm, the latter's earlier alleged irregularities are believed to have crept into its affairs. He is not named by the banks. They expect to file the responsibility on Booth.

The report of the company's officials shows \$1,500,000 cash on hand. The banks expect to receive \$1,000,000 as far as they can be holding these funds. At a meeting of the committee of creditors today various reasons for the failure of the firm were assigned. One holder of many thousands of dollars worth of collateral thought W. Vernon Booth's devotion to golfing and society left the company in the hands of men who could not manage its affairs. Another believed the firm attempted the impossible when it tried to establish a monopoly on the entire fish market. Stock promoters who large profits were given as the cause by another. A majority agreed that all of the causes mentioned contributed a part. Experts mentioned the failure of the company as poor judgment in buying fish for the market. Additional proceedings are expected next week.

Senator Jonathan Bourne is going to spend some of his good money—he alone knows how much—to aid in securing the "usual Republican majority" for Taft in Oregon, but the senator is not going to hand the coin over to the state central committee, or give it into the management of the finance committee of that organization.

He is going to handle the affairs of political warfare himself, personally, and put it where his experience and his discretion tells him it will do the most good. Senator Bourne is not concerned over the honor or his credit which will come either to himself, to Senator Fulton, or to the state central committee as a result of the work done during the campaign, for he knows that there will be a "disinterested person" on the field here in Oregon who will view with a calm and dispassionate eye the work done by Senator Bourne, by Senator Fulton and by the officials of the Republican organization. He also knows and believes, that this political monitor will bear back to Mr. Taft a true and unbiased report of what has been done during the campaign and by whom done and that as a result of this report all honor will be given by Mr. Taft to him to whom honor is due.

Effort Through Clubs. It is said that Senator Bourne has decided to cast the greater part of his effort in the work of organizing the state for Taft through the medium of a state league of Taft clubs made up of senators and district clubs in every part of the state. This is the work which is now under the direct organizing work of John C. Young, secretary to Mr. Bourne. Into this work the senator will put his own money and he will leave the presidential candidate to judge whether he has done the best work possible for him to do in the campaign.

It is also understood that there is to be a disinterested man sent to Oregon by Mr. Taft to watch the course of the campaign and to judge of the work that is being done here. Mr. Taft and the national committee recognize no factions in the Republican party of Oregon, so it is said, and do not care whether the work done for him is done through the efforts of Senator Fulton and his friends, or Senator Bourne and his adherents, or the state central committee and the party machinery, or by whom so long as it is done, and is effective. This Taft agent, so it is said, will remain in Oregon during the campaign and will carry his report back to Mr. Taft following its close.

Fulton Chilled Again. Some doubt is cast by this condition of affairs on the probability of any serious effort being made by the Fulton people to capture the control of the state convention of Taft clubs scheduled for Tuesday. The organization of these clubs has been undertaken by John C. Young, the state convention will come together by virtue of his call, and it is safe to presume that the credit for work done by it will go to Mr. Young and Senator Bourne. Therefore it is doubtful if Senator Fulton's friends will try to capture the convention.

CENTRAL BODY TO MEET WEEKLY

Plans for the Republican campaign in Multnomah county were discussed at a meeting of the Republican county central committee yesterday afternoon.

The meeting had been called by County Chairman J. P. Kennedy and approximately 70 out of a possible membership were attended.

Route business was transacted by the committee, J. F. Sinnott being elected vice-chairman and F. E. Beach treasurer to cooperate with the corrupt practice act now in force and which makes it necessary for all political organizations to have a treasurer. Gladness was brought to the heart of John C. Young and Senator Bourne by the endorsement of the Taft clubs already organized in the county by Young. This endorsement was made in the form of a resolution of respect.

It was decided to hold weekly meetings of the committee and also of the executive committee of the Taft clubs in the county during the campaign. The county committee has chosen the time and place of meeting the state committee will furnish the funds and pay expenses of the meetings.

GRAND AVENUE NOW HAS G. O. P. CLUB

The Grand Avenue Taft Republican club was organized at Logus hall, Grand avenue and East Washington streets, last night. There was a good attendance of voters from the district gathered in the hall in answer to the call for the meeting and a permanent organization was secured by election of the following officers: President, Henry G. Kundret; vice-president, Dan Kolaher; secretary, C. Howard; treasurer, George K. McCord. An executive committee was elected composed of the following men: Richard L. Delch, O. E. Hutchinson and W. J. Lyons.

Delegates were also elected to represent the club at the state convention of Republican clubs, called for next Tuesday, for the purpose of forming a state Taft league. The delegates elected were C. A. Eigelow, Dan Kolaher, Richard L. Delch, W. E. Williamson, George K. McCord, H. G. Kundret and C. V. Howard were designated as ex-officio delegates.
