

# BLINDING THE PEOPLE'S HEADACHE?

## United States Senator Gore Tells 'Vast Audience Democratic Truths at Armory Rally—Auditors Cheer the Name of Bryan and Democracy.

Concluding with laughter by his wit, swaying their hearts by his eloquence, holding their minds attentive by his reasoning, United States Senator Thomas P. Gore of Oklahoma last night at the armory entertained and instructed a vast audience of Portland for two hours and more in a discussion of political issues and remedies for political ills. He discussed the attitude of the Republican party, admitted its mission and its great work during its early existence and deplored its departure from the principles upon which it was founded. He took up the tariff and the trusts, he spoke of the bank guarantee act and the injunction law, and the platform. He lauded Bryan and predicted his success in November and through all the time the audience sat respectfully to his moods, laughing when he willed, observant or studious by turns, changing under the magic of his oratory.

### Bryan's Name Cheered.

It was a great meeting. Those who have contended that the cause of Bryan is dead in Oregon could not help being shocked and grieved at the wild outbursts of applause and long continued cheers which greeted the mention of Bryan's name. Nor could they fail to be concerned at the enthusiasm which greeted the doctrine of the great orator as set out by the blind advocate.

From the place that Senator Gore took his place upon the platform and waited until the cheers had died away, until he finished his peroration, more than two hours later, he had his audience with him. He was introduced by John M. Gearin, briefly, and in beginning his address acknowledged the compliments paid him sincerely. He acknowledged the debt of Oklahoma to Oregon in that his state had followed the lead of Oregon in the enactment of the direct primary law and other reforms.

### A President from the West.

He felt that he was a neighbor to Oregon, the speaker said, he was from the west and of it. In New York he had told the nation and now he came to the west for gold, opportunity and prosperity. The west must come to ease for sunshine, peace and plenty, but now the west was going to go the east one better and give it the president.

Senator Gore said he was a friend of Portland and of Oregon, and here he paid Governor Chamberlain high compliment. "I am a friend of Oregon," he said, "for one thing because you have selected in January of 1908 an old friend and fellow-Mississippiian, Governor Chamberlain. You have risen above partisanship in your selection. When Senator Chamberlain takes his place in the senate there will be seven native born Mississippians there and one from a flying wedge and give Oregon what she wants."

Continuing, the Senator paid compliment to the Republican voters of Oregon. He lauded them for their enactment of the direct primary, the initiative and referendum which were in the name of the Republic of the Past.

### The Republicans of the Past.

"And now I am going to say something which I hope my Democratic friends will not take offense at," he said. "In this world it is a few Republicans. That is the only fault I have to find with the Republicans, there are many of them. The Republican party was a great party. It struck the shackles from the hands of a million slaves and made this country in fact as in name the land of the free. But that was the Republican party of yesterday, not the Republican party of today."

"The great leaders who formed the party, who enunciated its principles, who led it on when it was in the trough. Then it was the party of principle, now it is the party of mammon. You can not emulate the fame of these great men, but you can emulate their principles. The Republican party, which has abandoned its principle. You can turn to the Jeffersonian principle that all men are equal, not in riches but in the right of justice."

### New Elephant Principle.

"The Democratic party has insisted that men be equal in rights, whether or not equal in riches. The Republican party is insisting that they must be equal in riches to be equal in rights."

Turning to Oregon again the speaker again acknowledged the spirit of the people and their desire for reform. "In Oklahoma," he said, "I followed Oregon's lead and enthroned the people by the enactment of the initiative and referendum. The Republican candidate came out here and fought that principle, contending that it loosened the foundation stones of our government. He cast his influence against the people of Oregon voters, and they ought to repudiate him. That is an enemy to self government, as he is the enemy of those who work with their hands."

"The Democratic party believes that the union is an indissoluble union of indissoluble states. It believes no union, no states; no states, no union. It believes that the union is the United States of America. The Republican party believes in the United States of America."

### HONOLULU TURNS ON YELLOW PERL, IN LABOR-CAMP PHASE

(United Press Leased Wire.) Honolulu, H. T., Sept. 26.—An agitation to restrict the Japanese colonies in the Hawaiian Islands to certain limited districts in incorporated cities and to limited areas outside the cities has been started by the citizens of Makiki, a suburb of Honolulu, and the agitation against the Japanese may be carried into the next territorial legislature. The trouble started with the application of a colony of Asiatics to erect a new Japanese labor camp just across the street from a schoolhouse on Berea street, one of the fashionable drives out of Honolulu. Superintendent Campbell, of the public buildings department, refused to issue the permit on the ground that the plans were faulty. The Japanese amended their plans and applied again. They threatened mandamus proceedings, and the permit was issued. The residents of the district are highly indignant and threaten to stop the construction of the building by injunction proceedings, on the ground that it is a nuisance and endangers the residence district.

### What Democrats Believe.

"The Democratic party believes that it is wrong for any man to get without earning, or for any man to earn without earning. The Democratic party has always stood against the centralization of political and industrial power in a few hands as equally dangerous and destructive to human liberty. The Republican party believes in both."

The senator then turned to the trust question. "The trusts," he said, "riffle the cradle and rob the tomb. They tax the cradle and the tomb. They tax the infant and lay their hands upon the ceremonies of the dead. They would, if they could, put a meter upon the breasts of the mother and charge the hungry infant so much per gram." He then took up the illustration of the housewife, showing that from the time she arose from her trust-made bed in the morning until she went back tired at night she paid tribute to the trusts in every thing she used.

"Even the beef she uses," he said, "comes from the beef trust, the worst charges house of them all where they make two kinds of beef, one kind and several kinds of canned beef out of the remains of one poor brindle calf. About that trust I want to say what I said in the senate, that there ought to be a law passed not only requiring that the date of canning be stamped upon the cans but also the disease of which the cow died."

### One Party Trusts' Mother.

"The trusts," continued the speaker, "are the offspring and the spawn of the Republican party. The Republican party admits that he is unfriendly to the trusts, but in heaven's name if he is not, he would have happened had it not been. But where is this legion of trusts that have been killed and buried by the Republican administration? Let some Republican sexton to take me to the cemetery where they lie buried that I may go there and weep tears of joy above them."

"They have slain but one trust. With all the machinery of the administration behind them, but one trust has been wiped out—our Trust in God. That is the only trust that has felt the withering touch of the big stick. I am opposed to taking from our currency our trust in God just as I am opposed to taking from our religion our trust in Jesus Christ from our religion."

"But who are you going to have curb the trusts? Are you going to give them over to the Democrats for correction, who are their old enemies, or give them to the Republicans, who are their parents to kill their own children?"

The protective tariff was taken up for discussion. The speaker said that he thought that it was unfair to the American farmer and wage-worker to pay more for the trust-made tools they used than the peasant who made them. The German peasants along the Rhine, and this was the result of the tariff.

They did it to keep their hands clean. They did it as an investment."

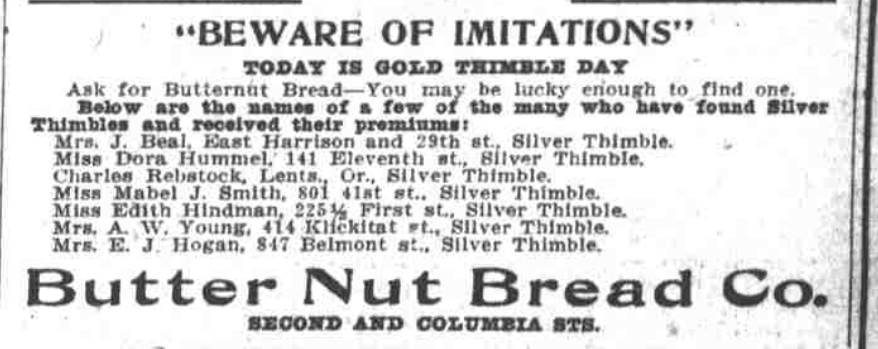

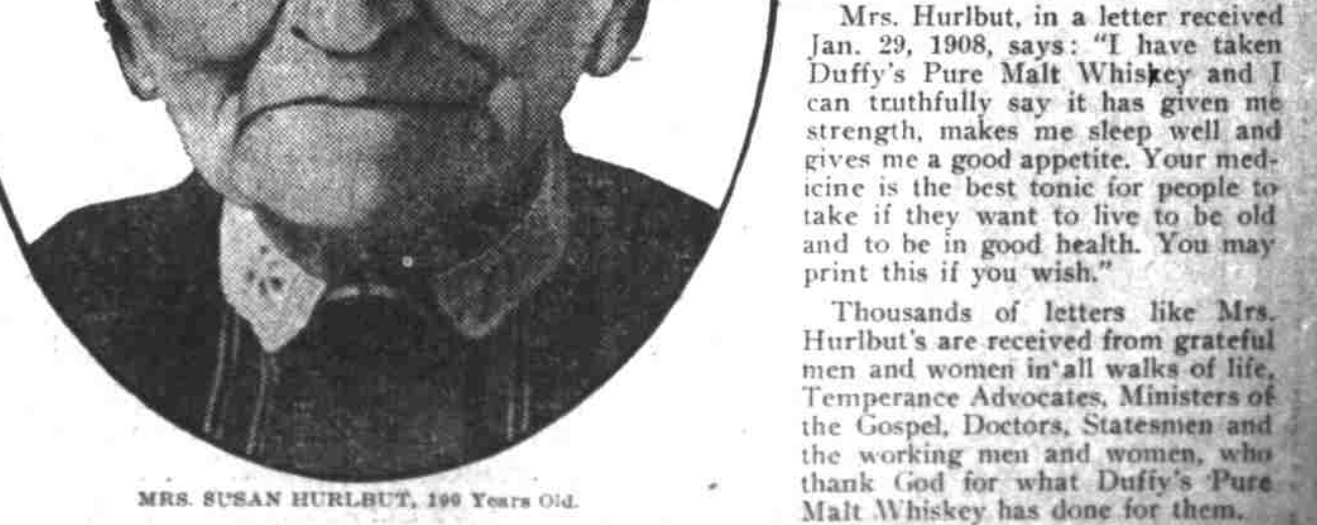
